As mentioned in the July 18 email, this is how we are conducting our annual meeting this year since we cannot gather as we usually do. We requested any new or old business that any member wished to raise or any motions to be brought forward. We did not receive any. We requested nominations for a new board member and received one. If you have questions or wish to comment use the matikohoa@gmail.com email and they and the responses will be made available to all HOA members as they would be in an open meeting. Voting and time for discussion will end on August 31 and results will be announced by email on September 1. Please return your vote as soon as possible so that your vote can be recorded and we can be assured of a quorum required to validate the election of your choices.

I'd like to thank our board, officers and Architectural Control Committee (ACC) members for their service to our community. You'll find them listed below. Without them the community HOA would not function and when that happens the community may start to deteriorate. You only have to drive through some of the Harbour Pointe communities to see the differences. I'd like to thank community members for maintaining their properties and seeking ACC approval for any exterior changes as required by the CC&Rs.

The Treasurer's Report is attached as a pdf to this email. It shows the 2019 proposed and actual expenditures and the 2020 proposed budget assuming a dues reduction of \$30.00/year. In summary we underspent each budget category and increased the Reserve Fund such that we ended the year with \$29,114.09 in the bank. The Board has been targeting reserves of \$30,000 or more. The proposed budget with the proposed dues reduction approved is also shown in the report. With 2020 proposed income and expenses we are targeted to achieve \$30,229.09 in our account. That is why we are putting the dues reduction and approval of the 2020 budget to your vote. Should the dues reduction not be approved the 2020 proposed budget would increase the ending balance by \$930.00 from \$30,229.09 to \$31,159.09. (See CC&R Section 3)

As discussed in the previous email, we will be voting on one other issue, that of roofing material change from cedar shake or tile to two or more ply asphaltic such as

Certainteed Presidential. This change was previously approved but the records were not retained so we must reapprove in order to record the change with the county. (CC&R Article VII, Section 19)

We will be voting on a new board member as we do every year. Bud Klosterman (Lot 11) has been nominated for the Board. Bud writes:
