- The option to upgrade homes to newer materials and differing colors was suggested by most of the homeowners present. It was determined that developing an Architectural Review Committee would benefit the neighborhood to ensure cohesive color schemes are selected moving forward.

- Dwane Blessing, Monica Brand, Mike Brown, Sherry Ruyle, and Patty Solomon volunteered to participate on this committee to provide the neighborhood a selection of color choices that would be deemed appropriate for replacement options. (The results of these options will be distributed to the homeowners as quickly as possible.)
- If homeowners are moving forward with repairs that utilize the same colors they currently have or newly approved color choices, they will not need to submit approval to the board at this time.
