The swimming area is for the exclusive use of the residents of Liberty Creek South, Liberty Creek North and Stratford Glen.

The swimming pool/area cannot be reserved or used for private parties.

Guests must be accompanied by a resident with a valid pool pass. Guest pass entrance fee is \$5.00.

The maximum capacity will be 75 bathers.

For pool card activation- Association account must have a zero (\$0) balance due.

Homeowner's first pool pass is provided at no charge. Charge to replace lost or stolen pool pass: \$25.00 each.

must be completed annually for pool pass activation.

MONITORS will assist lifeguards in maintaining safety and security at the pool in accordance with all applicable rules and regulations.

- ➤ <u>Verify pool attendee's eligibility</u> to use the pool including checking names and ages of persons to ensure compliance with LGA rules.
- Take disciplinary action when attendee(s) disregard pool rules or lifeguard's instruction.
- > Collect fees for guest passes and maintain guest register.

LIFEGUARDS MAXIMIZE POOL USER SAFETY in accordance with all applicable rules and regulations. Lifeguards prevent accidents or incidents from occurring by observing the environment but also acting to control hazards or risks. To keep people safe in the water, lifeguards supervise all activity at the swimming pool including:

- ➤ <u>Call Safety Breaks</u> for a period of fifteen minutes each hour, the lifeguards will clear the pool for a brief safety break. At the discretion of the lifeguards, adult residents (age 18 and older) will have access to the pool during these safety breaks.
- ➤ <u>Close the Pool</u> for part or all day when unfavorable conditions exist. When an unscheduled closing is necessary, the lifeguards will post the reason for the closure at the pool entrances.

MONITORS and **LIFEGUARDS** will control any situation by asking individuals to leave the pool and recreation area or by calling Police/Security. Disciplinary action as stated in the LGA Disciplinary Policy shall be used when swimming pool users do not follow lifeguard instruction per these swimming pool rules.

POOL USERS:

- ➤ All persons must follow the direction/instruction of the lifeguards and monitors.
- **▶** Obey USER SAFETY and SANITATION RULES for the SWIMMING POOL

USER SAFETY and SANITATION RULES for the SWIMMING POOL

per Indiana Code 410 IAC 6-2.1 Public and Semi-Public Pools Rule are included in the following rules established by the Liberty Glen Amenities Board of Directors:

- 1. Children under 18 years of age and non-swimmers shall be accompanied by a responsible adult.
- 2. Anyone who has or has had diarrhea in the past two (2) weeks shall not use the pool.
- 3. Anyone who has an area of exposed sub epidermal tissue, open blisters, cuts, etc. is advised not to use the pool.
- 4. All persons shall take a cleansing shower before using the pool. A bather leaving the pool to use the toilet shall take another cleansing shower before returning to the pool enclosure.
- 5. Spitting, spouting of water, blowing the nose and similar behavior in the pool is prohibited.
- 6. No running or rough play is permitted in the pool, on the deck, on floats, on platforms, in dressing rooms, or in showers.
- 7. Street clothes are not allowed in the swimming pool enclosure. Proper and modest swimming attire is required. Thong bikinis and/or street clothes such as cut-offs are NOT allowed in the pool or on the deck. Visitors or spectators in street clothes are allowed in the picnic area.
- 8. All diaper age children shall use swim diapers.
- 9. Do not change diapers at poolside. Diaper changing stations are available in the restrooms.
- 10. Adults or parents must be in the pool with their children when the children are using a flotation device.

- 11. Sponge balls, toys and rafts will be permitted **ONLY** with <u>lifeguard approval</u>.
- 12. Absolutely NO ALCOHOL, NO SMOKING, NO VAPING Visible signs of intoxication/controlled substances or behavior indicative of intoxication/controlled substances will be grounds for dismissal from the premises. Infraction of this rule will not be tolerated, and you will be asked to leave the facility.
- 13. Absolutely NO PETS at the pool facilities or inside the pool fences. Infraction of this rule will not be tolerated, and you will be asked to leave the facility.
- 14. NO DIVING at the pool facilities. Infraction of this rule will not be tolerated, and you will be asked to leave the facility.
- 15. Earphones are required for all electronic audio devices to not disturb other pool attendees, lifeguards, or nearby residents.
- 16. Food and glass containers are NOT permitted inside the pool area. Picnic tables are located in the designated picnic area. The picnic area cannot be reserved.
- 17. Playing or "staying warm" in the showers at any time is strictly prohibited. The showers are for bathing purposes only.

The following lifesaving equipment is available at the pool for emergency use: a ring, which can be thrown to a bather in difficulty; a life pole with a shepherd's crook for reaching a struggling bather and pulling him/her to the side of the pool; a spine board with ties, cervical collar, and head immobilizer for use by emergency medical or health care professionals; standard first aid kits. Bathers are not permitted to tamper with or remove such equipment from its location for any purpose other than the intended emergency use.

LGA Disciplinary Policy for Swimming Pool Rule Infraction(s)

Lifeguards/Monitors have the authority to control any situation by asking individuals to leave the pool and recreation area or by calling Police/Security.

Disciplinary action against individual(s) - not necessarily in the same day - shall be as follows:

- A. If a lifeguard/monitor needs to tell someone repeatedly to stop a certain behavior, that individual will be asked to leave the pool and recreation area. Assistance may be requested by calling Police/Security when needed.
- B. First Offense Pool privileges may be revoked for a minimum of two (2) weeks.
 - 1. Lifeguard/monitor will record individuals name, address, and owner of pool pass.
 - 2. Lifeguard/monitor shall report the infraction and information to the pool supervisor who will then inform the LGA property manager.
 - 3. Property manager will report to LGA Board of Directors.
- C. Subsequent offense(s)
 - 1. Owner of pool pass will be notified in writing of hearing date, time and place.
 - 2. Hearing among LGA Board, pool pass owner, and involved individual(s.)
 - 3. Board will determine disciplinary action –

First Offense – suspend pool privileges not to exceed sixty (60) days.

Subsequent Offense – suspend pool privileges not to exceed 365 days.

D. Enforcement

- 1. Lifeguards/Monitors will be informed of hearing outcome and names of suspended residents.
- 2. Property manager will de-activate involved owner's pool pass and collect all affected wrist bands.
- 3. It shall be the owner's responsibility to request pool pass re-activation at end of suspension.
- 4. Should suspended individuals attempt entry with another owner's valid pool pass or guest card, that pool pass owner will be subject to action according to the disciplinary policy.
