CCNA Officer, By-Laws Election in October

October is a time for scarecrows and pumpkins (and the Cedar Creek Pumpkin Patch at 1399 Austin Street), the inauguration of fall, and elections at the Cedar Creek Neighborhood Association monthly meeting. As usual, we will elect officers (president, vice president, secretary, treasurer) to lead our association in 2007. This year, as proposed at the September monthly meeting, we will also vote on some changes to the CCNA by-laws.

This year, your elected officers include Brad Carter (1633 Cedar Crest Drive) as president; Marianna Rasco (602 EN 19th Street) as vice president; Gayna Johnson (1399 Austin Street) as secretary; and J.C. McCurdy (602 EN 20th Street) as treasurer. With the exception of Mr. McCurdy, who served as CCNA secretary in prior years, these were all first-year Cedar Creek officers. According to our current by-laws, the executive officers serve one-year terms and must be elected each year.

Changes to the by-laws of the association are mainly for clarity with a few meaningful changes that reflect our actual practice. This includes clarity of boundaries and addition of some areas considered CCNA properties that were left out of the by-laws. It also includes more flexibility on when monthly meetings are held, removal of dues, and the change to "residents" from "property owners" as members of the association. The old and new by-laws can be reviewed before the meeting by requesting printed copies (please contact members of the Executive Board, contact information on reverse) or by downloading copies from our website (www.neighborhoodlink.com/abilene/cedarcreek). Members are encouraged to review these changes before our October 10 meeting.

Proposed Changes to CCNA By-Laws

- ◆ Boundaries clarified to include all properties between Judge Ely, Ambler, Treadaway & EN 10th.
- ◆ "Residents" considered members of the association rather than only "property owners".
- ◆ Monthly meetings changed to "monthly basis" rather than a set time each month.
- ◆ Past President added to the Executive Board.
- ◆ Removal of membership dues (possibly could be reinstated once able to collect dues tax-free).

A slate of nominees will be presented at the October 10 meeting in the University Church of Christ Family Room at 7:00 p.m. Additional nominations will be taken from the floor (please contact potential nominees about service before nominating).

The proposed by-laws will be available for voting and additional amendments and changes can be proposed from the floor.

Please plan to attend and participate in the election of these matters on October 10. Again, to review the by-laws changes, please contact the Executive Board or download on our website.
