## Traffic Nightmare 🚓 🚓 🚓 🚓

Do you hate dealing with the horrible traffic in our neighborhood? Are you tired of fighting traffic jams to get home? Does an endless string of cutthrough drivers stream by your home during rush hour? Are you tired of complaining about it? Do you want to do something about it?

Well, you actually <u>can</u> do something about it!

The WLA Traffic Calming Project needs concerned neighborhood residents who want to do more than just complain about traffic. It needs energetic and practical people who are willing to educate themselves and others about the kinds of measures that might reduce traffic problems.

The WLA Traffic Calming Project was organized by the WRA in 2003 to prepare and implement a traffic protection plan. The goal is to reduce the impact of traffic-related problems in the area bordered by the 405 Freeway, the 10 Freeway, Centinela Boulevard and Santa Monica Boulevard.

Through the efforts of the WRA, money from several development projects has been allocated to fund this traffic protection plan.

Over \$300,000 has been accumulated thus far. A traffic consultant has been retained to assist the project and a Steering Committee has been formed.

This Steering Committee needs people who are willing to roll up their sleeves and commit to doing something about our traffic problems. All that is required is an open mind and the ability to work with others. You do not need to be a member of the WRA to be involved.

Traffic mitigation measures that will be considered include "diversionary" measures, which include signs prohibiting access to certain streets during certain hours. Other "nondiversionary" measures include stop signs, speed humps, traffic circles, median islands, and other traffic control devices.

Community involvement is essential to this project. Neighborhood meetings and workshops will be needed to target specific traffic problems and identify possible solutions.



### Election of New Councilperson On Tuesday, May 17, 2005

On May 17, we will be electing a new councilperson for our district. The 11th District seat is being vacated by Councilwoman Cindy Miscikowski because of term limits. Two candidates, Bill Rosendahl and Flora Gil Krisiloff, are running for the Council seat.

Bill Rosendahl, who lives in Mar Vista, is a former professor at Cal. State Dominguez Hills and cable television executive who hosted a respected community affairs program for 16 years. You can check out his background at his website at www.billrosendahl.com.

Flora Gil Krisiloff, who lives in Brentwood, is a former nurse and is the past President of the WLA Area Planning Commission. She is presently the Chairwoman of the Brentwood Community Council. You can review her accomplishments at her website at www.flora2005.com.

In the March 8 primary, Rosendahl received 44.6% of the vote and Krisiloff received 41.7%. A third candidate, Angela Reddock took the remaining 13.7%. We urge everyone in our neighborhood to vote on Tuesday, May 17. Watch for your election ballot booklet to arrive soon in the mail. Your polling place will be listed on that booklet.

This is a very important election for our West Los Angeles community. While other people in government may be more prominent, your councilperson will likely have more impact on the quality of life in our neighborhood than any other elected official.



#### Local Adult Entertainment Establishments

Silver Reign is one of five adult-oriented businesses in our local West LA community. It is located on Mississippi Avenue near Bundy Drive behind the strip mall that faces Olympic Boulevard. This adult entertainment establishment has been an ongoing nuisance to our community since its arrival over ten years ago. The owners, Star Planets Incorporated, have consistently shown little regard for the law or for the community that surrounds them.

For the second time in nearly three years, *Silver Reign* has been cited by the Department of Building & Safety for an illegal expansion into an adjacent office space – formerly West LA Printing – in another attempt to circumvent city planning overview.

The club appealed their first citation to the Planning & Land Use Committee, but with the

help of the community, the Department of Building & Safety and the City Attorney, it was denied. It now appears that Silver Reign may now be submitting plans to demolish its present location and move the club into the adjacent office space next door in order to acquire more parking. However, because Wildwood School is only 500 feet from this adult establishment, it will be necessary for the club to apply for a Conditional Use Permit in order to retain its designation under Ordinance 12.70 as an all-nude club.

Our community can have considerable input in the issuance of a Conditional Use Permit -- but we need people in our neighborhood to participate in the process by helping our city officials understand that this type of business brings nothing beneficial to a residential area.

We must show that any expansion of *Silver Reign* will only be a further detriment to the people who

live with it on a day-to-day basis. Illegal activity is regularly reported by local law enforcement in connection with this establishment.

Keep in mind that there are school bus stops close to this location. There is a park three blocks away. And high school students are spending their lunch hours at this club because it offers a free lunch buffet. Remember -- since all-nude clubs *do not* serve alcohol, the age limit to get in is only 18 years old.

The WRA will keep all residents informed of any hearing dates for this Application for Conditional Use Permit pertaining to this location. We urge the community to rally together and attend these hearings, write letters and speak out against any such permit being issued to Silver Reign that would permit further expansion.

The first election for the City of Los Angeles' newly formed Neighborhood Council program took place in October of 2004 and 11 persons were elected to the Board of Directors. The West Los Angeles Neighborhood Council (WLANC) meets on the second Wednesday of every month at 7:00 pm at the Felicia Mahood Senior Center located at Corinth Avenue and Santa Monica Boulevard.

As a member of the WLANC Board and as a long time member of the

Westside Residents Association, I will keep the WRA membership informed about what the WLANC is doing and its potential effect on our community.

Please remember that the WLA Neighborhood Council is not a replacement for the independent status of our residents association. All neighborhood councils are still very much under the control of the City of Los Angeles and in some ways, this limits how much

However, the Westside Residents Association does not have these constraints and is completely autonomous.

Our community's participation in the WRA is now even more vital and we must be vigilant to insure that our West LA Neighborhood Council is responsive to the issues of our association and to the community it is intended to represent.

### Crime Corner



The good news is that violent crime in our West LA community is down by 47% and property crime is down 18%, year to date. Burglary suspects known as "office creepers" have increased along businesses in the Wilshire Boulevard corridor. Our major crime problem continues to be car burglaries. The bad news is that West LA officers have been transferred to other stations in Los Angeles to help combat the violent crime in other neighborhoods, leaving us less protected.

There is a great deal of interest by the community for a new device called a License Plate Scanner which is similar to a radar gun, but it quickly reads the license plates of moving or parked vehicles, informing the Police if the vehicle is stolen, if there are unpaid traffic tickets, etc. The cost for each unit is \$25,000. West LA LAPD would like to purchase 3 units. A total of \$2,000 has been donated to date.

Our West LA Commander, Captain Proctor has introduced a program that allows volunteers to go through a training program to become Crime Prevention Specialists. After training, the volunteers become Specialist Reserve Officers and will be able to call on victims of certain crimes to garner additional evidence and to provide other assistance. The start-up of the program is scheduled for mid-May. Any volunteers?

#### TIPS TO PREVENT "STOLEN IDENTITY"

- ✓ The next time you order checks, have them printed only with your first initial(s) and last name. If someone steals your checkbook, they will not know if you sign your checks with your initials or your first name, but your bank will.
- ✓ Do not sign the back of your credit cards. Print instead, "PHOTO ID REQUIRED".
- ✓ When you pay by check on credit card accounts, do not write the full account number on the "Memo" line – use only the last four numbers. The credit card company knows the rest of the number, and anyone who might be handling your check as it passes through all the check processing channels will not have access to it.
- ✓ Print your work phone number on your checks instead of your home phone. Use a P.O. box instead of your home address if you have one. If you do not have a P.O. box, use your work address. *Never* have your social security number printed on your checks.
- ✓ Place the contents of your wallet on a photocopy machine. Copy both sides of *everything* in it (license, credit cards, etc.). If your wallet or purse is stolen, you will know exactly what needs to be reported and cancelled. Keep the photocopy in a safe place.

#### IF YOU ARE A VICTIM OF "STOLEN IDENTITY"

- ✓ Cancel your credit cards immediately. By having a photocopy of them, you will also have the toll free numbers and your account numbers handy so you will know whom to call.
- ✓ File a police report immediately in the jurisdiction where your credit cards, etc., were stolen. This proves to credit providers that you were diligent, and this is a first step toward an investigation (if there ever is one).
- ✓ Most importantly, *immediately* phone the three national credit reporting organizations listed below to place a fraud alert on your name and social security number. If an application for credit is ever made over the Internet in your name, this will alert any company to the fact that your information was stolen, and they will be required to contact you by phone to authorize any new credit. Keep these numbers handy.
