All entries must be made by a PPCA Member only. (the name the submitters of entries being voted upon, will be secret until the final winner is chosen). The Logo Entry that highest receives the number of PPCA Member votes is the winner. In the event of a tie vote, there will be a runoff vote taken by the PPCA Members. The Winning Logo will be adopted by Resolution of the Board of Directors, and henceforth may be used in conjunction with Podickory **Point** Community Association name.



### Did You <u>Know</u>...

The 2004 Maryland **General Assembly passed** a law (Senate Bill 568) which permits condominiums, homeowners associations, and housing cooperatives to provide meeting notices and deliver information to owners by electronic transmission (e-mail/web) where certain conditions are met. Such transmissions must be capable of creating a record, which may be

retrieved, reviewed and reproduced in paper format by the recipient.

The PPCA Board has asked that those Members who are willing to accept email transmissions of PPCA information, notices and Association business correspondence, please provide your email address to Dieter Grotheer, Treasurer. This will inevitably save some money in mailing costs. Your email address will NOT be published in our PPCA telephone directory.

This will not preclude those Members who do not have access to e-mail, from receiving printed mailings of the PPCA correspondence via the USPS. If you have any questions or need further information, please contact the PPCA Secretary, Ginny Jones 410-757-0845.
