## **Snow Time!!**

Stone Mill has contracted with Pete's Garage for snow removal this winter season. Not only will Pete's Garage clear the streets of our community, salt when necessary and clear a path to the mailboxes and fire hydrants, but if you catch them as they make their rounds, they are willing to clear your driveway or your sidewalks!!! This is <u>not</u> through Stone Mill Maintenance Corporation, so they will take CASH ONLY. The fees range from \$20 (2-4 inches of snow) to \$55 (20+ inches of snow).

In addition, once the snow falls, any concerns or compliments for the snow removal service are welcome.



# ATTENTION Ryan Home Owners

- ACTION REQUIRED: Any homeowner who owns a Ryan Built home is urged to contact Ryan Homes Production Manager, Matt Egan, at 302-452-1610 regarding the needed repairs to the roof assembly. This is a fire hazard and needs to be addressed by these homeowners IMMEDIATELY.
- Ryan Homes has identified a deficiency with a common fire wall between the townhomes and the roof assembly that is a fire hazard. They have voluntarily opted to repair this critical deficiency at NO COST TO THE HOMEOWNER! If you do not repair this deficiency you will be obligated by Delaware law to disclose this at time of sale. Failing to do so will hold you liable should a fire occur in the home post your sale.
