

## LOW INCOME DRIVERS



In a slum and blighted neighborhood, in which 87.40% of its residents are low to medium wage earners, earning \$26,531 as median income, and the rest are overnight Americans; Fox Canyon is the host to plenty uninsured drivers. To bring a new perspective and a solid solution to this issue, Assemblywoman Shirley Horton hosted a community coffee last week and a representative from the State of California Low

Cost Auto Insurance Program was invited as a special guest. This State program basically provides good drivers with an affordable insurance option. Let us remember: it is illegal for drivers to be on the road without insurance and people who are struggling paycheck to paycheck may want to look into this program. There are a few hurdles to jump, like having a good driving record, being licensed to drive for the past three years, and the vehicle valued at less than \$20,000. A toll free telephone number is available to get FREE quotes at 1-866-60-AUTO-1. This makes me wonder what other useful programs are out there [that could impact directly and help our impoverished neighbors], that I don't know about. I appreciate Assemblywoman Horton for bringing this program to our attention helping us learn how our tax dollars can work for us, and for the benefit of our community.

## FREE MINI-ROLLOVER CLEANUP

Great News! Kindly, Councilmember JIM MADAFFER, CD-



7, and the city of San Diego Environmental Service Department allocated a FREE mini-rollover cleanup and Recycling Event to Fox Canyon [curb pickup, limited to a few blocks]. Separate waste and recyclables, into three different piles [metal, debris and greens], and place them at the

point of regular trash collection by 8:00 AM [do not use the automated refuse containers]. Due to time constrains, city crews will NOT be able to return to collect items placed out after 8:00 AM. This is serious! Please, be aware that this mini-cleanup is ONLY limited to the Loop [eastside of Euclid from Wightman to Auburn, Auburn from Euclid to Ontario and all of Wightman Street, again, residents from this area ONLY!]. City Crews will pick up: appliances [remove doors], computer monitors, metals, TV's, lawnmowers [free of oil/gas], carpeting, junk furniture, mattresses, wood [bundles up to 6' long] yards trimmings [6' long bundles], other non-recyclables. City Crews will NOT PICK UP: dirt, construction or demolition rubble, tires [all types], hazardous waste [paint, motor oils, batteries, etc.].

#### **CRIME WATCH**

On Friday, September 15, 2006, a group of young-adult males walked southeast on Lantana Drive, talking about having a 22 handgun. Panicking, for what she heard, the concerned Neighborhood Watch volunteer called the police at 4:30 PM.


Scrambling, as she could, a 95-year old neighbor dives to lack her front door; at the same time, the Neighborhood Watch volunteer calls 911 again, to report five shots fired [front of 4795 lantana], from what sound like a 9mm handgun and the same group of young-men running away west [toward Euclid] on Lantana at 5:30 PM.

Completely surrounded by a large group of "not looking good guys holding beer cans", walking north on Lantana/Dwight, a couple of neighbors are blocked-off from continuing their car trip home, at 9:15 PM.

Awakened by the loud and angry voices from a group of men running down-hill, at the empty parcels that unite Lantana/Auburn [where the water box is], the neighbor [4990 Auburn] got up to close the window at 9:45 PM.



Six real loud gun shots resonated throughout the entire Fox Canyon system, and residents on Lantana were awakened to pin point the origin of the gun shots, and later to see the police cordoning-off lower Auburn at 10:20 PM. Another neighbor on Lantana was awakened, by the soft spoken voices and the hushed commotion, to see a vehicle being wheeled off into another neighbor's driveway, and later the police holding a handcuffed person right across the street from his window, at 11:10 PM.



## NOW, WHAT HAVE WE LEARN?

- On Tuesday morning, 09/12/06 four neighbors called the association reporting a barrage of gun shots around mid-night, sounding like coming from Castle. Now we know, it was a "gang confrontation" at University/Euclid, the night of Monday the 11th.
- That only <u>one</u> "crazy woman" will call the police [twice] and the
  other TEN [10] potential witnesses, probably took a drink or a pill,
  at mid-night, and went back to sleep. The association received 12
  calls the day after. No wonder the police was annoyed, NO gossip!
- That James Varnadore was right, after all, when saying: "There's NO crime in Fox Canyon!" [City Council testimony] Yes, only in Oak Park and in City Heights.
- That we are either idiots or lunatics for believing that Ontario Avenue [the street we want to connect to Winona/Auburn] and Auburn Drive are in Fox Canyon.
- That the SDPD is NOT preventive but responsive.
- That we're all crazy. For years we have told the police: "there <u>ARE</u> [CRO instructions: 'alleged'] GANGS [MS-13, ESD and other] and gang-members in Fox Canyon". Now the newspaper tells us, "the police say shooting is GANG related, and having a GANG confrontation". Wow, we really didn't know that!!!
- That our [CRO is going to be proud] "alleged" gang members are
  real poor shots. Wonder if we need to give them scholarships to
  target practice at the police historical shooting facility down
  Federal Blvd., next to Vernardini Fields, some blocks south from
  Fox Canyon on Home, a short walking distance. Other than target
  shooting at the empty lot [proposed PARK] near Bandar Salaam.
- That 5014 Auburn [Auburn Arms going through a condo conversion] is a residence. Remember the "alleged" gang members [MS-13] in unit 2, and the pains the association went through to see them evicted? Now, we need to ask about unit 1.
- Dong! 10:00 PM. Time to don your bulletproof pajamas... And, by the way, do you know where your gang members are?

## A LAWYER STORY

A lawyer purchased a box of very rare and expensive cigars, and then insured them against fire, among other things. Within a month, having smoked his entire stockpile of these great cigars and without yet having made even his first premium payment on the policy, the lawyer filed claim against the insurance company. In his claim, the lawyer stated the cigars were lost in a series of small fires. Not all is well in our separate 'Hoods especially since a small group of individuals are strongly negative and predatory to our yearning for progress, and to our partnerships to secure project funding. Wolves in sheep's clothing, these people are the strong reason why our entire set of neighborhood associations is wilting away quickly. Please, let's be honest and face the truth, if you don't pay homage to the king and his cronies, your sub-'Hoods' projects don't get recommended. 
