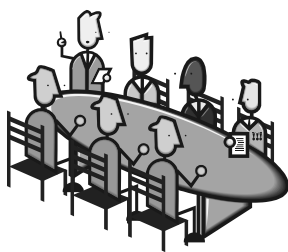

Rockwell Entrance

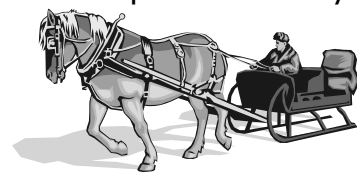
During our recent Fall perimeter clean up we did some work on our Rockwell entrance in order to start preparing for the installation of

our new traffic light which will be coming soon. The stones that formed the flowerbeds have been removed for two reasons. One, someone decided to start taking the stones and two, rather than risk losing them all we decided to remove them in hopes of the natural grass taking over the area so it would be more self maintaining. With no way to water this corner or keep flowers planted the CNNA board decided it would be more attractive to people sitting at the traffic signal if we kept it mowed, edged and neatly manicured during the warmer months.
