Dear Neighbors:

The Board would like to thank everyone for your support during our last KPHOA Meeting on June 12th. We had a very large turnout and those that attended the meeting had the opportunity to hear Dan Hennings' presentation of the services offered by Community Management Associates (CMA).

Presentation Highlights:

- CMA will offer full service management services for \$650.00/month;
- Our Annual HOA Dues will increase \$50 per year beginning in 2007;
- The Board will maintain control of KPHOA's account. CMA will be provided with an expense account;
- The Board contacted a total of five community references for CMA. We received a response of "very good" from four references and a 'rating" of "4" out of 10 from one reference;
- Mr. Henning presented the idea of an "Initiation Fee" as a way for our subdivision to raise funds (the Board is currently researching this option with our legal counsel;
- One of our neighbors generously volunteered to drive through some of the neighborhoods listed on CMA's reference list to evaluate the upkeep of those neighborhoods;

Attendees at the meeting requested the opportunity to submit names of management companies for the Board to consider before making a final decision on a management company. The Board appreciates the input and welcomes any suggestions that homeowners may have and agreed to refrain from signing a contract with CMA until we have

reviewed any companies submitted by community residents.
