
"Twelve Oaks at Bridlewood" Site Preparation Now Complete

Twelve oak trees planted at the entrance of the new subdivision will soon beckon for new home buyers in Helena's newest subdivision, "Twelve Oaks at Bridlewood". You have probably noticed the progress that has been made preparing this site for new home construction off of Bridlewood Road.

Ronnie Morton, developer for much of Old Towne Helena, is the developer of the property. "Twelve Oaks at Bridlewood" will consist of three cul-de-sacs containing 30 homes. Home construction will begin this spring and should be completed within a year.

The homes will feature a minimum of 1,600 square feet. We were not allowed to quote the pricing but let's just say it will greatly improve the value of our homes. Not one home will be priced lower than the highest price sold in our neighborhood. Ronnie Morton also has cleared the lot beside the entrance with the intent of building (with the assistance of the home builders) a park and playground.

At our next neighborhood Association Meeting we will discuss the possibility of erecting an entrance sign off of Highway 95 designating "The Homes of Bridlewood" making it easier for visitors to locate the various subdivisions of Bridlewood (Bridlewood Estates, Bridlewood Parc and Twelve Oaks of Bridlewood).
