#### **LWHOA GENERAL MEETING**

19 September 2006

#### CALL TO ORDER

General Meeting was started at 6:01 PM by John Clarke in the Library at the Peiffer Elementary School.

Board Members Present: John Clarke (Vice President), Liliana Baylon (Treasurer), Alan Blair (Secretary), Chris Ames (CoHope Representative), Jorge Baylon (Committee Chairman), Ken Krukar (Asst Committee Chairman)

#### II DISCUSSION

- \* John discussed the agenda and introduced Deputy John Rollf from Jefferson County Sheriff's Department
- \* Topics discussed by Deputy Rollf
  - Graffiti is a crime; They have caught some taggers. The penalties typically involve community service or fine. Seldom jail. Most of the grafitti in our neighborhood is not gang related.
  - Be aware of teenagers on line.

Particularly MySpace, 47 million profiles exist; increase by one million per week.

They have set up some stings for on line predators The best defense is alert parents

- Crime Prevention

Crime has been down in our neighborhood. Keep your garage door closed to discourage theft.

Do not leave your automobile running to warm up—it is an invitation to thieves.

It is illegal to leave a car running when it is on the street.

- Questions asked:

Who should I contact for removal of dead animals? Jeffco Road and Bridge, Animal control only responds to domestic animal issues

What is the curfew in Jeffco? Mon—Thurs 11pm to 5am; Weekends Midnight to 5am; Parks close at 10pm. Enforcement is a matter of priority for the sheriff's office

\* COHOPE Report by Chris Ames

- COHOPE meetings are the first Tuesday of each month; Oct meeting presents a candidate forum for local offices
- There is no ordinance against graffiti. A COHOPE representative is working on this
- Suggestion for a "Parade of home renovations" It is a good way to exchange ideas on how neighbors have solved similar home problems.
- There is white van cruising the neighborhood looking for copper in trash
- Watch for news of rezoning reorientation of flood areas; could require some residents to obtain flood insurance
- \* Treasurer's report by Lillian Baylon:
  - 119 residents expressed interest in becoming members; 63 have paid dues; make checks payable to the LWHOA
  - \$1890 have been collected from dues; \$495 was retained from the original HOA
- \* John Clarke reminded the audience of the original goals of the HOA
  - Join COHOPE (Completed)
  - Begin printing the Newsletter (Completed)
  - Neighborhood Event (Completed) Picnic meeting in August
  - Renovate or replace the sign at the west entrance; 3 alternatives were presented

The Board recommended a replacement alternative; One alternative was too expensive One alternative raised issues of permits

- Miscellaneous comments and concerns:

- \*The purchase would require one half of the HOA cash reserves
- \*The sign would show improvement and keep realtors honest regarding covenants
- \*The east side of Lakehurst was not represented in the decision
- \*Insufficient research had been completed

Dan Muldoon offered to compete further research and report back at the next meeting

- \*What else should the HOA plan to spend the dues on? Recommended HOA proceed with the purchase
- \*Other alternatives would require permits and acquisition of rights to place and maintain the sign

A motion was made and carried to table the decision until the next meeting. (16 for; 6 against)

- \* Ken Krukar addressed the group regarding the expiration of the existing covenants.
- \* The time and location of the next meeting was not addressed

III Meeting adjourned by John Clarke at 7:01 PM

The Board of the Lakehurst West HOA is calling for a re-vote on the following.




As a member in good standing with the Lakehurst West HOA, I hereby vote not table the issue of the sign on Simms and Marlowe.
