Welcome/Call to order: 6:34 pm by President Harlan Donaldson Guest Speakers:

 - a. Speeding on Winegarder and running through stop sign on Winegardner and Timberlane between 3:30 and 6. Options

- b. Winegardner park and ravine. Discharge area to ravine and dropoff from sidewalk. Committ to look at drop off because it's a long way down. Must be able to maintain the solution also.
 Guardrail and wall are options, but both have problems.
- c. Other end of ravine water doesn't drain correctly. Swampy. Planning a new line to help drain. Adam (Bullerman, chair on new project line.) will look at.
- d. Trash by Williams/University maybe have motion activated camera.
- e. Seal manhole cover in back. It stinks. Behind 1001 Winegardner.

(Brought map to show where the new line will run and who it will affect. They had a separate meeting with the affected homeowners.)

- a. Talked about new sewer line to add capacity to Ankeny sewer plant. Line is being built in stages from our plant north to Ankeny plant
- b. 1st phase done by year end 2009
- c. 2nd phase (our neighborhood) bidding in February/March
 - i. Whole project done by mid 2011
 - ii. Add some dirt so when it settles. We want dirt put back like it was. Make sure drainage is correct when the project is done.
 - iii. 100 ft wide maybe 60 ft if lose soil
 - iv. 6 ft underground.
 - v. Large enough to be able to walk in. Will be flowing full. The currents are 36 and 42 inches. The new will be further East. Out in field.
 - vi. Going under creek by city owned land/park.
 - vii. Federal money. Other communities will pay to use it.
 - viii. Looking at easement acquisitions now.
- d. What about kids playing on equipment?
 - i. Equipment will be parked in field off Dean
 - ii. Workers will park there also.
 - iii. Companies have dealt with before.
- e. If the company breaks something, they will fix it.
