

#### AUBURN PARK GRAND OPENING



Auburn Park is the brain and work child of this woman, GINGER HITZKE,

who here, in a moment of lonely reflection and internal satisfaction, contemplates the finished and tangible product of her extreme efforts to bring this project to fruition, and her visionary work. Auburn Park is the story, and now the reality, of a unique and majestic building of a Sixtynine-unit work force housing development, a crown jewel shining in the middle of a blighted neighborhood. Auburn Park is the story of many partnerships working together toward beneficial banking, financial, labor, housing/social and community goals...a partnership that was determined to work against all incredible odds produced by a strong, blind and misquided opposition!




Auburn Park is the reality of a very successful and a determined working relationship between a receptive and benevolent Developer, a strongly responsive to his constituent needs Councilmember and a hard working community group that provided constant, responsible and exemplary community oversight for this project. Auburn Park is the involvement of many neighbors who spent long hours in meeting-aftermeeting shaping, changing, expressing needs and vision of a housing development that is to anchored the neighborhood's efforts to revitalize the Fox Canyon rim, the northern most entrance to Auburn Creek [a tributary to grater Chollas Creekl, and the beginning of the long time desired Fox Canyon Park System. Our neighbors were adamant and sure of all the amenities needed within this complex... A management office, along with the community room, built right over the creek and overlooking the park to help control crime, a tot-lot within the complex to provide those children under 12-year old with a separate playing area from those playing in the park below; a community room, with bathrooms within and available to neighborhood groups; a computer room separate from the community room and the jewel: a pocket PARK privately owned and maintained, but "fully accessible to the public"!

Shown here is OUR PRIDE, the first pocket PARK and the catalyst to the continued work needed to advocate for the building of the Fox Canyon Park System [our vision and our continued work to restore the Auburn Creek and attached to it, like: ribs to the spine, five more adjacent empty parcels as pocket parks, to form the totality of a linear park spanning from University to Euclid Avenue]. Following the VISION, the park at Auburn Park borders Auburn Creek's western bank. The creek at this location has been restored with native plants as well as the eastern bank which is an open space preserve. In addition this pocket park was designed to be a walking link between the old [on the lower plane of the park] and the new [18 feet higher-up] University Avenue, where the bus stop is and which is fitted with disabled access as well. In addition, our neighbors designed this park with an instructional gazebo were outdoor events, meetings and presentations will be held and neighborhood tours will be given by the Fox Canyon Neighborhood Association. With the advent of Auburn Park, our neighbors finally see the fruit of their labor and long years of activism shaped in physical form, where this project is concerned. Remember, Auburn Park is only the beginning of a dream to redevelop our neighborhood to be the best with new housing stock, across the board, and with all kind of marketing venues and models available in a balanced formula. These models are to include affordable for SALE, also for RENT and all array of market prices as well, while preserving neighborhood cohesiveness and the now existing single family stock. The achievement of this goal will turn our neighborhood into a strong and sustainable community available to residents from all income levels. As our neighbors walk into Auburn

Park, they know it intimately as they do know their own homes. They find it eerily familiar and recognizable due to the fact that their vision and all of their suggestions, while expressing and reflecting neighborhood needs, are now, for ever, captured in Auburn Park, in a concrete form. An excellent design team of professional architects skillfully chosen by Affirmed Housing Group lent a big listening and emotional ear to the personal voices, community needs, goals and vision of the Fox Canyon people. In accepting this type of development in any particular neighborhood, around the city of San Diego, the leading factor is the strong need for the host community to always remain involved in project development, to be positive, visionary and to HELP the developer in every facet of the project, from the very beginning, until the very end. For community goal achievement, it's necessary to become the leading PARTNER while providing knowledgeable and un-obstructive community oversight. This is to make sure that improvements are up to community standards and wants. And also to help the developer save money in design, blue printing and building/development costs, as the savings can translate into neighborhood amenities, like: more pocket parks, green open spaces, water fountains, trails, walkways, computer/meeting rooms, etc. By the same token, ill conceived opposition and obstruction by myopic leaders only delivers mediocre and very expensive projects to an already victimized, oppressed and blighted community to the detriment of the low income people that these facilities are intended to benefit and serve. Auburn Park is the epitome and the beacon to what is now needed, highly expected and wanted in affordable housing projects, a standard to be compared against to provide much needed housing, parks, meeting places and residents amenities to a deprived and blighted community like Fox Canyon. #### **MINI-DORMS**

As students are pushed out of the College area, their second best choice has always been Fox Canyon and we have noticed their bunching up [double up] among our residential housing. Due to mounting complaints and questions as to "what to do" to get rid of this nuisance and to best recognize a mini-dorm house; read up: (a) description: a big [three or more bedrooms] single family house, in a residential neighborhood, rented to

unrelated [by blood or marriage] people [usually single young adult students working stocked with six to eight and/or more unrelated tenants all with girl/boy [+ regular] friends if not a spouse, attached. (b) Detriment: The previous number of tenants accounts for a total, of a potentially low number, of 20 + people constantly coming and/or going and visiting at all hours, which translates into a horrible number of needed parking spaces that the rented house can not possibly provide. Therefore, the residential parking immediately surrounding the minidorm house gets severely affected, cramped and strongly competitive, resulting in the squeezing out and discomfort of long term established [sometimes elderly, sick and/or disabled] property owners. This discomfort coupled with the noise produced by all these new and transitory people while conducting normal life's business and their bad parking habits [like parking on the curb and blocking driveways "just for a little minute" turning up to be thereon up to 12 hours] also strangulates the superb quality-of-life in a peaceful and quiet neighborhood, like: our own, which already has a severe problem with parking. (c) Solutions: 1. Call the police [531-2000] parking enforcement, immediately with vehicle description, color, make, model and LICENCE PLATES at the first sight of parking on the curb, blocking an entrance [driveway] and/or parking over 72 hours. Even if the police don't show up, they will log the complaint and the vehicle description for later use. 2. Call the police and give them the exact address of the house from which you hear the first sounds of loud music, loud talking, large and loud partying and log in a noise complaint. Even if the police do not respond, they will CAPP the house based on the number of complaints produce by it. Also have all your neighbors bothered and disturbed by these nuisance activities call-in too. Remember: ZERO tolerance always works best! And this helps the police CAPP the offending house quicker. 3. Call the property owner/manager and complaint about the tenants; chances are that the owner/manager doesn't know about the tenants' detrimental behavior, and of the \$1,000 fine charged to the Landlord when dealing with these type of cases. 4. Lastly, call Code Enforcement (George Andrade 533-6139] with the proper property ADDRESS on code violations, vehicles parked on the lawn, excessive trash [trash containners overflowing and with lids not properly/completely closed on trash day] with a request for an administrative citation and for an investigation into a Mini-Dorm house.
