# **Approval of Minutes of Previous Meeting**

A motion was made by Dario Ceragioli and seconded by Bob Horn that the minutes of the previous meeting be approved, as written. The motion carried.

# **Homeowner Comments**

Mary Catherine Fields stated that she lives across from the upper pool. Ms. Fields stated that she has found drug items at the amenity area recently. Ms. Fields stated that she has spoken with her attorney regarding the potential liability of the homeowners association. Ms. Fields suggested that a chain and lock be put at the entrance to the amenity area and he pool gates be chained and locked at 11:00 P.M.

Bob Freeman inquired as to the number of complaints regarding the area Ms. Fields had received and reports of vandalism, but no number was made available.

Randy Rudder stated that he would also support the installation of a chain and lock across the amenity area entrance and the hiring of private security. Dario Ceragioli reviewed past actions taken regarding hiring private security for the amenity area.

It should be noted that the amenity area, including the pools, has signs posted that the area is closed from 11 PM to 5 AM.

Vikki Adkins stated that she would like to request that four additional umbrellas be purchased for the lower pool and new chains for the 4 "belt" swings at the playground.

Mary Catherine Fields stated that there was a problem with noise from the individuals who had been hired by the Willoughby Waves for overnight security the night before the swim meet. Annmarie Wikman apologized for the behavior of the individuals. Annmarie stated that the individuals will not be used in the future.

Joan Atkeison stated she had received calls from two homeowners whose cats had been shot with BB guns and asked that we make homeowners aware of the problem.

Will Sellers stated that at the next meeting of the parking commission, a final vote will be taken on removing the current no parking from 1 to 5 AM and allow a homeowners association to request no parking restrictions on specific streets within their community to the city traffic commission. This would pertain to passenger vehicles only. Will stated that homeowners will need to petition their board of directors to restrict parking on their street.

Will also stated that a new police chief for the city has been hired and will start June 30. Will also stated that a new traffic light will be installed on S. Green Hill Rd. before you get to the railroad tracks (similar to the one on Tulip Grove, north of Chandler).

Brian Snyder stated that 3 homeowners and two board members have volunteered to serve on the neighborhood watch committee. Brian stated that at least ten homeowners would be needed to form a committee.

Bob Freeman reviewed the financial report for the period ending May 31, 2008. A motion was made by Dario Ceragioli and seconded by Melissa Taylor that the report be approved, as presented. The motion carried.

## **Unfinished Business**

Pet Waste Containers at Amenity Area

Brian Snyder discussed some information that he had obtained regarding containers, waste bags and disposal systems for use at the amenity area. After some discussion, a motion was made by Brian and seconded by Bob Horn that two containers be purchased for an amount not to exceed \$800.00. The motion carried with Bob Freeman voting in opposition.

# **Clubhouse Survey**

Brian Snyder reported that he had e-mailed a survey to approximately 450 homeowners with the following results; about 45 returned due to being undeliverable (bad address), 37 homeowners stated that they might be interested in a clubhouse, 62 homeowners stated that they would not be in favor of a clubhouse, and 120 homeowners stated that they would be in favor of a community clubhouse. After some discus-

sion, it was decided that Brian would ask for volunteers to form a clubhouse feasibility committee from the list of homeowner who stated that they would be in favor of one.

### **Security Cards for Entrance to Pools and Tennis Courts**

Bob Freeman stated that he would work on this and have some information in the next few months, prior to working on the 2009 community budget.

# Web Cameras for Amenity Area

Bret Watt and Brian Snyder discussed some information that they had received regarding this. The cost of one proposal was approximately \$ 4,000.00. The cost of the second proposal was approximately \$ 10,000.00.

Bob Freeman stated that he would like to see a demonstration of a system. Brian Snyder stated that he contact the company that he had contacted regarding this.

# Movie Night at the Amenity Area

After some discussion, it was decided that this will be done on July 12. Details regarding this will be posted on the community web site.

# **Architectural Change Requests**

Joan Atkeison stated that she had been in contact with a homeowner who had installed a chain-link dog pen. Joan stated that she had informed the homeowner that chain link fencing had not been allowed but that the homeowner needed to complete an architectural change request form. Joan stated that the homeowner had refused to complete the form. A motion was made by Bob Horn and seconded by Dario Ceragioli that a letter be sent to the homeowner informing him that the architectural change request form must be completed and that if it is not completed and returned within ten days to Association Management Services, the matter will be referred to the attorney for the community. The motion carried.

## **New Business**

Security at Amenity Area

Brian Snyder stated that he felt that in light of recent events at the amenity area, off-duty Mt. Juliet police officers should be hired again for a thirty day period to patrol the amenity area in the evenings. Bob Freeman stated that he felt that the board should meet with the new police chief of Mt. Juliet before this is done. After some further discussion, a motion was made by Brian Snyder and seconded by Bob Horn that off-duty officers be hired to work between 8:00 P.M. and midnight, four nights a week, for a thirty day period. The cost will not exceed \$ 30.00 per hour. The lights will be turned back on at the basketball court and tennis courts. The motion carried with Bob Freeman voting in opposition. Brian will coordinate this with the Mt. Juliet Police Department.

# New Umbrellas for Lower Pool and Chains for Playground Swings

Bob Freeman asked if action could be taken on Vikki Adkins request for four new umbrellas at the lower pool and new chains for the playground swings. Bob stated that umbrellas could be purchased for apPage 5 Willoughby Station News

proximately \$ 80.00 each. It was agreed that two umbrellas should be purchased. Bob will get information about the chains for the swings and forward it to the board for approval.

The next meeting of the board was scheduled for July 16.

# Adjournment

There being no further business to come before the board, a motion was made by Brian Snyder and seconded by Bob Horn that the meeting be adjourned. The motion carried and the meeting was adjourned at 9:23 P.M.

# Neighborhood Watch Program forming for Willoughby Station

The Willoughby station HOA board is developing it's neighborhood watch program. This program creates a path to spread word of neighborhood events and develops a plan for reporting events in our neighborhood. The first step in forming an effective watch program is to develop an initial volunteer base. We need approximately 10 initial volunteers to form the first tier of the program. He entire program will need many more volunteers, and we are open for additional volunteers as well. The basic plan works this way: When you see a strange event going on, you call your area captain. The captain calls their next level and that leader contacts a pre-designated officer of the Mt. Juliet Police Department. We will be developing the plan further, but that is basically how it will work. We need 10 initial volunteers to form a tier of the chain.
