SCA: What it is —What it is NOT!

Stoneybrook Community Association is a non-profit neighborhood organization comprised of volunteers who want to affect positive change that benefits the entire neighborhood. We are NOT a Home Owners Association (HOA). HOA's have the authority, through homeowner covenants, to regulate such things as the color you can paint your house and where you can put your trees. Community Associations are generally used as a tool to communicate issues that affect our neighborhood. This allows us to respond to and become involved with issues such as crime, zoning variances, transportation studies

and other community issues. The primary purpose of the SCA is to promote, preserve and respect the health, safety and welfare of our residents. SCA's mission is to represent the interests of the residents through community involvement and commitment. One of SCA's goals is to obtain federal, non-profit tax status, which would enable select contributions and donations made to the association to be eligible for "charitable deduction" status. The future of our community depends on neighbors working together and developing a strong organization that is committed to maintaining our community and our homes.

What is Community Policing?

Partnership—Effective community policing has a positive impact on reducing neighborhood crime, helping to reduce fear of crime and enhancing these things by combining the efforts and resources of the police, local government and community members.

An Idea for the Times—Community policing is a collaborative effort between the police and the community that identifies problems of crime and disorder and involves all elements of the community in the search for solutions to these problems. It is founded on close, mutually beneficial ties between police and community members.

Community policing offers a way for law enforcement to help re-energize our communities. Developing strong, self-sufficient communities is an essential step in creating an atmosphere in which serious crime will not flourish.


Renewed Emphasis on Crime Prevention—Law enforcement is looking to enhance its tough stance on crime with renewed focus on strategies that help prevent crime, reduce fear of crime and improve the quality of life in neighborhoods. This requires an intimate knowledge of the community. Policing concepts currently in vogue have tended to isolate officers from the communities they serve which can hamper crime-control efforts. Community policing allows law enforcement to get back to the principles upon which it was founded, to integrate itself once again into the fabric of the community so that the people come to the police for counsel and help *before* a serious problem arises, not after the fact. A Recap of SCA's First Meeting

More than 60 residents turned out for SCA's first meeting, held on Tuesday, October 24, 2006. Councilman Kenneth Oliver (4th District) attended this meeting and addressed several issues. Some of the topics discussed included:

- Liberty Road West business and transportation plans—New businesses: Super Wal-Mart and Ruby Tuesday coming soon (projected date of 2007) to the Liberty & Brenbrook Roads corridor. It was also stated that no public transportation routes are being planned for community streets in Randallstown.
- Large number of group homes in Randallstown. Currently, Randallstown houses 64% of the total state-licensed homes.
- Need for better traffic control-ie, speed bumps, stop or yield signs, traffic lights, islands or middle turn lanes for increased traffic areas
- Community sweep of abandoned and/or undriveable vehicles and commercial trucks or vehicles per county code enforce-
- Increased "gang" activity as noted in the community

Councilman Oliver stated that areas of concern for residents can be resolved, but only with 90% of the community residents' participation.
