Badger Drive HOA

There has been no word of any changes regarding the Badger Drive HOA. There are uncollected assessments (separate from the Seneca Whetstone HOA) and no one has stepped forward to organize as a Board. The SWHOA Board will have to pursue this issue. One problem is that the amount of time and energy necessary to take on this task seems daunting. Even so, this issue needs to be addressed as improvements to the individual units are needed and required as part of the bylaws governing our community as a whole.

Seneca Heights

Assessments

The assessments for the trash collection were due in mid-July. Some homeowners have failed to pay this assessment. Additionally, there are a few who have not paid the annual assessment. Late fees are being charged and those with accounts continuing to be past due will be sent to collections. If a homeowner is unable to pay the assessment, they should contact the Board immediately to make a payment arrangement.

Street Lights, Sidewalks, and Trees

The streetlights were painted! There has been no word on sidewalk repairs. It also seems as though the trees along the streets could use some trimming. Another request will be made to the County to complete this task. In the past we have been told they stopped this service due to budget cuts. Homeowners may be asked to consider clearing some low branches along sidewalks.

Curbing Your Dog

Please remember **Montgomery County law** requires a pet owner to clean up the mess left by their pets. You can be fined \$100 if someone files a complaint.

Montgomery County Code, Sec. 5-203 (a)(2):

An owner must not allow an animal to damage or defecate on property outside of the owner's property. An animal may defecate on public property or the common area of property in which the owner shares an interest if the owner immediately removes and disposes of the feces by a sanitary method approved by the Director.
