Wow! The neighborhood looks good in the spring! All neighbors are commended for expert lawn upkeep, landscaping, and diligent trash pickup in the common areas. Thanks!

For our part, the Board continues to maintain your neighborhood services, particularly the grass cutting and the trash collection. For these and other services, we need prompt payment of dues. Please send your check if you haven't done so already. We will now aggressively pursue payment on long-outstanding accounts with legal help, and the fees will be paid by the homeowner.

We also are keeping an eye on the future of Old Game Preserve Road. The Travis Avenue Self Storage Zone proposal is moving ahead; the City of Gaithersburg Planning Commission has asked the developer to complete plans and land purchases and to seek approvals from the County on storm water management improvements. NEIGHBORHOOD WATCH

Officer Diane Tillery reported that on May 15, 2007, at approximately 9:17 p.m., the owner of the home at 19212 Jericho Drive called the police to report that someone was on her back deck. The person reportedly said that he was waiting for someone. The suspect left the deck before the call was made to the police and officers circulated the area for 35 minutes looking for someone.

Also, someone was seen walking down Eberhardt Drive and in between two homes on the court in the evening on May 16 around 8:30-9:00 p.m. It appeared he was taking a shortcut down to Game Preserve Road. Neighbors are encouraged to keep an eye out for any unusual occurrences or unfamiliar faces in the community and to report them to local authorities. FROM THE TREASURER

We are now in week 22/23 of the Fiscal Year and surprisingly, 20% of the members have not submitted their annual dues. We will be sending out reminders soon and if this applies to you please send your assessment to the address on the Newsletter. If you (or your realtor) require confirmation of dues payment please get in touch with Jay Long.

Starting the year we had a handful of people who still had not sent their assessments, but since then most of our members have brought their accounts current. However, we still have several individuals who have outstanding balances that are several years old. In these cases we are taking a zero tolerance approach and will be pursuing restitution through legal means. Essentially, these individuals are costing us all.

On a lighter note, the board has noted several budgeted areas that are complete and their entire budget has not been used. The board reviewed this situation and has agreed to fund at least a partially catered picnic – so hopefully it will be a go. Any assistance you can provide would help.

FROM THE SECRETARY

We are working to consolidate all the directory updates to finish up the 2007 directory and we will probably have both a hard (paper) and a soft directory. No promises, but a by soft directory we mean we are trying to generate a web page for the Neighborhood Link site for address and phone number lookup. We are currently addressing issues such as homes that have requested not to be in the directory and encrypting the information.

TRAVIS AVENUE SELF-STORAGE

Our Secretary/Treasurer attended the City Council meeting on April 18, 2007, for the new storage facility on Old Game Preserve and unfortunately it looks like it will go forward. In testimony, Jay reiterated the concerns SWHOA presented in September of last year—safety of the road, traffic flow, access issues, and "green" development. To each, the developer commented on what they were doing and received complete support from the city. Many of the issues associated with the county road (down to Arrowsmith) they are not addressing.

This we do know—from the new development to Travis they will widen the road (purchased the land from Pepco) but will not change the grade. The bump by Travis will stay due to the gas line under it. They will route their drainage to the culverts under Arrowsmith and pick up the car lot runoff on the way. The city will allow big trucks to leave the storage facility either north or south on Old Game Preserve, unlike Fitzgerald's where traffic is directed south only (away from our neighborhood). We may need to request a one-way sign on Old Game Preserve from the county.

A general note here—if you see white zone change signs near the neighborhood, take note and consider attending the public meetings. Jay was the only SWHOA voice at this meeting and additional voices would have made a difference.

REMINDERS...

Yield and **Stop** signs have a purpose. Please observe them—particularly the Stop sign at the end of Gatlin Drive. Recently a driver was observed turning left from Gatlin Drive onto Game Preserve Road without even slowing down, much less stopping at the stop sign. Unfortunately, this is not an isolated occurrence. We all are in a hurry these days, but a few seconds stopped at a Stop sign will not make a difference in the time it takes to get where you are going—but it could mean the difference between getting where you are going or having a fender-bender (or worse).

Also, please remember to maintain a <u>maximum</u> speed of 25 M.P.H. in the neighborhood. It's the law, and more important, our children's lives depend on <u>your</u> safe driving.

Please remember that **Montgomery County law** requires pet owners to clean up the mess left by their pets. You can be fined \$100 if someone files a complaint.


Montgomery County Code, Sec. 5-203 (a)(2): An owner must not allow an animal to damage or defecate on property outside of the owner's property. An animal may defecate on public property or the common area of property in which the owner shares an interest if the owner immediately removes and disposes of the feces by a sanitary method approved by the Director.


