### PROTECT YOUR PROPERTY

Lock doors and windows every time you leave your car. Get out of the habit of leaving keys in the car, even when the car is parked in your drive or garage. 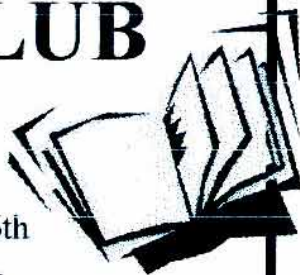

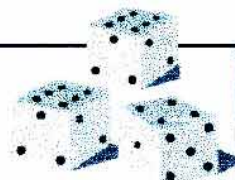
### Special Summer Playgroup Times

# DAMAGE TO TENNIS COURTS

Recently the Copperfield Homeowners Association (CHA) noticed that damage has been done to our brand new tennis courts. The west court has black stripes on the top surface, the bench on the east side has been broken, the net on the east court has holes in it and the tension wire has broken. This damage did not occur due to playing tennis, but due to the abuse by skate boards and other devices. The tennis courts are for playing tennis only as stated on the sign next to the gate. Any other activities, including but not limited to, skate boarding, bicycle riding, practicing lacrosse, baseball, or any other sport, are subject to prosecution. We are appealing to all parents to instruct their children to stay off the courts. We are asking all residents to take ownership of the courts and assist the CHA in keeping kids off the courts. We collectively own this asset and you have the right to ask a child to leave. TAKE ACTION! IT'S YOUR POCKETBOOK. In case a minor is caught at the tennis courts performing an activity other than tennis, the CHA intends to pursue the parents or guardian for damages done in past and present.

# Kids' Summer Fun

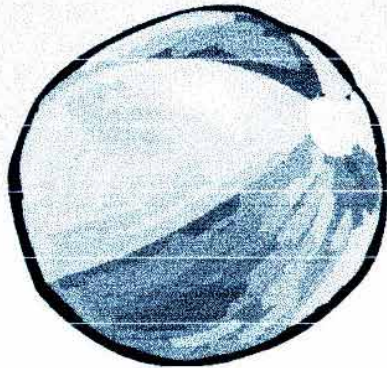

## Copperfield Pool Reminder

The Copperfield pool is for the use of Copperfield residents and their guests only. We do not sell outside memberships to anyone. Neighboring communities (Including Overlook, Locust Point and Midland Meadows) do not pay dues to us, are not members of the Copperfield Homeowners Association and are not members of the pool. This was a decision made by resident consensus. Several complaints have been made to the Hotline on this issue. If you see a violation of any of our pool rules, particularly violations of the guest policy, please address it with the person violating the rule, inform the lifeguards and call the hotline with details (254-2113). We do not have any full time paid staff so it is expected that if you want to see issues corrected that you personally get involved.

As a reminder from previous years: The lifeguards have been instructed to admit only persons with a validated (2007 sticker) Copperfield pool card. An adult guard will be present at the gate at random times to help enforce the above mentioned policy. Any Copperfield resident caught loaning a Copperfield pool card to anyone will have their pool privileges suspended for 2 weeks. A second violation will result in the loss of pool privileges for up to one year. The loss of pool privileges will apply to all residents residing within the household of the violator. All residents should be able to identify themselves through a drivers license when requested. Our policy concerning guests is shown below.

### Guests

- Guest fees are \$2.00 per individual guest or \$5.00 per family, per day.
- Members must accompany their guest(s) and are responsible for their conduct.
- The same guest(s) are not permitted to use the pool more than 4 weekend days a year and no more than 8 days total.
- Out of town guests may accompany residents for the duration of their visit.
- CHA reserves the right to limit the number of guests.
- Residents of Copperfield cannot be guests of members.
- No one under the age of 15 is allowed to bring a guest.

# COPPERFIELD HOMEONERS ASSOCIATION (CHA)

## POOL RULES

### General

1. Members must have their validated membership card with them when using the pool.
2. Membership cards can be replaced at a cost of \$15.00.
3. A babysitter, who is employed by a member and not a resident of Copperfield, can obtain a 1 year membership card for \$15.00.
4. Unauthorized use of the facilities is considered trespassing.
5. CHA cannot be held responsible for any injuries sustained by members or guests.
6. All persons must shower before entering pool.
7. Swimmers must wear swimming attire. No blue jeans are permitted.
8. Swimmers must maintain a safe distance from the diving board area.
9. No diving in the shallow end of the pool.
10. No swimming unless there is a lifeguard on duty.
11. No running or rough play allowed.
12. No glass within the pool area.
13. Bicycles, scooters, skates etc. are not permitted within the fenced pool area.
14. Pool toys are permitted with the lifeguard's permission. Toys that the lifeguard considers dangerous or that infringe on the rights of others are not allowed.
15. No chairs are permitted within 8 feet of the pool edge to permit an unobstructed walkway around the pool and to protect the pool coping.
16. In the event of thunder or lightening, members must exit the pool and pool deck. The lifeguard on duty will determine when swimming can resume.
17. People in wet bathing attire are not permitted in the clubhouse. The clubhouse is closed during normal pool hours unless a member has rented it.
18. Pool deck furniture is not permitted outside the fenced pool area or in the pool.
19. No animals are allowed within the fenced pool area or clubhouse.
20. No food, gum, drink or tobacco is allowed within 5 feet of the pool water edge.
21. Alcoholic beverages are not permitted within the fenced pool area. The CHA reserves the right to permit alcoholic beverages at special events.
22. Private parties are limited to 15 people during operating hours.
23. Any rule violation or vandalism will result in loss of pool privileges and/or prosecution.
24. Lifeguards may enforce these, and any other, rules as they see fit to ensure safety and members' satisfaction. Lifeguards are authorized to take disciplinary action to enforce these rules.

### Children

25. Children under 11 years old are not permitted to use the pool without a member 15 years old or older responsible for the child.
26. If a lifeguard has any doubt about any person's ability to swim, that person may be required to demonstrate swimming proficiency and/or required to be accompanied by an adult on future visits.
27. Children who cannot swim unassisted are not permitted to use the diving board or be in the deep end.
28. The baby pool is for use by children 6 years old or younger and accompanied by an adult. There is no lifeguard on duty at the baby pool.
29. Children 6 years old and younger may accompany an adult during adult swims.
30. Children that are not potty trained are not permitted in the pool without swim diapers.

### Guests

31. Guest fees are \$2.00 per individual guest or \$5.00 per family, per day.
32. Members must accompany their guest(s) and are responsible for their conduct.
33. The same guest(s) are not permitted to use the pool more than 4 weekend days a year and no more than 8 days total.
34. Out of town guests may accompany residents for the duration of their visit.
35. CHA reserves the right to limit the number of guests.
36. Residents of Copperfield cannot be guests of members.
37. No one under the age of 15 is allowed to bring a guest.
