Curfew Reminder

CURFEW AT A GLANCE

Columbus Division of Police

AGE RESTRICTED HOURS

Under 13 One hour after sunset to 4:30 a.m.

13 through 17 Midnight to 4:30 a.m.

Rule:

- A minor <u>under</u> the age of 13 years is found loitering, idling, wandering, strolling or playing in or upon the public streets, other public places, places of amusement and entertainment, vacant lots or other unsupervised places, during the restricted hours. 2319.30(A) M-3
- A minor 13 years of age or older is found loitering, idling, wandering, strolling or playing upon the public streets, other public places, places of amusement and entertainment, vacant lots or other unsupervised places, during the restricted hours. 2319.30(B) M-3

Exceptions:

- The child is with a parent or legal guardian.
- The minor is a member of the United States Military or a registered full time student at a business school or institution of higher learning – a valid identification card must be shown.
- The child is on an emergency errand or legitimate business directed by parents or legal guardian – this will be verified.
