CRIME STOPPERS

Greetings Crime Stoppers Supporters!

This month, Crime Stoppers rewarded 5 tipsters for their calls to Crime Stoppers' anonymous tip line—7 arrests were made in connection to these cases. One tip led to the arrest of a suspect for an armed robbery of a North County gas station. The suspect has pled guilty. Channel 8 worked with us to profile a fugitive in violation of probation for a domestic violence charge. This dangerous individual was known to carry a gun. With the help of our tipster, the suspect was arrested for the probation violation and also charged with possession of ecstasy, marijuana, and a firearm. An anonymous tipster called in to report the sale of drugs out of a home in Chula Vista. While the Chula Vista Police Department did not find drugs at the house, the suspects were in possession of several stolen vehicles, tools, and other valuables. To date, these arrests closed three

burglaries and most cases are expected. We also had cases that led to arrests for possession of a controlled substance and a fugitive wanted on an assault with a deadly weapon case. KUSI, our media sponsor for our upcoming 5K race, will be featuring Crime Stoppers related stories for the next three Tuesday mornings. Be sure to tune in! UNDERGROUNDING

Fox Canyon Block 7-A

Our neighbors continue to inquire about the utility undergrounding status, and here it is folks: Fox Canyon Residential Block 7-A has left the Hearing status, and it is now in the "DESIGN" phase. To learn more visit: http://www.sandiego.gov/undergrounding/, then click on: "Master Plan", then click on: "Utilities Undergrounding Mapping Application", Click on: "List of Projects by Council District Priorities". Find "Project Block 7-A" and on the right, click on: "MAP". Also remember that all of the Fox Canyon rim: the entire community of Islanair and Euclid Avenue 4J [from University to Altadena], Altadena [from Euclid to Wightman], Wightman Street [from Altadena to Winona] and Winona Avenue [from Ontario to University] are within the Fox Canyon Residential Block 7-A. The entire Block 7-A is scheduled to leave the design phase and start construction on June 29, 2009, and the entire canyon rim project is schedule to be completed on June 29, 2012. This is a huge project.

NEED TO DO HOME REPAIRS?

HELP and **PITCH** are ON THE WAY!

Fixing an older and deteriorating home doesn't have to be a traumatic and lonely endeavor; as there's HELP available with NO need to hustle and Price Charities is willing to PITCH - in. The Crossroads Redevelopment Project Area [PAC] provides tax increment dollars to fund its FORGIVABLE loans Housing Enhancement Loan Program [HELP] focusing on residences in the Fox Canyon Communities within the PAC map [excluding properties fronting the south of University, east of Euclid, All of Dwight and Castle]. A one-time only HELP loan up to \$15,000, at an annual simple interest rate of 3% which is forgivable over twelve (12) years shall be available to single family and one-unit and two-unit owner-occupants of residential properties located in the target area indicated above those gross household income do not exceed certain income limits

[check those at www.FoxCanyon.Org click on Community Pages, then H.E.L.P-4-Fox Canyon – También en Español. Presently, there are funds available to assist a good number of homeowners, and there is NO waiting list for Crossroads/Fox Canyon applicants. To apply, for the HELP and/or for information, call Lyle Knudson at [619] 578-7521, or by email at wyle@sdhc.org Neighbors if your house is in urgent need of repairs, in addition, to the Crossroads HELP and the Price Charities PITCH programs, the San Diego Housing Commission has a website with a summary chart of rehab programs available, including Crossroads: http://sdhc.net/hahelpfix1.shtml And other, which include: (a) Loans and grants for owner-occupied homes, including mobile homes, (b) Programs to help with lead paint removal on owner-occupied and rental properties and (c) Grants to tenants with disabilities to make accessibility improvements in rental properties.

PRICE CHARITIES PITCH IN!

In addition and in conjunction with the Crossroads HELP forgivable loans, Price Charities has initiated a homeowner rehabilitation program for residents of City Heights [ALL of Fox Canyon included] who own and occupy single family and condominium homes. The Participate in Transforming City Heights [PITCH] rehabilitation loan program provides up to \$25,000 to owners who earn no more than 100% of the Area Medium Income (\$64,000 for a family of four). Owners who want to make repairs and improvements to their homes are provided assistance in identifying and specifying a scope of work which is performed by a private contractor of the homeowner's choice. Eligible work includes roofs, kitchens, windows, plumbing, electric, exterior and interior improvements. Loans are made for a period of 15 years with current interest rate. This unique program allows eligible borrowers and household members age 14 and older to "pay" interest owing on this loan in full by performing qualified community service hours at specified City Heights based non-profit organizations and other agencies, like: local schools, YMCA, Park & Rec Programs and Neighborhood Associations. The PITCH rehabilitation loan program offers flexible underwriting criteria to assist those with housing repair needs. The program may also be combined with other housing rehabilitation loan programs such as those offered by the San Diego Housing Commission [Crossroads/Fox Canyon H.E.L.P] to increase the overall amount of funding. Please, remember that the Fox Canyon Neighborhood Association is a Price Charities registered Community Service Organization [CSO] giving service hours credits to PITCH participants when volunteer-working in anyone of our programs and/or community events.
