

## GRAFFITI CONTROL PROGRAM CITY OF SAN DIEGO

#### **NOTICE**

This is to notify you that it's unlawful to maintain graffiti on your property per: San Diego Municipal Code Section 54.0405, GRAFFITI PROHIBITED which states:

- (a) It is unlawful for any person to place graffiti upon any public or private property.
- (b) It is unlawful for any person to maintain graffiti placed upon, or to allow graffiti to remain upon, any surface within that person's control, possession or ownership

The City of San Diego and the San Diego Police Department (SDPD) Graffiti Strike Force take graffiti very seriously, allowing graffiti to remain after 24 hours often results in more graffiti, an increase in crime and a reduction in property values. It is important to quickly remove all graffiti. If you plan to personally paint it out, you can assist law enforcement by: 1) taking a photo (please include the name, date, and time of the incident) before you paint it out; and 2) calling SDPD at (619) 531-2000 to file a police report.

If you fail to remove graffiti from your property in a timely manner you may be subject to administrative penalties and/or misdemeanor prosecution. Fines range from \$100.00 to \$1,000.00.

The City of San Diego offers free resources to assist you. For information, call: (619) **527-5419**.

- Free recycled paint is available in limited colors and quantities, along with paint supplies and information on removal techniques
- If you are a property owner who is unable to remove the graffiti (an elderly person or a person with a disability) you may obtain a Consent Form to grant the City the authority to remove the graffiti at NO charge.

If you witness someone spray painting or committing an act of graffiti, call 9-1-1 with the location and a description of the suspects and vehicles. Do not confront a graffiti vandal. They often carry weapons and have look-outs you may not see.

#### Graffiti hurts everyone.

Thank you for doing your part to help eliminate blight in our neighborhood.

#### AVISO OFICIAL

For medio de la presente, se le notifica á usted que es ilicito mantener graffiti en su propiedad.

El Codigo Municipal de San Diego, Articulo 54.0405 declara: SE PROHIBE EL GRAFFITI.

- (a) Es ilicito el que cualquier persona coloque graffiti, ya sea en propiedad privada ó en propiedad publica.
- b) Es ilicito el que cualquier persona permita que el graffiti sea colocado, ó que permita que el graffiti permanezca sobre cualquier superficie bajo el control, posesion, ó propiedad de dicha persona.

La Municipalidad de San Diego y la Unidad Anti Graffiti/Graffiti Strike Force del Departamento de Policía de San Diego, consideran el graffiti como un grave acto de vandalismo. Por lo general, al permitir que el graffiti permanezca en exceso de 24 horas resulta en mas graffiti. También fomenta un incremento en actos dilectivos y de vandalismo, crimenes y contribuye a la devaluation de su propiedad. Remover todo el graffiti de su propiedad lo antes possible, es muy importante. Si usted planea remover el graffiti personalmente y de esa manera colaborar con las autoridades correspondientes, se sugiere que haga lo siguiente: 1) Tomar fotos del graffiti antes de removerlo y 2) Reporte el incidente llamando al Departamento de Policía de San Diego al (619) 531-2000. Incluya en sus fotos la fecha y hora del incidente, asi como el nombre del vandalo, cuando esto sea posible. Las multas correspondientes en contra de los propietarios que no remuevan el graffiti oportunamente varian desde \$100 a los \$1,000 dolares.

La Municipalidad de San Diego le puede proporcionar a usted materiales y pintura para remover el graffiti. Para obtener mas information comuniquese al: (619) 527-5419

- La disponibilidad de colores y tipos de pinturas son limitados, al igual que los materiales para remover el graffiti y el suplemento de información referente a metodos para remover la pintura.
- Si usted es un propietario de edad avanzada ó es una persona invalida, ó discapacitada, puede obtener una Forma de Consentimiento autorizando a la Municipalidad para que remueva el graffiti de su propiedad gratuitamente.

Si usted es testigo de un acto de graffiti ó ve a personas pintando con aerosol, comuniquese al 9-1-1 de inmediato y proporcione el lugar ó dirección, descripción de los sospechosos y el numero de placas de los vehículos. No confronte al vandalo de graffiti. Muchas veces ellos portan armas y colaboran con personas que usted tal vez no pueda ver a simple vista.

## **AUBURN PARK**



#### **CRIME STOPPERS**

Greetings Crime Stoppers Supporters! This month, Crime Stoppers paid out \$3,250 in rewards to anonymous tipsters for information that led to arrests in 7 cases that took place in San Diego County. One tip helped the Chula Vista Police Department solve a homicide that took place in July. Andrew Hicks was shot and killed outside of Wild Woolly's Bar. The anonymous tip led police to the suspect and his accomplice, who were arrested and are now in jail.

Another tip helped to solve more than 175 cases of identity theft. Six arrests were made, including the ring leader. After receiving our tip, investigators throughout Southern California collaborated for several months to put together the case. Victims suffered more than \$500,000 in losses as a result of this identity theft ring.

An anonymous tipster identified the person responsible for attacking a developmentally disabled man in Poway. Victim's jaw was broken—requiring surgery and a three-day hospital stay. A Campus Crime Stoppers tip led to the suspension of student for assaulting another student on a school bus.

We had three narcotics cases this month for marijuana, crack cocaine, and ecstasy. One tip led to the recovery of \$260 ecstasy tablets. Another led to the seizure of ½ lbs. of crack cocaine.

Your support of Crime Stoppers helps us to fund our tip line and reward program that truly help law enforcement solve crime.
