# A+ Committee Draft Resolution

The diverse 100-person A+ Committee is headed by past mayors Federico Peña and Wellington Webb as well as Ann Bye Rowe, DPS parent and board chair of the Colorado Children's Campaign, for the purpose of supporting Denver Public Schools (DPS) reform to make DPS into the best public school system in the country. In addition, there are several foundations and other community-based organizations represented. All have given hours of time, studied tons of, for the most part, very reliable data, and listened to many discussions.

A+ has made presentations at INC in recognition of the serious neighborhood impacts of school closings. The DPS Board of Education will consider voting on recommendations of the Finance and Facilities subcommittee at its August meeting or shortly thereafter although no physical changes will be made in the schools until the 2008-09 school year. We are proposing an INC position for presentation at the August 11 general association meeting.

The following is a draft of a possible motion to be discussed, edited, and approved at the August INC meeting:

"Whereas 30,000 Denver school-age children do not attend Denver Public schools; whereas the School District's budget cannot sustain itself given the present long-term trend of declining enrollment; whereas the Denver Public School system is threatened with possible financial insolvency; and whereas, this trend cannot be reversed quickly, even with strong academic changes, therefore

INC supports the recommendations and criteria presented to the community by the A+ Denver Finance and Facilities Committee for closures, consolidation, realignment, and reprogramming - particularly for schools with low enrollment and poor academic performance provided that the money saved by these changes is used to improve student achievement for children impacted by the changes and across the board for all DPS students. INC recommends to Denver Public Schools that these recommendations be:

- Applied in geographic clusters, such as Northwest, Southwest, Southeast, Near Northeast, and Far Northeast because each section of the city has different needs, current resource levels, and population dynamics;
- Accompanied by detailed implementation and transition plans so that parents and students know in advance what is happening at which schools and what their choices are or will be;

• Followed by a rigorous assessment strategy and program so that the community will know what results were obtained from any changes.

INC further recommends they be implemented:

- As part of an open, participatory, two-way communication process involving the community at large, parents, and Denver's neighborhoods that informs, listens, and responds to questions and concerns. Two good examples of this are (1) the model used by the city of Denver for zoning and permit applications and (2) the process used at A+ in a series of recent community meetings; and
- That all individuals, neighborhoods, community organizations, and schools be treated in an equitable manner."

# **Executive Committee Minutes**

The meeting was called to order on July 9<sup>th</sup> at 6:30 p.m. Present were: Larry Ambrose, Ken Beaudrie, Al Habercorn, Mike Henry, Charles Howard, Steve Nissen, Dave Webster, and Brad Zeig. The June minutes were distributed. Approval was put off until everyone had a chance to digest them.

Treasurer Halbercorn reported INC is doing well. There is \$30,008.48 in all accounts in the bank. There is more than \$6,000 in the checking account. Larry Ambrose suggested that the bulk of these funds be placed in a money market where it would earn at least some interest. It was agreed that someone, at some time, should look into this. A motion was made and seconded to approve the Treasurer's report. It passed.

A motion was made to approve the June minutes as amended as follows: "Proposed subject for meeting, Infrastructure Task Force." The motion was seconded and "do passed."

A discussion of the Dollar Dictionary project ensued. Labels need to be updated. Charles is waiting for the labels. As of July 6, all RNO's are being acknowledged. The name of the applicable RNO's is placed on the dictionaries in geographic areas where they are passed out.

We applied for a grant from Xcel for the dictionary drive. Dave will follow up on the status. There was some detailed discussion regarding how many dictionaries are to be distributed and where. Larry will check on why Brown Elementary School's Principal did not want the dictionaries and why she did not respond to questions.

Membership was discussed. Ken said membership forms were emailed to all RNO's and memberships were solicited at the Neighborhood Citywide Conference in June. He was not sure if we have any new members. The idea that the City might help solicit membership was brought up. Although this could be a double-edged sword, Dave will talk to Julius Zasko about options.

Newsletter – Dave will do an article about the Citywide Conference. Mike pointed out the impressive distribution of attendance from a plethora of neighborhoods. Ken is having trouble with emails coming back from the City. Everyone was confident he would figure out the problem.

Mike will publish the ZAP Ruby Hill letter he sent to Council in the Newsletter along with results of the July 9 vote.

The INC Dinner will probably be moved from November to January or February 2008. Volunteers are needed. The Denver Metro Convention and Visitors Bureau (DMCVB) has made possible the Dinner in the past. Dave and Larry will visit Bill Mitchell to see if the DMCVB will

# Minutes of the Delegates Meeting

The meeting was called to order on July 14<sup>th</sup> at 9 a.m. at the Community Room of the Mount Loretto Apartments.

Regina Huerter, Executive Director of the Crime Prevention and Control Commission, presented regarding the mission, directives, authority, and goals of the Commission and the strategic priorities of the Metro Denver Gang Coalition. The goal of the Commission is to reduce the need for jail beds through recidivism reduction and community satisfaction. Youth crime prevention is to be accomplished through education, reduction of child abuse, family accountability and interventions, and curfew enforcement. In general, they City aims to hold young people accountable. The criminal justice system has become a holding place for the mentally ill. The City is involved with faith-based service providers in the area of adult reentry.

Ms. Huerter said gangs and graffiti are symptoms of other things that are taking place on the street. Some gangs have 4<sup>th</sup> generation members. The members have been taught gang values by their parents, grandparents, and great grandparents. Zipcode areas 80219 and 80205 are gang hot-spots. Huerter says emphasis is being placed on prevention, intervention, enforcement, and developing an infrastructure for organizations to collaborate on implementing integrated and effective interventions. The City will work with DPS which has been "proactive in dealing with kids." The City is dealing with graffiti through enforcement and abatement.

Dennis Gallagher pitched the Our Lady of Mount Carmel Festival at 37<sup>th</sup> and Navajo. He said the festival has not changed since the Chauncey Smaldone attended during prohibition. In his inimitable style, he announced that he had been encouraging kids who do graffiti to be more creative by tagging in calligraphy.

John Hambright, Program Fellow from the Mayor's Greenprint Denver Office, presented a "Draft Climate Action Plan" developed by the Greenprint Advisory Council. The plan's intent is to "set goals and guiding principles." Goals include qualitative goals and deadlines and making Denver a national leader by example. Actions include "incentivizing" energy consumption, penalizing consumers for using too much energy, and establishing a community bank to make loans for home energy efficiency. # **ZAP Committee Minutes**

The INC Zoning and Planning (ZAP) Committee met July 28. Peter Park, the Community Planning and Development (CPD) Manager, spoke about changes that have been made at CPD to improve the planning and the permitting processes. A greater volume of work now can be accomplished and with more clarity. He distributed charts, lists, and a map of Area Plans—both Neighborhood/Small Area Plans (SAPs) and Transit Oriented Development. Please go to www.denvergov.org/planning for links to this information or call CPD at 720-865-2915.

Steve Gordon is now the Comprehensive Planning Manager at CPD and reported on the status of various plans. He said that periodic assessments for neighborhoods are made including updates of statistics and trends and reference to new city strategies and regulations. These include the Strategic Parking Plan, Transportation Plan, Living Streets Initiative, and others.

The goals are to think in broader terms—State, US, and global; to improve communication with citizens; establish a review process for SAPs; and interface with Neighborhood Inspections. Future projects include the extended Speer-Leetsdale corridor, Arapahoe Square, Ball Park, University Hills, an update of citywide needs, and reviews of Blueprint Denver and River North plans. ZAP was reminded that SAPs are "guidelines" and not mandates for city action. Perhaps we need to propose legislation to give

As neighborhoods have experienced with e-mail notices now circulated by the Board of Adjustment for Zoning Appeals, electronic information is easy for you to forward to others for comment while avoiding the photocopy expense, postage, and delay of printed notifications. In addition to the added convenience for neighborhoods, the electronic distribution is a more cost efficient and environmentally friendly way for the City to do business.

Notices of rezoning applications will be circulated via e-mail starting on August 1<sup>st</sup>. We will continue to provide printed notice of rezoning applications for those registered neighborhood organizations that prefer it. It is especially important for registered neighborhood organizations to maintain a correct e-mail address and contact person with our office. Changes should be forwarded directly to Julius. Zsako@DenverGov.Org.

Future rezoning applications will be published on www.DenverGov.Org/Rezoning starting on August 1<sup>st</sup>. In the event an application is received for a property that is

located within 200 feet of a registered neighborhood organization's boundary, Joel Pousson will notify the RNO contact person by e-mail fifteen days in advance of the scheduled Planning Board meeting at which the application is to be discussed.

Please remember that all organizations are required to re-register each year between December 1<sup>st</sup> and January 31<sup>st</sup>. I will be in touch again in December concerning the mandatory annual re-registration.

Although homeowners are by no means required to submit plans to this group, they are encouraged to contact this learned group thus possibly helping their cause with the city.

Our 14th annual neighborhood picnic is going to be held on Sunday, August 26, at our local "Circle Park" in the middle of Bonnie Brae. We have seen a trend towards more families with young children and have seen increased attendance over the last couple of years. Happy summer!

**Cheesman Park** - Great People's Fair. Over 300,000 attended. It was fun and safe with great weather. The Cheesman Park Fourth of July Kid's Parade saw 150 kids participate. Fire trucks and mounted police were in attendance.

Congress Park Neighbors - There is concern with noise from outdoor patios along East Colfax. We are working

with the city on the problem of high crime around 13th and Colorado Boulevard condos. A non-resident owner has 4 units at this location. There have been about 60 arrests at this location in the last 18 months. The City Attorney's Office refuses to enforce nuisance abatement laws at this location due to the fact that most illegal activity takes place in the alley and hallways that are common areas. These units are inhabited by known gang members. The halls and alley are covered in gang graffiti. The owner has stated to the DPD that activity at this location is not her concern. The HOA is basically non-existant. We welcome any ideas that other community organizations may have based on similar experiences.

**Golden Triangle Museum District** - The GTMD neighborhood will have a new post office in August as a part of the new Judicial Center development. The GTMD and the other neighborhood.

**Greater Mar Lee** - We have been working with Ruby Hill, Godsman, and Athmar Park on the Xcel Energy/Ruby Hill view plane.

#### **Hampden South Neighborhood Association**

Staples Office Supply and Starbucks Coffee: Construction has been completed on both and the Office Supply and the Coffee house are ready for bushiness. Both businesses are very nice and possess pleasant architectural design and quality construction.

7180 East Hampden Ave. Rezoning: The Blockbuster store relocation to Tamarack Square location is in progress and close to completion. July 23 is the scheduled public hearing date. The HOA and the Council Women's office has no objection regarding the rezoning, demolition of the out-of-business India Cousin Restaurant and construction a new Walgreen store.

Southmore Vine and Spirit: The licence transfer is in progress. The new owner was contacted and is satisfied with the process.

Neighborhood Inspection: We have a new inspector: Eleanor Garcia. She is very cooperative and is interested in the problems or code violation details. She is welcome in our neighborhood.

Bridge Painting: The HOA will cooperate with the City to help repaint the two bridges on Tamarack. We are waiting for cooler temperatures to achieve quality work.

Comcast: The TV service provider, without prior announcement, removed pre-paid stations from the subscriptions and is transferring to their paid services. The reruns are numerous and the advertising is so extensive that we do

# **Denver Integration**

Conversation Points For "Denver Defines Integration"

#### 1) What is immigrant integration?

- Integration is an intentional two-way process of adaptation between arriving and receiving communities, which is non-linear as it develops along multiple pathways at varying speeds.
- Integration focuses on strengthening community assets rather than scrutinizing individual status.

#### 2) What are various pathways to integration?

Pathways to integration include language acquisition, education, economic mobility, family support, civic participation and citizenship, equal treatment and opportunity, health access, cultural and social interaction, community planning and advocacy, and neighborhood building.

#### 3) Why does integration matter in Denver?

- Integration matters because Colorado has become a preferred destination for immigrants and refugees. These newcomers, who come from countries around the world, represent the widest possible range of ethnic groups, religious beliefs, education levels, and employment histories. They bring change to communities and, at times, pose challenges for municipal leaders.
- Integration matters so that we can all live in a healthy community that creates a sense of belonging for everyone and that creates opportunities for all to improve their lives.

#### 4) What factors make Denver unique?

- Denver is unique because of its geographic size, its demographic and neighborhood diversity, and its centrality in legislative and public opinion debates concerning immigration.
- Denver is unique because no single organization can provide access to or has the trust from all of the voices that need to be at the table to develop a comprehensive integration plan.

#### 5) What is the Denver Integration Coalition?

The Denver Integration Coalition engages individuals and organizations from arriving and receiving communities in a planning process to define integration and develop a comprehensive integration plan for Denver that promotes a vision of belonging and opportunity for everyone.

#### 6) Who is involved in this initiative?

The initiating coalition is made up of stakeholders from the Denver community who represent virtually all of the pathways to integration and who understand that true integration cannot occur without the acceptance and support of the preexisting community. We understand that both established residents and newcomers have a deep interest in the community that can best be understood through open and mutual communication.

Participants include concerned citizens, the State of Colorado's Division of Refugee Services, the City and County of Denver government, Denver Health, Denver Public Schools, Denver Police Department, the Archdiocese of Denver, the Family Resource Center network, the Neighborhood Resource Center, various religious organizations, and several community based nonprofits.

#### 7) What will the Denver Integration Coalition accomplish?

Currently, we are in the planning phase of this effort. Our goal during this planning phase is to gather and synthesize as much input and information as we can from various individuals, communities, neighborhoods, and organizations to create a comprehensive plan for integration in Denver.

#### 8) What activities will you carry out?

We will conduct forums to elicit input from members of both the arriving and receiving communities as it relates to Denver's definition of integration and we will coordinate task forces focused on the different pathways to integration in order to synthesize this input. In addition, we will gather information from other community integration dialogues that are independent of our planning process.

#### 9) How will this work help your community? [What is in it for me as a community member?

This coalition's priority is to help Denver strengthen the relationships between and the engagement of our arriving and receiving communities to create a sense of ownership, belonging, and opportunity for everyone. Our work emphasizes that everyone has a voice in our community and that by working together our community will be strengthened.

#### 10) How will your coalition involve the community? Established community members? Immigrant families?

During this planning phase it is critical to invite and obtain input from many and diverse Denver residents. This coalition's participants are "gateway organizations" to diverse immigrant and mainstream populations and along the multiple pathways to integration. As a result, the coalition participants will utilize the breadth of their networks to extend an open invitation through a variety of media for participation to all members of the community. Community involvement can entail participating as a member of the coalition, attending and contributing at community forums, and/or working on one of the issue-oriented task forces that evolve from the forums. Opportunities for ongoing involvement will be suggested in the comprehensive integration plan developed by the community.

#### 11) Who is funding this work?

The work of this planning process to develop a com-

prehensive integration plan is funded by The Colorado Trust which is a private grant-making foundation dedicated to advancing the health and well-being of the people of Colorado. The foundation develops long-term initiatives that are responsive to the needs of communities. Each initiative addresses different aspects of The Trust's two goals – advancing accessible and affordable health care and providing resources to strengthen families.

• The Supporting Immigrant and Refugee Families Initiative provides funding to 19 Colorado communities in their efforts to support immigrants and "established" residents in working together for strong, healthy communities. While each of the communities develops its own plan to address the unique challenges and opportunities it faces in respect to an increasing immigrant population, all participating communities are dedicated to a "two-way street" process that encourages adaptations both on the part of immigrants and on the part of the receiving community where the immigrants now live.

#### 12) What is the timeline?

• The planning process for the Denver Integration Coalition began in January and is scheduled to deliver its comprehensive integration plan at the beginning of November. Community forums will take place in June and July and task forces focused on issues related to various pathways to integration will meet during August and September. The Coordinating Committee will draft the final comprehensive integration plan during October. The plan itself will be implemented over four years.

#### 13) What will be the result of your efforts?

 The result will be a comprehensive integration plan that establishes the goals and proposed activities that the community agrees are important for defining integration for Denver.

#### 14) How can I participate?

- We will be planning several types of forums and small focus groups throughout the months of our planning. The Denver community can look forward to several opportunities to participate in the input process and to let us know what they would like to see happen to achieve integration. Each person in Denver can be a part of this process and their opinions will help drive what is included in the comprehensive integration plan and which projects will ultimately be implemented.

# **Emergency Response**

The Mayor's Office of Emergency Management is now offering free Community Emergency Response Training (CERT) to educate the citizens about disaster preparedness for hazards that may impact our area and to train them in basic disaster response skills such as fire safety, light search and rescue, team organization, and disaster medical operations. Using the training learned in the classroom and during exercises, CERT participants can assist others following an emergency event when professional responders are not immediately available to help. CERT participants also are encouraged to support emergency response agencies by taking a more active role in emergency preparedness projects in our community.

During a disaster, the number and scope of incidents can overwhelm conventional emergency services. Citizens may initially be on their own for 72 hours or more. The CERT program is an all-risk, all-hazard training designed to help citizens protect themselves, their family, their neighbors, and their neighborhood in an emergency.

The ability of our community to recover from a devastating terrorist event or any natural disaster or emergency requires active planning, participation, and cooperation from all members of society. Each individual shares the responsibility for preparedness. By encouraging preparedness and hazard mitigation, CERT can help minimize the effects of a disaster and facilitate a faster recovery.

The long-term goal for the Denver CERT program is to train as many citizens and organizations as possible to be prepared for a local disaster. The CERT training courses are being scheduled for the summer and fall for citizens, businesses, faith-based organizations, schools, volunteer organizations, special interest groups, and neighborhoods,

Denver's next CERT course will be offered on September 11, 6 p.m. to 10 p.m., September 13, 6 p.m. to 10p.m., and September 15, 8 a.m. to 5 p.m., a total of 16 hours of training at Denver Police District 3, 1625 South University Boulevard. SAPs higher status with the City. Tyler Gibbs is Plan Implementation Manager.

ZAP members stressed the importance of citizen involvement, suggested development of criteria for identifying healthy neighborhoods and methods of engaging more citizens in city matters, asked that builders put an eaddress on their signs for informative websites, reminded that sidewalks are part of "Living Streets," asked that the Parking Plan focus on impact of increasing density in neighborhoods, mentioned the importance of open space, and asked how CPD ties into the Capital Budget to ensure CPD needs are implemented. Mr. Park said funding must come from other sources as well as the city budget and asked ZAP to thank City Council and the Mayor for their support of CPD. Several ZAP members expressed appreciation for CPD's improvements.

Molly Urbina and Kent Strapko of CPD and Kent Olson of ZAP reported briefly on the status of INC's 2005 "Report on Residential Zoning and Construction Issues: Recommendations for Improvement." Kent suggested and all agreed that a few members of the ZAP subcommittee that wrote this document should meet with Ms. Urbina and other CPD staff to go through the report and work out implementation alternatives, then report to ZAP.

Greg Mauro of Denver Community Corrections and Criminal Justice Consultant Cecilia Mascarenas discussed Non-Governmental Residential Facilities for treatment or supervision of offenders who are on probation or parole. Proposed is an amendment of the present ordinance that will allow more facilities to serve these people, many of whom are now sent to unsupervised locations or become homeless and on their own in Denver neighborhoods. The focus is on public safety.

District 7 Councilman Chris Nevitt spoke about recent meetings citizens have had with Xcel Energy, the City, and mediator Steve Charbonneau regarding the Ruby Hill View Plane and a proposal brought to City Council by Councilman Charlie Brown to allow Xcel Energy to violate the plane with large utility towers. A decision on this matter has been postponed at Council until September 10 so that meetings may continue and a solution reached. A number of ZAP members indicated they would be willing to pay more on their utility bills to save not only this view plane but all others in the city by funding the burial of such cables.

ZAP members were urged to read and think about Mayor Hickenlooper's inauguration speech that referred to "the common good" and stated that neighborhoods take views that are too narrow and self-interested. How would the Mayor engage more neighborhood residents? It was commented that his Greenprint task force included NO "common citizens" and, if we are to work for a common good, we need to sit at a common table. This topic will be discussed at future INC meetings. The next ZAP

meeting will be September 22. There will be no August ZAP meeting. --Diana Helper, ZAP member.


