### **Letter concerning Bond Issues**

The following quoted text was sent, in letter format signed by INC's Executive Committee of and Committee Chairs, to Mayor John Hickenlooper, Margaret Browne, Marilyn Miller, Members of City Council, and Amber Callender. Neighborhood groups are encouraged to consider sending similar communications.

"The undersigned executive committee members and committee chairs of Inter-Neighborhood Cooperation understand that the city is likely to propose one or more bond issues for the voters to consider in May of 2007.

We strongly encourage you all to discuss such a bond issue with citizens, including registered neighborhood organizations and, most importantly, to listen to comments from citizens before the list of projects is finalized. Citizens always respond more favorably to a bond issue if there has been meaningful citizen involvement.

Obviously, some items that should be discussed with the public are:

- What will the amount(s) of the bond issue(s) be?
- Should the city be borrowing money for items that are only maintenance?
- Will the projects be equitably distributed around the city?
- Will any transportation projects pay for sidewalk and bicycle facilities as well as road-
- Will citizens have any grass-roots role in the decision-making process to develop the list of projects, such as they did in the 1998 Neighborhood Bond Issue?

INC will be happy to be part of this discussion process. Thank you."

The July Minutes were approved and the Treasurer's report was accepted.

### The EC discussed INC's fund raising efforts:

- File for Life cards: Interest seems to be waning. Karen will submit a promotional blurb for the newsletter. David will forward the blurb to other organizations and Cathee will take some File for Life cards to East Montclair to sell.
- People's Fair: Funds have been distributed but INC has not received its check yet.
- Dictionary Drive: The fundraising kick-off is traditionally the INC Presidents' Dinner.
  - Macy's: Ken will send the information Steve put together to all INC members. All members are encouraged to forward it to their individual RNO members, colleagues, and etc.
  - Monique mentioned that next year INC/DD can apply for a grant from the Xcel Energy Foundation.

### **President's Report:**

- EC Meeting with the Mayor: Dave is encountering difficulty scheduling this meeting. Dave will try providing a couple of dates to see if we can't get on the Mayor's calendar. {Ed. Note: The meeting will be September 6<sup>th</sup>}
- Infrastructure Bond Issue: Michael presented INC's letter requesting public participation on what projects are included in the 2007 bond issue in a manner similar to Mayor Webb's process for the 1998 bond issue. A motion to approve the letter passed. The EC Meeting attendees signed the letter, it will be put in the September INC newsletter {ed. note: see text top of page one}, and Ken will send a message to the INC membership encouraging people to contact Diane Barrett, Project Manager, in the Mayor's Office at 720-865-8780.
- Program/House Committee: Dave would like to start a committee responsible for locating meeting places,

# Minutes of August 12th Delegates Meeting

Thanks to extra help on Thursday and Friday, the Dollar Dictionary book labeling was completed prior to the meeting.

The speaker from the D.A.'s Office who was to speak about exploitation of seniors did not attend.

Allison Billings, of Transportation Solutions, spoke of her concerns about the Strategic Transportation Plan (STP). Ms. Billings has been a member of the STP committee (that has been meeting for over a year), and she has attended every public meeting. The public input from these meetings has stressed the need for the STP to address pedestrian and bike connectivity and to make multimodal options attractive to current drivers. However Ms. Billings believes that the STP and the Public Works department are focused on moving cars. In addition, the city is looking at obtaining bonds in 2007 to "catch up" on projects that previous bond issues did not completely pay for. Ms. Billings presented a letter she asked INC to submit urging the city leaders to dedicate the necessary resources to achieve the goals of enhanced transit, bike, and pedestrian connectivity within Denver by dedicating funding to building and – importantly – maintaining these improved transit amenities. The need for ongoing public input as a part of this process was also emphasized. A motion to support the Transportation Solutions' position statement was passed with 23 in favor, 0 opposed, 6 ab-It was suggested that INC encourage the Mayor to immediately include neighborhood representatives in the Infrastructure Task Force's current prioritization efforts. There were concerns that that bonds raised for maintenance-only are short-sighted, that project fund estimates are "low-balled" resulting in some projects remaining incomplete or not started, and that residents are becoming reluctant to vote for such bonds. It was suggested that the city consider increasing debt to issue bonds that include realistic funding for both construction and ongoing maintenance. There was a question raised about why plans negotiated between neighborhood residents and the city aren't implemented as negotiated; e.g., the Cherry Creek Plan included a wetland park and bike trail as part of reconstruction of the Holly Street bridge but the park and bike trail were not built.

Roberta Simonton reported that there is a vacancy coming up on the Water Board Citizen Advisory Committee and encouraged INC to submit a representative. If you are interested in this very important committee role, please contact Dave Webster.

# Zoning and Planning Committee Report

The INC Zoning and Planning Committee met on August 19<sup>th</sup>. It was decided that the next meeting will be scheduled for September 16<sup>th</sup>. If your name is not on the mailing list for ZAP meetings and you would like to receive e-mail notices or if you are on the list and wish to have your name removed, please contact Gertie Grant at gertie-grant@estreet.com.

Councilwoman Kathleen MacKenzie was present at the August ZAP meeting to discuss bus stop advertising billboards ("kiosks") which are part of the Public Works Department Transit Amenities Ordinance, effective 2001. These billboard kiosks are to replace the advertising that was on the old bus benches. Each kiosk sale includes extra green benches to place at many bus stops but the City has neither enough staff nor resources to implement this part of the program. Thus it is hundreds of benches "behind" in placement. To encourage ridership, benches (and shelters) need to be available.

After considerable discussion and comment, the ZAP members voted to send a letter to Public Works and City Councilpersons stating that the public right-of-way is an important element of city design and citizens' sense of place; the installation of non-advertising benches should be accomplished now before more kiosks are sold; all residential blocks, parkways, and historic districts should be exempt from kiosks; notice of future kiosk placement should be sent to appropriate property owners and Registered Neighborhood Organizations (RNOs) with ample time for comment; American Disability Act (ADA) considerations must be addressed; and alternative sources of funding bus benches and shelters must be found. {Please see motion on page six for consideration at the September 9<sup>th</sup> INC Delegates meeting.}

City of Parks, The Preservation of Denver's Parks and Parkway System is a recent publication by Carolyn and Don Etter, former co-managers of Denver's Department of Parks and Recreation. Carolyn discussed this illustrated "brief history and selected bibliography" pointing out the importance of "quality of space" for Denver and its residents. She urged assertive protection and maintenance of our parks and open spaces, free from advertising, and encouraged neighbors to form coalitions to accomplish these goals. The book is published by the Denver Public Library Western History Collection. ZAP attendees received copies—upon the condition they read them.

The topic of zoning waivers and conditions was ad-(Continued on page 9)

### File of Life

An INC Dollar Dictionary Fundraiser that Your RNO could also use to Raise Funds. The File of Life card (see an illustration of portion of a card below) is a mini-medical his-



tory card that can be kept in the home or easily carried on the person in a wallet or purse. In a medical emergency, the card enables paramedics to obtain a quick medical history if the patient is unable to offer one and begin *immediate* treatment.

The cards are kept in a red plastic pockets labeled "FILE OF LIFE" and list the patient's name, emergency medical contacts, insurance information, health problems, medications, dosages, allergies, recent surgeries, doctor's name, and health care proxy. The front of the packet is clear vinyl. Each card is folded twice with the bottom two sections and back of each card containing all the medical data. There is a space for the person's Social Security Number although folks might consider leaving that space blank.

INC member RNOs can purchase these File of Life packets for \$1.00 each. All of the proceeds go towards the Dollar Dictionary drive. RNOs can sell the packets to their own membership for a price that allows the RNO to raise funds as well. Please contact any INC Board member to purchase this potentially lifesaving card.

### Recyclers' Corner

It's a new school year so it's time for kids and adults to put thinking caps on and learn how they can get an "A" in the environment. There are all types of ways you can reduce waste, save water, and lower your energy usage. Below are some easy "Green Tips" you use can



utilize at home, work, or school to help do your part to protect our environment.

#### RECYCLE and REDUCE WASTE

- Reuse empty plastic tubs for storing pencils, paper clips, or other small items.
- Recycle papers such as old homework and junk mail in your recycling container at home. Each ton of recycled paper can save 17 trees.
- Build a compost pile in your backyard and save kitchen food scraps to add to your compost pile.
- Pack your lunch in reusable containers instead of disposable plastic bags or plastic wrap.
- Avoid buying single serving food items such as juice boxes, individual chip bags, and cereal variety packs.
- Don't waste paper! Write on both sides. *The average American uses 650 pounds of paper per year*.
- Cereal boxes, paper egg cartons, and paper towel rolls can all be recycled.

#### **SAVE WATER**

- Turn off the water while bushing teeth or washing up. *This can save 3 to 7 gallons per minute.*
- Take shorter showers or fill up the bathtub only part way. And, in the winter, let the water cool before draining. *The average person uses 15 gallons a day in bathing.*

#### SAVE ENERGY

- Walk, bike, or ride public transportation whenever possible. At today's gas prices the average U.S. household will spend more than \$3,000 a year on gasoline.
- Turn off lights when leaving a room.
- Don't leave computers, televisions, or other electronic equipment on when you're not using them. When added up nation-wide, it's an enormous a waste of energy.

### **Motions Up for Vote**

The INC Zoning and Planning Committee has voted to submit the following motions for consideration by the September 9<sup>th</sup> Meeting of the Delegates:

**Motion 1.** Inter-Neighborhood Cooperation should communicate to the Mayor, City Council, and the Department of Environmental Health as follows – "Residents of many Denver neighborhoods are increasingly burdened with construction noise, some from remodeling of houses, some from single new house construction projects, and some from major commercial projects. Neighbors deserve more peace and quiet in residential neighborhoods. The city's construction noise ordinance should be amended to prohibit construction noise after 8 p.m. (as opposed to the current ordinance which is 9 p.m.) and to prohibit construction noise on Sundays (currently, construction noise is permitted seven days a week)."

Motion 2. INC should communicate to the Mayor, the Manager of Public Works, and City Council as follows – "INC supports the placement of bus benches and bus shelters throughout the city in order to encourage the use of transit and promote the comfort and safety of busriders. However, INC encourages the Department of Public Works to recognize that the design of items in the public right-of-way is a very important element in the sense of place and the quality of life in Denver and to incorporate the following into the criteria it uses in granting permits to private advertising contractors:

- Notification of proposed sites for advertising at bus benches (kiosks) should be given to adjoining property owners and to registered neighborhood organizations, with opportunity to comment. (Some neighborhood businesses have been damaged when the view of their businesses has been obscured by the advertising kiosks.)
- Installation of all of the bus benches (without advertising) contracted for by the contractors should be accomplished before more advertising kiosks are permitted.
- Advertising kiosks should not be permitted on city parkways, or in designated historic districts or in residential zone districts. Existing permits for advertising kiosks in such areas should not be renewed.
- More careful attention should be given to the placement of bus benches so that they are safe and easily usable by the disabled.
- Other avenues for funding the bus bench/bus shelter program should be explored, including a bond issue, allowing neighbors and neighborhood organizations to fund and maintain benches and shelters and joint ventures with the Regional Transportation District."

A dictionary and thesaurus of their own for every third-grade student in the Denver Public Schools. Dozens of volunteers joined us in August to unpack, count, and place gift labels sorted by school and neighborhood association and to repack boxes holding a total of 16,032



books. Hooray to our Volunteers!! This event included community and neighborhood volunteers both young, old, and in between; Denver Correctional inmates and their Sheriff Deputies; and a great crew of our younger neighbors doing their community service time donation. Without each and everyone the process would not have been so easy and enjoyable.

The best opportunity for thrills and satisfaction with this program is visiting the students and personally giving them their own books. All the books to each of the students at the 100 DPS elementary schools (new schools Howell and Waller have added to the school count) will be delivered by August 25<sup>th</sup>. Since this is the 11<sup>th</sup> year of the program, the principals and teachers will excitedly be awaiting this gift from the community for their students. Contact your neighborhood's school principal as soon as possible to set up a brief program. Cathee Fisher (303-333-3141) can provide you with more information.

We still have a way to go to reach our fund raising goal. Our costs have risen. For the past 6 years the thesaurus has only cost us \$0.85 each. This year we were able to find an appropriate thesaurus but the cost per book is now \$1.25 each. This program will provide these life long learning tools for each third-grade student for only \$2.70. The books include the U.S. Declaration of Independence and Constitution as well as many other learning tools such as the periodic table, multiplication table, the word supercalifragilistic expialidocious and more!!! Has anyone seen our state fossil Mr. and Ms. Stegosaurus?

Donations again this year have been received from individual donors and neighborhood associations. Some of those donors have faithfully contributed every year since 1996. **Golden Triangle** – Karen Cuthbertson and Mike Henry of INC attended our August Board meeting to make suggestions for our new, staff-less RNO situation. They were very helpful.

Greater Mar Lee – Zoning issues continue to be an issue. Houses with broken fences and unfinished structures that neighbors have complained about for years are not getting the attention of zoning or the building permit department. We also have a home in the neighborhood that has been abandoned and burned twice. Despite repeated complaints that this was additionally dangerous because it is adjacent to the playground at Sanderson Gulch, only after the matter was brought to Tom Kennedy's attention did the City erect a fence around the property. Another problem is that builders are not required to consider the integrity of the neighborhood. As a result, many trailerhome type buildings are being put in giving our community a trailer-court look thus decreasing property values.

**Highland** – The Highland bridge construction is well under way with scheduled completion in October. The bridge is a pedestrian structure that will connect Highland to the Platte River Valley at 16<sup>th</sup> and Central on the west and 16<sup>th</sup> and Platte on the east. For more information visit www.highlandbridgedenver.com.

**Inspiration Point** – The celebration of the opening of Camp Rollendet Open Space is August 24<sup>th</sup>, 4 to 6 p.m. at 52<sup>nd</sup> and Sheridan {See the August INC newsletter}.

University Park – The City has assigned 2 new planners to work on completing UP's Neighborhood Plan begun in October of 1999. UP input and updates are being included. A Historic Preservation Workshop is planned also. Documents for naming the new open space along Buchtel Boulevard "Prairie Park" have been sent to Parks and Recreation with a presentation set for November.

Virginia Vale – Virginia Vale is pleased to report that a 2-acre piece of vacant land that has long been a point of contention between Channel 6 and the surrounding neighborhood is under development. It will be a self-storage area – destination only traffic; it's a low-traffic solution for the neighborhood. We are watching the Holly Street bridge reconstruction -- something that desperately need to be accomplished.

dressed. It was announced that Peter Park, Manager of Community Planning and Development, is assembling a small working group to find a common framework to understand waivers and conditions. The Zoning Code Task Force (ZCTF) also is working to create new categories to preclude need for many waivers and conditions and to streamline the permit process.

The next topic for the ZCTF is to determine what it is that neighborhoods wish to preserve. All RNOs are urged to think about what is important to perpetuate in their areas and beyond. ZAP members mentioned patterns of architecture, ways to keep neighborhood character, and the importance for all neighborhoods to be mindful of the great assets afforded by trees, proper set-backs, tree lawns, and other open spaces.

#### Other items:

- An ordinance concerning review of demolition applications to identify historic properties is scheduled to come before City Council in six to eight weeks.
- The Mayor has ordered Kim Bailey, Manager of Parks and Recreation, to study implementation of his "Million Tree" initiative. A task force is being formed to consider this. It is hoped that concern for preserving trees and a realistic look at irrigation will be important components of this study.
- Copies of Draft Number 19 of the new Denver Sidewalk Policy were distributed by University Park Sidewalk Chair Mary Myers. This topic (as well as kiosks) is being addressed by the City Council Public Works Committee which is now chaired by Councilwoman Marcia Johnson. ZAP members were urged to read the policy carefully, note the proposed funding plans, provide neighborhood comment, and attend the hearing (the ZAP email list will be notified).
- Implementation of INC's November, 2005 Improvements for Residential Construction document was discussed at a meeting of ZAP representatives with Councilwoman Jeanne Robb, Chair of City Council's Blueprint Denver Committee.


