### MIDCOUNTY CORRIDOR STUDY

Midcounty Corridor Study (MCS) Public Workshop Wednesday, December 12, 2007 7:00-9:00 p.m. at Seneca Valley High School.

Format: Stations set up with mapping and display staffed by County/other agency representatives. Citizens are encouraged to view the information at their own pace and provide comments (verbally or written). No formal presentation will be given. Public input will be used by the Study Team in the selection of alternates that will be carried forward into the next stage of detailed study.

This is a chance for nearby residents (us) to contribute ideas for further analysis. This would include: revisions to the alignments and engineering details to better serve the project Purpose and Need and to avoid or minimize direct impacts (physical and noise impacts) to natural and socioeconomic resources, including wetlands and streams, historic resources, community facilities, and neighborhoods.

Please consider attending this workshop and letting the Study Team know your concerns and opinions.

### SAFETY MESSAGE

The following has been going around the Internet for some time now, and it is worth considering for all of you who have cell phones.

ICE Campaign - "In Case of Emergency"

We all carry our mobile phones with names and numbers stored in its memory but noone, other than ourselves, knows which of these numbers belong to our closest family or friends. If we were to be involved in an accident or were taken ill, the people attending us would have our mobile phone but wouldn't know whom to call. Yes, there are hundreds of numbers stored but which one is the contact person in case of an emergency? Hence the ICE (In Case of Emergency) campaign. The concept of ICE is catching on quickly. It is a method of contact during emergency situations. As cell phones are carried by the majority of the population, all you need to do is store the number of a contact person or persons who should be contacted during emergency under the name ICE (In Case Of Emergency).

The idea was thought up by a paramedic who found that when he went to the scenes of accidents, there were always mobile phones with patients but they didn't know which number to call. He therefore thought that it would be a good idea if there was a nationally recognized name for this purpose. In an emergency situation, Emergency Service personnel and hospital Staff would be able to quickly contact the right person by simply dialing the number you have stored as ICE. For more than one contact name simply enter ICE1, ICE2, and ICE3, etc. A great idea that will make a difference! Let's spread the concept of ICE by storing an ICE number in our mobile phones today!

Please make sure that you and your loved ones have this information. It really could save your life or put a loved one's mind at rest. ICE will speak for you when you are not able to.

Please remember that **Montgomery County law** requires pet owners to clean up the mess left by their pets. You can be fined \$100 if someone files a complaint.


Montgomery County Code, Sec. 5-203 (a)(2): An owner must not allow an animal to damage or defecate on property outside of the owner's property. An animal may defecate on public property or the common area of property in which the owner shares an interest if the owner immediately removes and disposes of the feces by a sanitary method approved by the Director.


