The final membership count for 2007 is 234 members. The 2008 membership season is now open. Renewal letters will be mailed the second week of January. The application is 2 pages for individuals. Please complete both sides. Your record is built from this application so please do not refer to older applications.

The membership count for 2008 is 46 each. We welcome new members Gaylene Barber and Verla Barber of Miller, and Leslie Hall. Norman. We carried over 41 commercial records that do not expire until May 17. Congratulations to our Diamond members, Pauline Hawkins and Lee Nichols.

All of the Membership 2007 goals established by the Committee were completed. Instead of exceeding the 2006 count by 10%, it was increased by 73%. The Centennial Membership Directories has been delivered or mailed. All records have been established. Past policies and procedures in Standing Rules were reviewed. A report is made for each Miller Messenger publication. Contacts are made with known non-members.

The 2008 Membership Goal is 263 members. We encourage everyone to help us by joining or renewing. The Membership Committee will sponsor a celebration in early May with the theme "Cinco de Mayo". Not only will this be a fun time but interpreters will be available to those who might have questions concerning the purchase of memberships.

The Membership Committee will chair a new MNA Event - a 4th of July Parade. Details will be available in the spring. # Tips to prepare your property during winter storms

- To keep pipes from freezing, wrap them in insulation or layers of old newspapers. Cover the newspapers with plastic to keep out moisture.
- Let faucets slowly drip to avoid freezing.
- Know how to shut off water valves.
- Install and check smoke and carbon monoxide alarms.


## Prepare a winter storm disaster supply kit

- A cell phone with an extra battery or twoway radio.
- Windshield scraper and small broom for ice and snow removal.
- Several blankets or sleeping bags.
- Rain gear and extra set of dry clothing.
- Non-perishable snacks like canned fruit, nuts and other high energy foods. Include non-electric can opener if necessary.
- Jumper cables.
- First aid kit.
- Flashlight with extra batteries.

# **Tree Trimming Do's and Don'ts:**

#### DO:

- Consult the services of a professional arborist, even for maintenance pruning;
- Get several estimates from reputable tree service companies (listed in the phone book under "Tree Service");
- Check each arborist's credentials, including insurance and licensure. Reputable companies will also be bonded (insured) to protect you and your home from potential damage;
- Get referrals from the arborist. Other customers' opinions may help you determine which arborist is right for you;
- Check with your homeowner's insurance.
   Some insurance companies will pay for tree removal and/or replacement if it is deemed the tree contributes to the overall value of the home or property;



#### DON'T:

- Go near or try to trim a tree that is near an exposed electric line;
- Try to take down a damaged tree that is still standing or try to prune high branches using a chainsaw hire a professional for these services:
- Fall for "door-to-door" offers for treetrimming services;
- Pay for trimming services up front. Certified arborists and reputable tree companies will not ask for payment up front, only after services have been completed.
