#### **Approval of Minutes of Previous Meeting**

Bob Horn stated that some the amendments that he requested were not included in the final draft.

A motion was made by and seconded by Brain Snyder and seconded by Bret Watt that the minutes of the meetings be approved, as written. The motion carried with Bob Horn voting in opposition.

#### **Homeowner Comments**

Dario Ceragioli stated he had received a message from a

homeowner regarding a problem with homeowners allowing their pets to use homeowners yards. Jerry Wallace stated that this is a neighbor issue and not an homeowners association issue. A discussion followed regarding the installation of dog waste containers. Brian Snyder volunteered to get some information regarding this and bring it to the next board meeting.

Bret Watt stated that he had several issues that he would like to discuss, at some point. These issues included inconsistency in the delivery of the monthly newsletters. Other issues involved some of the same issues that had been previously discussed regarding the amenity area. The other issue was the amount of traffic on Willoughby Station Blvd. Jerry Wallace suggested that the City of Mt. Juliet would be the first place to check on this.

#### Committee Reports

**Block Captains** 

Delivery of Newsletters

Bob Freeman stated that newsletters for one area which did not have a block captain were delivered to him, which he delivered. Bob stated that Melissa Taylor would need to find a replacement who could deliver the newsletters to those homeowners.

Bob Horn stated that he did not volunteer to be in charge of the newsletters. Bob stated that he hadn't received all the information that he needed to determine which block captains that he was deliver newsletters to.

Jim Atkeison discussed the e-message that he had received from a representative from the Mt. Juliet post office regarding the placement of newsletters in mailboxes, which is in violation of postal regulations. It was agreed a copy of the message will be delivered to each block captain next month.

Covenants & By-Laws

Bret Watt stated that he has started reviewing the covenants and by-laws for the community.

Cemetery, amenity area and amenity area rules

Dario Ceragioli stated that he has put one application of weed killer on the weeds in the cemetery area.

Bob Horn asked if a local historical society had been contacted to perhaps establish the area as a historical area. Dario reviewed some of the background of contacts that had been made regarding care of the cemetery.

#### Landscape

Bob Freeman reported that Beazer Homes had removed the stone walls at the corner of Sydney Terrace and Willoughby Station Blvd. Bob also stated that a large tree located close to the main entrance had been removed by West Wilson Utility and that a section of the fencing close to the front entrance around a fire hydrant had been added. Bob stated that Brockman's Landscaping was working to complete the bushogging of an area behind homes located on Cairns Dr. W.

#### Neighborhood Watch

Brian Snyder stated that he had spoken with Jason Brockman who is the officer in charge of neighborhood watch programs. Brian stated that the first step in the establishment of the program would be to identify ten districts for the community and ten homeowners who would be willing to serve as the contact person for those districts. Brian will write an article for the next newsletter regarding this.

#### Newsletter

Bob Horn stated that his telephone number was listed incorrectly in the last newsletter. Bret Watt stated that his last name was listed incorrectly in the newsletter.

#### Pool

Joe Valencic stated that most of the work that was needed for preparation of the pools for the season opening had been completed. Joe stated that the new chlorinators remained to be installed. Joe stated that he had replaced one faucet which was broken in the men's restroom. Joe made a motion that the remaining faucets in both

bathrooms be replaced. Joe stated that the cost of the faucets would be approximately \$ 90.00. The motion was seconded by Dario Ceragioli. The motion carried.

Bob Freeman stated that the hours for the pool attendants this year would be 8:00 A.M. to 4:00 P.M. for one attendant and from 11:00 A.M. to 7:00 P.M. for the other attendant.

Joe Valencic asked Jerry Wallace to include in his President's column to remind homeowners that the fountain area should not be used as wading pools. Jerry stated that he would do so.

Bob Freeman asked Jerry to also include a reminder that a shower should be taken by children who may have played in the drainage area next to the pool prior to entering the pools in order to help prevent algae from the drainage area being introduced into the pools. Bob stated that floats and other items that may have been used at a lake should also be washed prior to being used at the pools.

Bob Horn stated that there seemed to be some inconsistency in the hours posted for use of the various amenity areas. Bob Freeman explained the reason for the differences.

Bob Horn stated that if the decision is made to pursue the use of identification bracelets next year that it may be a good idea to try a test of their use next year at the Spring Fling event, prior to the opening of the pools.

#### Social

Brian Snyder stated that the social committee was planning a Summer event for either the first or second Saturday after school starts again. Brian stated that he needed to make a correction to state that each member of the social committee, devoted approximately thirty hours to preparation for the Spring Fling event. Brian stated that most of the balloons that he had for homeowners to use for the upcoming community garage sale had been picked up.

#### Welcome

Dario Ceragioli stated that welcome packages had been delivered to all the new homeowners that had moved into the community last month.

#### **Financial Report**

Bob Freeman reviewed the financial report for the period ending April 30, 2008. Bob explained the variations in some of the line items between the budgeted amount and actual expenditures. A motion was made by Joe Valencic and seconded by Dario Ceragioli that the report be approved, as presented. The motion carried.

Bob stated that Jim Atkeison had prepared an analysis of the various costs for the annual association meeting. Bob stated that total cost was approximately \$ 2,500.00 and approximately one third of the cost was for the attorney for the community attending the meeting.

#### Unfinished Business

Amenity Area Rules

After some discussion, it was agreed that further discussion of the rules would be tabled until the September meeting of the board.

Frequently Asked Questions

It was agreed that no additional changes needed to made, at this time, to the document and that they should be posted to the community web site. A copy will also be given to new homeowners.

#### **Architectural Change Requests**

Jerry Wallace reviewed the requests which he had reviewed since the last meeting of the board. A motion was made by Bob Freeman and seconded by Bret Watt that the requests be approved. The motion carried. Brett will begin reviewing any new requests.

#### **New Business**

#### Community Clubhouse

Jerry Wallace stated that several of the surveys which had been returned after the Spring Fling indicated that some homeowners were interested in pursuing information regarding the construction of a community clubhouse.

After some discussion, it was decided that a survey will be developed to determine homeowners interest in this. The survey will be included in the next newsletter and posted on the community web site. Bryan Snyder and Bob Horn agreed to collect the data and provide a summary. Bryan and Jerry will work to develop an e-mail distribution list of homeowners in the community so the survey could also be e-mailed to homeowners.

Security Cards For Entrance to Pool and Tennis Courts

Bob Freeman stated that he and Jim Atkeison had discussed the use of security cards instead of a key for entrance to the areas, which would eliminate the need for issuing new keys to homeowners each year. A motion was made by Bret Watt and seconded by Bob Horn for Bob and Jim to pursue this. The motion carried.

Web Based Surveillance of Amenity Area

Bret Watt stated that he felt that a surveillance system for the amenity area would help identify individuals who may be misusing the areas and hold them accountable. A motion was made by Brian Snyder and seconded by Dario Ceragioli for Bret to pursue getting information regarding this. The motion carried.

Discount From Providence Businesses for Willoughby Station Homeowners

Bret Watt suggested that some of the businesses in Providence Marketplace be contacted to determine if they would be willing to give a discount to Willoughby Station homeowners. After some discussion, it was decided that would be discussed at a later date.

Friday & Saturday Night Movie Night at the Amenity Area

Brian Snyder stated that an outdoor movie night at the amenity area might be of interest to homeowners during the Summer months. Brian will get some information regarding this and bring it to the next board meeting.

Community Newsletter on Community Web Site

Jerry Wallace stated that there had been discussion in previous board meetings regarding the advantages of posting the community newsletter on the community web site versus delivering a copy to each homeowner. After some discussion, a motion was made by Jerry Wallace and seconded by Joe Valencic that beginning July 1, the newsletter would be posted on the web site and a limited number of copies will be available at the pool area. The motion carried. Brian and Jerry will also work on being able to e-mail a copy to homeowners who have an e-mail address.

#### **Next Meeting**

The next meeting of the board was scheduled for June 19, 2008.

#### Adjournment

There being no further business to come before the board, a motion was made by Dario Ceragioli and seconded by Joe Valencic that the meeting be adjourned. The motion carried and the meeting was adjourned at 9:20 P.M.

# Neighborhood Watch Program forming for Willoughby Station

The Willoughby station HOA board is developing it's neighborhood watch program. This program creates a path to spread word of neighborhood events and develops a plan for reporting events in our neighborhood. The first step in forming an effective watch program is to develop an initial volunteer base. We need approximately 10 initial volunteers to form the first tier of the program. He entire program will need many more volunteers, and we are open for additional volunteers as well. The basic plan works this way: When you see a strange event going on, you call your area captain. The captain calls their next level and that leader contacts a pre-designated officer of the Mt. Juliet Police Department. We will be developing the plan further, but that is basically how it will work. We need 10 initial volunteers to form a tier of the chain.
