<u>Homeowner's Responsibilities –</u> <u>Following the Covenants</u>

It has come to my attention there are several violations to the homeowner's covenants I would like to bring to your attention. Remember, when you signed your contract to purchase a home in Willoughby Station, you agreed to adhere to the covenants and by-laws of Willoughby Station. Please follow these covenants and help keep our neighborhood looking clean:

- 3.12 <u>Use of Temporary Structures:</u> No structure of a temporary character, mobile home, camper, trailer, basement, tent, shack, garage, barn or other outbuilding shall be erected, moved onto any Lot and/or used at any time as a residence, not shall any residence of a temporary charter be permitted.
- 3.13 <u>Storage of Automobiles, Boats, Trailers, and Other Vehicles:</u> No trailers, boat trailers, travel trailers, inoperative automobiles or campers shall be semi-permanently or permanently parked or stored in the public street right-of-way or forward of the front

building line. Storage of such items and vehicles must be screened from public view, either within the garage or behind a fence which screens such vehicle from public view, unless otherwise approved in writing by the Developer in accordance with paragraph 3.2 above. No tractor-trailers, buses, or other large commercial vehicles shall be parked on driveways or in streets within the Properties for periods of time exceeding twelve (12) hours or for more than twenty-four (24) hours in any calendar week.

What has been brought to my attention I believe is a temporary building in a back-yard. As well as boats in driveways. I ask that you have these issues addressed. The Association Management will receive the addresses of the homeowner(s) who are in violation of this covenant.

Approval of Minutes of Previous Meeting

A motion was made by Joe Valencic that the minutes of the previous meeting be approved as written and Dario Ceragioli 2nd the motion. The motion carried.

Homeowners Comments

Lorine Ruotolo expressed her concerns that residents and non-residents causing problems in the amenity areas. She suggested that they be sent notification of possible loss of the privilege to use the amenities or prosecution.

Darinda Lening informed the board of a recent incident that occurred in the parking lot and basketball court area. Brian Snyder stated there was concern enough that the Mt. Juliet Police Department had been contacted.

Terry Lening stated as a runner as well as others who walk and jog are concerned about the offensive language that is coming from the basket-ball courts.

Chris Sorey stated he wasn't in favor of removing the basketball goals. He suggested that the lights to the basketball courts be shut off and cameras be installed.

Page 3 Willoughby Station News

Will Sellers reported to the group news from the City Commission. He stated that with the state getting involved with funding for the Music City Star there is a possibility that they may help with funding for the proposed Quiet Zone. The removal of the "no parking" city law will not happen as was reported last month. They are now looking at keeping the current 1-5 AM restriction and allowing residents to request addition of no parking time on certain streets. Hickory Hills association is involved against their developer to get rezoning for the area south of their entrance off Lebanon Road to allow restaurants and light retail.

Chief Andy Garrett & Lt. James Hambrick addressed the concerns expressed by the homeowners present and answered their questions. Mt. Juliet Police Department is in the process of revamping their webpage to permit individuals to report incidents without having to leave your name. Please call 754-2550 and press 0 for the dispatch to report any incident. Every call will be addressed as a patrol car becomes available. These are some things that you need to remember in reporting an incident is the time it happened, date and detailed descriptions. Chief Garrett reported that Mt. Juliet Police Department had received only 5 calls in May and 5 calls in June concerning Willoughby Station amenity area. Both Chief Garrett and Lt. Hambrick stated they wanted to hear from residents in Willoughby Station when they have concerns and to let them know if you are having any trouble getting patrol cars out.

Committee Reports

Block Captains: Nothing to report

Covenants & By-Laws:

Brett Watt stated there was one violation in the neighborhood and it was being addressed.

Cemetery, Amenity Areas and Amenity Area Rules:

Dario Ceragioli reported that a direct descendant of the Williamson family who are buried in the cemetery in Willoughby had contacted him. The family member expressed concern of the condition of the cemetery. Dario told him about how the association doe not own the cemetery, just the land around it. Mr. Williamson also provided a very interesting story about one family member buried in the cemetery being a decorated officer and a close friend of President Andrew Jackson. The board will be pursuing permission from the family to publish the history and family information in the next newsletter.

Brian Snyder stated there have been some concerns expressed tonight about activities in the amenity areas and that he would discuss those in new business section.

Landscape

Bob Freeman stated that he felt that the new ground company continues to do a good job of maintaining the grounds. He expressed concern about a retaining wall that was leaning. Jim Atkeison is to get bids for repair of this wall.

Neighborhood Watch

Brian Snyder stated nothing to report this month. Officer Brockman

with Mt. Juliet Police Department who heads up the Neighborhood Watch Program was currently enrolled in classes to revise the current program. Brian stated he was still looking for volunteers to help with the program.

Newsletter

July's newsletter was placed on the website for the 1st time in Willoughby Station's history and seemed to have gone smoothly as no one had received any complaints. Joe Valencic had placed a few hard copies of the newsletter by the pool and monitored it daily.

Pool

Joe Valencic reported that the lower pool had to be closed for a few hours due to a pump failure. The Health Department inspected the pools and is requiring No Smoking signs to be posted in "closed" areas by the pool; both restrooms, pump room and the upper pool building.

A couple of steps on the pool ladders need to be repaired and we also need to purchase 2 new umbrella bases.

Pool Party

Tina McMahel stated a neighborhood pool party is planned for August 16, 2008 between 3:00 p.m. - 7:00 p.m. The social committee requested \$1,400.00 to fund the function. Brian Snyder made a motion to give the committee \$1,400.00 and Bret Watt 2nd the motion. The motion carried with only Bob Freeman voting against it. A water slide with an attendant, dunking machine, and other activities are planned. Hamburgers and hot dogs will be sold to benefit the Willoughby Waves and Italian Ice will be sold to benefit Care-Is.

Modified the security schedule will be used in the amenity area to use off-duty Mt. Juliet police officers on random evenings.


