

We have two initiatives that we need to have passed by the HLHA membership. One initiative helps to unify the neighborhood and protect our homes while the other initiative helps to expedite the procedure for advancing our association.

Neighborhood Watch

We need your signature in order to allow our neighborhood to be recognized by the Neighborhood Watch Program of Hillsborough County.

Your signature will acknowledge and endorse the need for our neighborhood to unify and protect our homes from any criminal element.

We hope you will answer your door and take the time to sign the petition. Volunteer neighbors will be visiting your homes in October. They will be wearing red shirts.

HLHA Amendment for 51% Majority

The Board has identified a bureaucratic barrier which prevents us from effectively improving our association.

Most of the Association's Articles, Bylaws and Covenants are the original documents that were transferred from the developer to the first Association board in 1986. One of the Articles states that no amendment may be approved without a 90% majority.

The Article makes it nearly impossible for the Association to improve our conditions and the neighborhood.

We ask that you answer your door to sign a petition to lower the majority vote to the realistic and reasonable 51% majority.

Your Board members will be knocking on your door to explain the change and ask for your support. We hope to see you soon.

Please take note of the main article on the front page of this newsletter. It is imperative that we get these two initiatives passed. We need your support to accomplish the task.

The Neighborhood Watch Program initiative is an obvious bonus that we should all support without a second President

thought. With a Neighborhood Watch Program we will benefit from added support by the Hillsborough County Sherriff's Department as well as the Neighborhood Watch Program of Hillsborough County. I hope you will answer your door to the volunteers (in red shirts) and sign the petition.

The 51% amendment is an important initiative. The initiative will enable all of us to make important decisions to our association without the deeply cumbersome task of getting 90% approval. Without this important change to the way we conduct our association, we will continue to need 72 out of 79 homes to approve any amendments to our documents. This 90% majority article puts a chokehold on our ability to make any progress or improvements to our neighborhood association.

Your Board members will be canvassing the neighborhood to get everyone's signature to approve this amendment. We hope you will answer your door and approve the amendment change to 51%.

I hope to see all of you at the meeting on Monday, October 6, at the Northdale Recreation Center at 5PM.

We will meet the principal builders/developers of the Reserve at Hampton Lakes and learn about their plans and schedule for the upcoming months.

The meeting is not meant to be a forum for complaints and finger pointing. Please come to the meeting with any questions, but please keep an open mind; these folks want to make the project run as smoothly as possible with the least amount of disturbance to our neighborhood.

Trash Violations

Several neighbors have complained that others have been putting trash out several days in advance of trash pickup days.

Exposed trash encourages pest and dog "curiosity" and it's unsightly to look at for more than a day—especially if we have rainy days.

Please remember: It is a violation of the deed restrictions to place garbage, and yard debris at curbside before 6PM the night before trash days.



Water Restrictions

Hillsborough County watering restrictions have been extended through February of 2009. Please be sure to check your sprinkler systems.

Only one exception applies to our neighborhood. If you have new sod or other landscaping, the county allows for daily watering for up to 30 days.
