**Homeowner’s Responsibilities – Following the Covenants**

3.19 – Maintenance – All Lots, together with the exterior of all improvements located thereon, shall be maintained in a neat and attractive condition by their respective Owners or Occupants. Such maintenance shall include, but not be limited to, painting, repairing, replacing, and caring for roofs, gutters, downspouts, building surfaces, patios, walk-

ways, driveways, and other exterior improvements. The Owner or Occupant of each Lot shall at all times keep all weeds and grass thereon cut in a sanitary, healthful, and attractive manner and all trees and shrubbery pruned and cut.

.....  
.....In the event of default on the part of the Owner or Occupant of any Lot in observing the above requirements or any of them, such default continuing after ten (10) days written notice thereof, the Association may, subject to approval of its Board of Directors, enter upon said Lot, repair, maintain and restore the same, cut or prune or cause to be cut or pruned, such weeds, grass, trees and shrubbery and remove or cause to be removed, such garbage, trash and rubbish or do any other thing necessary to secure compliance with these restrictions and to place said Lot in a neat, attractive healthful and sanitary condition. In so doing, the Association shall not be subject to any liability for trespass or otherwise. All costs incurred in any such repair, maintenance, restoration, cutting, pruning, or removal shall be charged against the Owner of such Lot as the personal obligation of such Owner and as a lien upon the Lot, enforceable and collectible in the same manner and to the same extent as a maintenance assessment.

Call to Order

### Approval of Minutes of Previous Meeting

A motion was made by Dario Ceragioli and seconded by Bob Freeman that the minutes of the previous meeting be approved, as written. The motion carried.

### New MJPD Neighborhood Watch Liaison Discussion

Jason Brockman introduced Officer Tyler Chandler who is now the liaison for neighborhood watch programs in communities in Mt. Juliet. Jason stated Willoughby Station has been the model program in Mt. Juliet. Jason stated that the web site [www.nwii.org](http://www.nwii.org) is a good resource for neighborhood watch information. Officer Chandler stated that the Del Webb community in Providence had recently set up a good neighborhood watch program.

Jason explained that some watch programs use a "block captain" to communicate with 10 to 20 homes for safety items, neighbor vacations, etc. Bob Freeman explained that we have existing block captains that may be interested in participating in a neighborhood watch program. Homeowners in a block captain's area could notify the block captain if they were going to be out of town or if someone would be staying at

their home in the absence.

Officer Chandler stated that classes regarding personal safety and home invasion could be offered to residents.

**New MJPD Neighborhood Watch Liaison Discussion**

Officer Chandler asked if the homeowners in the community who have an e-mail address would be interested in receiving e-mail alerts from the police department when there was a safety or security issue in Mt. Juliet. It was agreed that the majority of the homeowners would be interested in this. Officer Chandler stated that he would let the board when this service was available.

Officer Chandler stated that the action line section of the City of Mt. Juliet web site can be used to report safety and security concerns to the police department as well as requests for various city services.

**Homeowner Comments**

Will Sellers stated that previous board of directors for the community had dealt with the issue of political signs in homeowner yards. Will stated that the board had been advised that First Amendment rights may be involved, therefore the board had chosen not to attempt to require homeowners to remove the signs. Will gave an update on various city projects.

**Committee Reports**

**Landscape**

Bob Freeman stated that Beazer Homes had completed some grading work in a common area behind some homes at the top of Sydney Terrace and that he had asked Brockman's Landscaping for a bid on any additional work needed so that the area could be mowed with the other common areas in that section rather than be hand-cut. Bob stated that he had just received Brockman's Landscaping proposal for next year. Bob stated that he and Jim Atkeison had been pleased with their services over the past year and would like to continue working with them. It was the consensus of the board that it would not be necessary to place the work out for additional bids again next year as long as the Brockman bid was reasonable. Bob stated that he would review the Brockman proposal and forward a copy of the proposal to the board for discussion at next month's meeting.

**Pool**

Bob Freeman stated that he, Joe Valencic, Ricky Biggs and Jim Atkeison had met to look over what work may need to be done to the pools. Bob stated that Jim had contacted Kevin Adams with Adams Pool Company who stated that the work could be scheduled for next week. Bob stated that he had received a proposal from Ricky Biggs for next year. Bob stated that it provided for a small increase due to chemical prices. Bob stated that he would recommend continuing with Pro-care for another year. It was the consensus of the board that it would

not be necessary to solicit bids for the work from other companies.

**Social**

Bob Freeman stated that the money raised by the social committee at the Summer Fest for Charis had been given to them by Nancy Valencic who does volunteer work there. Bob stated that a letter had been received from the charity thanking the association for the donation.

Jerry Wallace stated that he thought the date for the Fall Festival had been changed to November 1.

**Financial Report**

Bob Freeman reviewed the financial report for the period ending September 30. A motion was made by Dario Ceragioli and seconded by Bob Horn that the report be approved, as presented. The motion carried.

**2009 Budget Draft**

Bob Freeman reviewed the draft of a budget for the community next year and noted items of expected increased or decreased spending and why. Bob will prepare a final draft to be reviewed and approved by the board at the next meeting.

**Unfinished Business**

**Web Cameras for Amenity Area**

Jerry Wallace stated that he was still working on getting an estimate for the labor to install the equipment.

**Tennis Court Drainage Bid**

Jim Atkeison stated that per the discussion at last month's board meeting, he had obtained a bid from Tennis Court Construction Company for the installation of a French drain to drain water from the right side court to the edge of the court closest to the playground. Bob Freeman stated that it did not appear that water could drain out of the drainage pipe on that side of the court due to the slope of the ground in that area. He suggested that the water be drained to the back of the court. Jim with contact the company to discuss this and forward a revised proposal to the board.

**Street Lighting**

Bob Freeman stated that he had spoken with the majority of the homeowners at the intersections of the streets at the three corners of the amenity area. Bob stated that the homeowners that he had spoken with were in favor of the installation of the street lights. Bob stated one of

the homeowners had already installed a security light. After some discussion, a motion was made by Bob Freeman and seconded by Bob Horn that lights be installed at the 2 intersections where there are no lights and that the association assume the monthly expense for the light which had already been installed and was being paid a homeowner. The motion carried. Bob will contact MTEMC to determine their recommendation as to whether a 150 watt light or a 250 watt light should be used. In addition, the motion included the installation of a 250 watt light at the entrance of South Greenhills Road.

**Architectural Change Requests**

Joan Atkeison reviewed the requests which had been received and approved since last month's board meeting.

**New Business**

Political Signs

It was the consensus of the board that no action regarding this would be taken at this time.

Portable Basketball Goals

Jerry Wallace stated that he would like to table discussion of this until all of the board members could be present.

**.Next Meeting**

The next meeting of the board was scheduled for November 20.

**Adjournment**

There being no further business to come before the board, a motion was made by Bob Horn and seconded by Dario Ceragioli that the meeting be adjourned. The motion carried and the meeting was adjourned at 9:20 P.M.
