
Forced Mowing What is it?

We have an issue in our community with the number of lawns not being maintained. According to Article X, Section 17, of the DCCRs the Association can go in and maintain a vard if the correction is not done within a 10-day period after notification. If a resident who has received a lawn maintenance violation does not correct the problem within a 10 day period the HOA will have the lawn maintenance performed and invoice the homeowner for the cost. This will begin October 1st, PLEASE maintain your lawn including weeds!!

Neighborly Reminders!!

There are several VERY important reminders for ALL of our residents for the SAFETY of OUR children and each other as well as for maintaining the integrity and views of our community.





- 2. There is a City of Schertz ordinance requiring ALL pets to be on a leash or fenced in. They can not be left to roam the neighborhood at will. Animal control may be called and your family pet could end up in a shelter! Worse yet there may be dangerous items they can get into such as anti-freeze, rodent poison, fertilizers or other material.
- 3. The elections will be upon us shortly. <u>IT IS IMPORTANT THAT ALL RESIDENTS VOTE</u>. Reminder you are a citizen of the City of Schertz, as well as either Comal or Guadalupe counties which may require you to vote in two locations. Please check the City, County or State web sites to determine exactly where and when you can vote. Each of these web sites are accessible from our web site at home.satx.rr.com/fairwaysscenic.
- 4. With the elections nearing it is important that everyone understand and adhere to the sign restrictions in our community. Only signs permitted in your yard are (1) For Sale or For Rent/Lease, or (2) ONE political sign per candidate or issue. Political signs can only be up 90 days before and 10 days after election. NO sign can be larger than six (6) square feet.
- 5. The speed limit for <u>ALL</u> of our streets is 20 MPH. For the safety of our children, and all of us, please obey the speed limit. We have been in communication with the City regarding the speeding problems on Columbia and Pebble Beach. We may request speed humps on Columbia in the future. A survey would be done by the City and if the traffic flow is 500 cars per day then speed humps can be considered. The City Police Department will be watching for speeders and violation of other ordinances regarding traffic safety.
- 6. Architectural Control Committee (ACC) operates as an independent arm of the HOA. It is a requirement of the DCCRs that ALL exterior improvements to your home be approved by the ACC <u>PRIOR</u> to any improvements being made. If you have made improvements and they have not been approved by the ACC, you may be at risk of being requested to remove those improvements. PLEASE notify the ACC of ALL exterior improvements, PAST or FUTURE, via the Spectrum web site. The majority of requests are approved quickly, so be in compliance and file!
- 7. Please keep your lawn neatly trimmed, including any weeds in the strip between the sidewalk and street. If you do not keep up with lawn care you WILL receive a violation notice from Spectrum. If the problem is not solved, within the stated time frame, an outside service may be used to solve the problem and you will be billed for the service, as provided for in the DCCRs. If legal action is required you will be responsible for all legal costs. This is the "forced mowing policy" which will begin on October 1, 2008.
- 8. Do not place trash out in front of your home <u>sooner than 24 hours before trash pickup</u> (Wednesday AM) and please remove your trash can and recycle bin as soon as possible on Wednesday. Trash cans when stored should not be visible from the street. Storage of items (trash, basketball hoops, etc) at the front of a home is not permitted. They must be at least 5 feet from the front of the house and on the side of the house, in the back of the house, or in the garage.
- 9. Per the HOA DCCRs there is no parking of boats, travel trailers, utility trailers, or any unauthorized vehicle in drive-ways or yards for any length of time. You can park them in the street, attached to their towing vehicle, but ONLY for 48 hours per Schertz City Ordinance. All vehicles in driveways must be operable and in working condition. Check our DCCRs for details and the City of Schertz ordinance for parking details. Don't get a ticket.
- 10. HOA dues are due upon receipt and can be paid on-line. If not paid legal action may be taken.

***** <u>Dallisgrass</u> ******

IDENTIFICATION AND LIFE CYCLE

Dallisgrass is a coarse-textured grass that grows in a clump and slowly increases in diameter as its shallow, underground stems (short rhizomes) grow outward. The <u>rhizomes</u> have short internodes (the length of stem between the joints) that look like concentric rings on its surface. The presence of these distinctive rhizomes is a good way to distinguish dallisgrass from other common clumping grasses in lawns, such as crabgrass. As the clump matures, the center may die and a different grass or weed may be growing in its center.



MANAGEMENT

A major component of dallisgrass management is preventing establishment of new plants. In home landscapes, removing <u>young plants</u> by digging them out before they form rhizomes or set seed is the best strategy for control. Mature plants can also be dug out, but they sometimes grow back if rhizomes are left behind. In professionally managed turfgrass areas, prevention is an important component in managing this weed. When dallisgrass is abundant or the plants are located over a large area, it may be necessary to supplement cultural practices with herbicides.

Prevention

Dallisgrass can be introduced into lawn areas with new turfgrass seed or sod, but often the seed is introduced on mowers that have been used in contaminated sites and then moved to weed-free sites. Cleaning a mower after mowing a contaminated site should reduce the chance of invasion into new areas. Inspect sod before taking delivery to make sure dallisgrass is not present. Don't use soil from dallisgrass-contaminated areas to repair low or bare spots in lawns. In dallisgrass infested areas delay or minimize the amount of aeration performed on the turfgrass in spring when new seed-lings germinate to avoid small open areas where dallisgrass plants might become established.

Cultural Control

Because dallisgrass is a perennial plant, persistence is required to kill it. In lawn areas the clumps can be removed by digging. Mowing the turfgrass will not remove dallisgrass, but when turfgrass is mowed at its optimum height, it is better able to resist an invasion of this weed.

****** City of Schertz Proposed Tax Increase Hearings *******

The City of Schertz will hold two public hearings on a proposal to increase total tax revenues from properties on the tax roll in the preceding tax year by 1.79 percent (percentage by which proposed tax rate exceeds lower of rollback tax rate or effective tax rate calculated under Chapter 26, Tax Code). Your individual taxes may increase at a greater or lesser rate, or even decrease, depending on the change in the taxable value of your property in relation to the change in taxable value of all other property and the tax rate that is adopted.

The first public hearing will be held on September 2, 2008 at 6:30 PM at Council Chambers, City Hall, 1400 Schertz Parkway Building #4, Schertz, Texas.
