Minutes from July meeting

The quarterly meeting of the White Lake Hills Neighborhood Association was held Monday, July 13, 2009 at the Catholic Renewal Center, 4503 Bridge Street, Fort Worth, Texas. President Elaine Mireles called the meeting to order at 7:02 p.m. The President called for approval of the minutes from the January 12 meeting. The minutes were unanimously approved. NPO Tamelia Reddick was on vacation. No incidents or statistics were presented. President Mireles reminded neighbors that National Night Out will occur on Tuesday, Oct 6, 2009 at 6:30 p.m. Those interested in being block coordinators were invited to call 817-392-4123. WLH residents were reminded that the next COPS training on Saturday, July 18th, from 8 a.m.- 4 p.m. at the Police Academy, 1000 Calvert Street.

Code Compliance Officer Mark Oler was on vacation, no code reports were presented. Treasurer Bob Curtis presented the treasury report, which appears as follows:

\$ 8,900. in checking account

\$ 55,355.00 in money market

\$ 9,500.00 in COPS fund

\$ 54,760 in total

The neighborhood received a donation of \$2,000.00 from Chesapeake Energy for this year's July 4th parade, which had an attendance of approximately 220 people. \$3,800. was budgeted for the parade and picnic (including the gift from Chesapeake). The neighborhood made almost \$700.00 selling briskets. Since there was not a quorum in attendance, the treasury report could not be approved, and will be filed for audit. President Mireles announced that the silo on Oakland Boulevard has been bought by XTO Energy. Both XTO and Historic Fort Worth, Inc. will be involved in seeking to approve a historic designation. President Mireles then announced that Chesapeake Energy is considering purchasing a water fountain for Smith-Wilemon Park. Along with the water fountain, a doggie fountain, and water spigot are being considered. Chesapeake would be donating approximately \$6,000 to underwrite the project. Vice-President Johnny Young announced that Freeman Toyota may also be interested in helping to fund the new fountain. President Mireles then submitted a general report about the July 4th Picnic & Parade, and asked for comments from neighborhood residents. This years' parade included: 40 classic cars from the "Rockin Rods", 3 floats, 7 hybrid cars (1 from Freeman Toyota), 2 motorcycles, 1 Segue, Several walkers

A few meeting attendees noted that a band didn't perform in this year's parade. The Nolan Catholic High School band is on the calendar for next year's parade. In 2010, July 4 is on a Sunday, so next year the parade and picnic will occur on Saturday, July 3rd. The firetrucks were also missed this year. The sons of the American Revolution remain an important part of each WLH parade, and their presence was noted and appreciated. One neighbor said Willow Ridge seemed to have no viewers, but others thought there was a good crowd. President Mireles suggested the heat may have played a role, others noted a good attendance, with people sitting in the shade. Thanks were given to the volunteers who made the event a success, including L.G. Cornish for cutting the meat, to Sammie's BBQ for cooking the meat, Elaine Mireles for providing beans, also to Willie Anderson and his brother for cutting and serving meat. Manfred and Gisla for decorating, Patrick Krick for staying up all night guarding the set-up, and to Johnny Young for serving beans and putting up tables. Gratitude is also expressed to those volunteers who set up chairs and tables, including the boys from our neighborhood apartment complex, who stayed and picked up every chair and table, getting them stacked up ready for Taylor's Rental to pick up. Thanks also to the Boy Scouts and the Countrytown Flyers frisbee team.

President Miureles then announced that The White Lake Hills Fall Festival will take place on November 7 this year. It was suggested that another Neighborhood Garage Sale be set up for the same date, since the Swine Flu school shut-down reduced attendance at the spring sale. Each block is encouraged to bring side dishes for the fall picnic at Smith-Wilemon Park. The 5 briskets that are left over from the July 4th parade and picnic could be used for the Fall Picnic event. Any musicians or performers in the neighborhood would be gladly welcome to perform at the picnic. Since the quorum had not been met. At the evening meeting, no vote on the Fall Festival was made. President Mireles then invited neighbors to voice their concerns and announcements. Peggy Terrell suggested that the neighborhood use one website, instead of the two sites White Lake Hills currently has, which are whitelakehills.org and neighborhood link.org. Patrick Krick suggested that The Executive Committee discuss one single website to represent our neighborhood. Jack White raised a concern about the upkeep the neighborhood entrances, and was

We are very excited about the work we are doing in east Fort Worth and with White Lake Hills. As you may have noticed, the drilling has finished and the rig has come down on Chesapeake's Arc Park property on East 1st Street to the north of White Lake Hills. Four wells were drilled back to back at this location to produce the minerals of our neighbors. These wells are White Lake Hills 5H, 6H, 7H, and 8H, and join the 1H and 2H as wells drilled for the White Lake Hills unit. These wells will be fractured in the coming weeks. Exciting news!

You may have also noticed the improvements made to this property. Chesapeake has completed construction on five buildings thus far using all Fort Worth owned and operated subcontractors; adding millions of dollars into our community! These buildings currently house over 100 jobs with the potential for many more.

It is our goal to operate in the Barnett Shale for many years to come and we are committed to our good relationship with you, our neighbors. Thank you, White Lake Hills, for doing your part to deliver clean-burning natural gas to the nation and helping to reduce our dependency on foreign energy.

Handyman's Corner

It is something that most of us have, but none of us think too much about, or talk about. It's aluminum wiring. Aluminum wiring was used in home construction between 1965 and 1973, and it is still used in limited applications including residential service entrance wiring. However, copper wire is now the only wire that can be used for residential home construction according to current city code. Aluminum wiring, when properly installed, can be just as safe as copper. Aluminum wiring is, however, very unforgiving of improper installation. The main problem with aluminum wiring is a phenomenon known as "cold creep". When aluminum wiring warms up, it expands. When it cools down, it contracts. Unlike copper, when aluminum goes through a number of warm/cool cycles it loses a bit of tightness each time. To make the problem worse, aluminum oxidizes, or corrodes when in contact with certain types of metal, so the resistance of the connection goes up. Eventually the wire may start getting very hot, melt the insulation or fixture it's attached to, and possibly even cause a fire. But if you think of it in common sense terms, I would estimate 90% of the homes in White Lake Hills have aluminum wiring, yet since we moved into this area six years ago, there has not been one house devastated due to fire caused by aluminum wiring.



There are some warning signs that home owners should heed that can indicate a fire hazard. These include: warm-to-the-touch face plates on outlets or switches; flickering lights; circuits that don't work; or the smell of burning plastics.

Whenever you do the repairs yourself or you contract to have a professional do them for you, there are a few things you as the home owner want to ensure.

According to Fort Worth City code, the only approved connection between copper and aluminum wiring is by using a purple wire nut manufactured by "Ideal" commonly called the Ideal 30 Twister 65. These caps are rather pricey, for a package of just two of them, enough to make one connection; you will pay right around \$5.00 dollars at a local home improvement store.

When replacing outlets or switches ensure that your contractor uses devices designed especially for aluminum wiring. These will be marked "Al/Cu" or "CO/ALR". These fixtures are somewhat more expensive than the ordinary ones.

Wires should be properly connected (at least 3/4 way around the screw in a clockwise direction). Never connect a fixture wired using the alternate "push-in" terminals. This type of connection results in an extreme fire hazard with aluminum wire. Any connections using push-in terminals should be redone with the proper screw connections immediately.

Any non-rated receptacle, the most common being "GFCI" or *Ground Fault Circuit Interrupter*, be connected by means of a short copper "pigtail" or connecting a short piece of copper wire to the end of the aluminum branch circuit using the purple caps. The short copper leads are then attached to the receptacle.

Disclaimer, this brief article describes only the basic information about aluminum wiring and is not inclusive, if you would like more information I suggest either you research the topic at the local library or consult a professional licensed master electrician.
