is located right in our neighborhood at 933 Goss Avenue. The organization focuses on helping people overcome their challenges to become self-sustaining members of the community. Some of the issues that the VOA addresses are homelessness, addiction and developmental disabilities. Many programs are available on a sliding scale to increase accessibility for those in need.

The VOA's major projects include the Family Emergency Shelter, the Grace House and the Maud Booth House. Each establishment has a distinctive purpose, and all provide shelter for those in need. The Family Emergency Shelter addresses the immediate needs of homeless families while helping them build a plan to transition to their own home. The Grace House provides a safe haven for pregnant or postpartum women who are suffering from addiction. The Maud Booth House is a home for women who are at least six months into recovery from substance abuse who have young children. Each shelter focuses on keeping families together during such difficult transitions, a distinction that is important for parents who would hesitate to seek help if it meant separation from their children.

Follow up is provided in all cases to make sure that individuals and families stay on the road to recovery, and the VOA also operates various programs to support veterans and adults with limited independence due to developmental disabilities. For those interested in learning more about the VOA, the organization offers the Real3 Journey, a tour of the Family Emergency Shelter that includes information on the solutions that VOA offers to people in need. Reciperite

From the chef at Flabby's

Fried Chicken Livers

As seen in Saveur Magazine

Ingredients:

Canola oil, for frying

1 lb chicken livers, trimmed

1 cup buttermilk

2 cups self-rising flour

1 thsp. kosher salt

2 tsp. freshly ground black pepper

1 tsp. poultry seasoning

Hot sauce for dipping

Directions:

- 1. Pour oil into a 4-qt saucepan to reach a depth of 2"; heat over medium-high heat until a deep-fry thermometer registers 340 degrees. Soak livers in buttermilk for 5 minutes. Combine flour, salt, pepper and poultry seasoning in a small baking dish. Drain livers; dredge each liver in flour mixture, shaking excess flour, and transfer to a plate.
- 2. Fry livers in batches until golden brown, 3-4 minutes.
 (Cover pan with a splatter screen to keep oil from splattering.)
 Transfer livers to a paper towel-lined plate. Serve with hot suase.
