

## YUMMY HALLOWEEN RECIPE

30-40 cherry tomatoes 1 8oz package cream cheese, softened 3-4oz crab meat, chopped shrimp, salmon, deviled ham OR tuna

Small jar of black olives

To prepare the tomatoes, cut off the stem and also a slice off the bottom so that the tomato sits flat. Hollow out center (seeds and pulp) with a small spoon, then lightly salt the inside of each one and put upside down on paper towels to dry.

When the tomatoes are dry, using a small spoon or pastry bag, fill tomatoes with cream cheese mixture, rounding off the
