### JCCA's Phase Representatives Will Soon Be Knocking on your Door for Your Signature

Many of you have already received the combined Phase Building Restrictions in your mailboxes.

- JCCA Neighborhood reps will be going door to door during the month of May to get your signature on the newly combined Jefferson Cort Building Restrictions.
- These restrictions are very similar to the ones that have been in effect since the neighborhood was built, however each phase has had slight differences. This combined set of restrictions will be re-filed with the Parish Clerk of Courts office and from that date forward will be enforced.
- 4. Please understand that any structures or violations erected prior to the Renewal/Adoption of these May '09 Restrictions are grandfathered and will not be enforced.
- These restrictions protect our property values and prohibit people from building anything that would adversely effect them. If you have any questions please call your phase representative.

This camera would monitor the comings and of vehicles goings into Jefferson Cort and transmit wireless video to designated computers with JCCA security code. ### Legal and Safety Reminders:

- Kids will be getting out of school in the end of May, many will be home during the day, out later at night, etc. Talk to your kids about safety and responsibility.
- Firing ANY FIREARMS in the neighborhood is illegal and addressed by both State and Parish laws
- PLEASE be careful at the stop sign at Adams Road, many travelers do not stop!
- Residents in phase 5 and at the end of State Street often see kids on go-carts, golf carts and 4-wheelers going TOO FAST, taking corners on 2 wheels, hanging on with one hand, often with too many kids. This endangers themselves, people/kids walking, biking, and narrowly missing cars backing out of driveways. We are concerned about the safety of children. Should a child be seriously injured (or worse) no one will know how to contact the parents. PLEASE WATCH YOUR CHILDREN. Also remember these vehicles are NOT street legal, any accident no matter how large or small will be the legal and financial responsibility the owner.
