Recycling Changes

Kansas City, MO has made some changes to what materials are ok to put out for curbside recycling. The Kansas City Star published an article in late January with changes which was distributed at our February meeting; however, their article was incorrect! They may have since published a retraction. Here is a list of acceptable and unacceptable items according to the city's website:

Recycle these items in your bin:

- Aluminum cans and other metal cans.
- Plastic bottles with a neck that are designated as #1 or #2 on bottom (examples: water & soda bottles, milk jugs, detergent bottles)
- Plastic containers designated as #3 through #7 on bottom (examples: yogurt and margarine tubs)
- Office paper, junk mail, newspapers, phone books, catalogs, magazines.
- Cardboard (both thick corrugated and thin, cereal box-type)

Don't put these in your bin:

- Pizza delivery boxes
- Glass
- Plastic bags
- Styrofoam
- Motor oil bottles & other automotive product bottles
- Egg cartons
- Paper towels, tissues or napkins, plates or cups
- Waxed containers (examples: milk cartons or juice boxes)
- Gift wrap
- Shredded paper
- KC Recycles will not accept plastic containers used for commercial or medical purposes, household hazardous materials, medicine and pills.

City Housing Funds

The city has funds available for housing, but many at City Hall do not perceive the needs north of the river. One example is the funds set aside to deal with foreclosures. Kansas City received federal funds to tackle the foreclosure issues in our city. In some areas of the city, foreclosed homes will be purchased, rehabbed, and resold. However, there is currently no plan to spend any of those dollars north of the river!

In the Chaumiere neighborhood alone, there are five foreclosed homes currently on the market & ten that have sold since January 2008. When the entire Kansas City north area is examined, there are currently 139 foreclosed homes on the market and 423 that have sold since January 2008.

Scholarships Available for Low-Income Residents

(from "News from City Hall" email)

For the second year, the City of Kansas City, MO Youth Advocacy Office, a division of the City Manager's office, will help administer a scholarship grant program funded by The Port Authority of Kansas City, MO and area casino gaming operators.

The scholarships will serve city residents living in households that have a total annual income of 80% or less of the median income of city households. Scholarship applicants must be 17-25 years old, pursuing educational opportunities at an accredited or certified college, university or vocational/technical school and have a high school diploma or GED equivalent.

Scholarship applications, along with a high school transcript or GED certificate, a 300-word essay, a letter of recommendation from a teacher, counselor, employer, or clergy member and the most recent IRA tax forms of all members of the household are due by May 1. Scholarship applications are available at www.kcmo.org/youth or at the Youth Advocacy Office on the 25th floor of City Hall, 414 E. 12th St.

The scholarships will provide a minimum of \$1,000 per academic year and can be used for tuition, books, room and board, and activity fees. Scholarships are renewable if recipients remain full-time students, stay in good academic standing with the institution they are attending and continue to live in a household that has a total annual income of 80% or less of median income of the city, defined as:
