Prince George's County's <u>Fire Safety Law SEC 11</u> states it is against the law to shoot fireworks in Prince George's County, and the penalties for violation of the law include a <u>FINE UP TO \$1,000 AND/OR</u> <u>SIX MONTHS IN JAIL</u>. Call the Police on 911 and give the address where fireworks are being used.
