Who Can Use the Residential Trash Transfer Stations?

Residents of the following cities may use the program: Coconut Creek, Cooper City, Coral Springs, Davie, Dania Beach, Deerfield Beach, Fort Lauderdale, Hillsboro Beach, Hollywood, Lauderdale-By-The-Sea, Lauderdale Lakes, Lauderhill, Lazy Lake, Lighthouse Point, Margate, Miramar, North Lauderdale, Oakland Park, Pembroke Park, Plantation, Sea Ranch Lakes, Southwest Ranches, Sunrise, Tamarac, Weston, West Park, Wilton Manors and residents of Unincorporated Broward County.

Who Cannot Use the Residential Trash Transfer Stations?

Residents of Hallandale Beach, Pembroke Pines, Parkland and Pompano Beach cannot use the stations for yard and bulk waste. They must contact their city for additional disposal information. **Additionally, business-generated trash cannot be accepted at the stations.**

What Kind of Trash is Accepted?

Yard waste, home furniture and furnishings, white goods (appliances) and woody items (fencing and lumber). Also, household hazardous waste (paints, solvents, oil, etc.) and used electronics (computers, televisions) are accepted, but must be kept separate from bulk trash.

What Kind of Trash is Not Accepted?

Garbage, explosives, radioactive materials, biohazardous waste and dead animals are prohibited.

What Documentation is Required?

For trash to be accepted, you must show the following: Proof of residency (current driver's license/photo ID) **and** one of the following: Current utility bill (water, electricity, cable, telephone) and/or tax notice (name and address must match). Any users without the required proof of residency will be denied access; residents without the required proof of residency will be required to contact their City for an Authorization Certification to be allowed access into the facilities.

Is There a Charge?

No, the program is free for qualified Broward County residents. **However, there is a 4-visit limit per resident per month.**

Responsibility and Limitations

Residents are required to off-load and place material in the dumpster themselves, and must abide by the unloading directions of the site supervisor. Children under the age of 16 are not permitted in the loading area. Care and caution should be exercised at all times.
