Farley Neighborhood Crime Watch

Are you interested in participating in the Farley Crime Watch efforts? It may not be what you think!

The neighborhood crime watch group is a network of neighbors involved in the communication of crime related activities reported in Farley. After an incident has been reported and controlled by the local police, neighbors are encouraged to report the incident to their block captains. The block captain then reports the incident to the neighborhood crime watch team for distribution of crime information throughout the neighborhood and surrounding neighborhoods. The Farley Crime Watch team, like many quality crime watch groups, is not involved in the handling of ongoing incidents. Rather, the crime watch team is network of neighbors who distribute crime related information with one another.

Participating in the distribution of crime information encourages neighbors to communicate with one another on a routine basis. The Metropolitan Police Department reports that this type of networking of crime watchers creates safer neighborhood and criminals are more likely to be apprehended and prosecuted.

The Farley Neighborhood Membership flyer (attached) contains a section where you can provide your e-mail address which will be given to your block captain. If you would like to be involved in receiving information about incidents that occur in Farley,

The cars parked along both sides of the street created a nuisance for service vehicles, trash trucks, and emergency vehicles entering Farley's main entrance along Girls School Road. Farley Board members worked with City Councilman Robert Lutz to petition the residence along Carlsen Avenue for a city ordinance that restricts parking along Carlsen Avenue between the hours of 7 AM and 3 PM. Support for the new ordinance was widely accepted by the home owners along Carlsen Avenue.
