Have You Signed Up Yet????

The Answer to Your Yard Waste Prayers is Just a Phone Call Away

To save money the City of Columbus announced in late January that it was canceling its contract with Rumpke to collect yard waste. (This action does *not* affect recyclables.)

So, what's a person to do now? Excellent question! The Indian Hills Residents Association has made arrangements with CMI Waste Removal Service to pick up yard waste curbside every week for a fee of just \$10 per month. Service began March 9. Our pickup day is *Monday* -very convenient. So now you can do yard work all weekend from sun up til sun down and on Monday all those bags and cans of leaves and brush and foliage will miraculously disappear. But, you have to call to start the service. So, if you're interested call CMI at 614-833-4612 and mention Indian Hills. If they're not available, they'll call you back. CMI will bill you every other month (\$20 six times a year).

If you choose not to participate in this voluntary program, you may take your yard waste to the following drop-off centers:

- Com-Til (the city's compost facility at 7000 Jackson Pike on the South Side) accepts tree limbs.
- Kurtz Brothers accepts leaves, grass clippings, small branches and Christmas trees (which hopefully you've already disposed of by now) at its facility at 2850 Rohr Road, Groveport. The company also takes homeowners' yard waste at 6055-C Westerville Road, Westerville and 6279 Houchard Road, Dublin.

Lastly, Ohio Mulch takes yard waste at 4120 Roberts Road on the West Side. It also accepts yard waste in recyclable paper bags at 4665 Westerville Road, on the Northeast Side; 1600 Universal Road, on the South Side; 7320 Industrial Parkway, Plain City; 7765 Refugee Road, Pickerington; 840 S. Columbus Street, Lancaster; and 537 Reynoldsburg-New Albany Road, Blacklick.

If you forego the CMI pick ups, now would be a *great* time to create that compost pile you've always dreamed of. In addition, you may want to think about mulching the grass instead of bagging. It's better for the grass and for the environment.

What You Should Know About Snow Plowing in Indian Hills

A couple years ago, the IHRA Executive Board made the decision to spend some of our money – your money – to pay for a snow plowing service in Indian Hills. We're not required to do it. The City of Columbus is responsible for this function, but City plows get to us sometime between late and never. Our decision to plow has been overwhelmingly popular, but "perfect" service is a tall order.

Our plowing service is automatic at a predetermined snow depth. The provider has customers other than us. We won't always be first, nor will we always be last. The plow will get to us. Please be patient.

It's not always possible to plow down to bare pavement, and you can't plow ice. Our provider will apply salt/deicer as necessary and when temperatures allow.

Plowing will not necessarily be curb to curb. Our provider will come as close as possible, but must deal with corners, curves, parked cars and so forth.

Plowing does not mean removal. The snow and slush will not literally disappear. It must go somewhere. On public streets such as ours, generally the plows will move in the direction of traffic. But whatever the plow's direction, the end result is half the snow pushed to one side of the street and half to the other. (Cul-de-sacs require a bit more "art".)

Inevitably, therefore, some snow will be plowed up onto the edges of your yard and driveway. It will be plowed onto and over the storm sewer drains on the streets and the curb outlets of your gutter and downspout drain lines. It may be plowed toward your mailbox. This is unavoidable and simply the way it goes.

It remains the responsibility of each resident to clear their own driveway, and clear their mailbox area, drain line outlets, and storm drain if necessary.

Tom O'Mahoney, 950 Greenridge Road, is helping out SVOSH - Student Volunteers of Optometric Services to Humanity at the Ohio State University College of Optometry. SVOSH's goal is to offer eye exams and glasses to folks who otherwise would not be able to get the care they need. This year about 45 students, technicians and optometrists will travel to Ecuador for four days. Each patient is given an exam, corrective lenses, medicine if necessary and a pair of sunglasses. For some patients this will be the only eye care they receive in their lifetimes.

So, where do all these glasses come from? The students gather the glasses that have been donated in large part by Lions Clubs and optometry offices throughout Ohio. They examine, clean and check the prescription of each pair to ensure patients receive high quality glasses. Other supplies are donated by businesses and travel expenses are paid for with public donations.

comfort of your family room. Maybe your friends and relatives would also like to participate. Then they too will feel that sense of satisfaction which comes from decluttering their house and helping out a good cause.

We remind everyone that long-term parking or storage of *boats*, *trailers*, *RV's*, *motorhomes*, *utility trailers*, and the like is prohibited by both City Code and Indian Hills Restrictive Covenants. Such vehicles may not be parked or stored on the street, on a driveway, or in a yard or lot. They may be parked/stored if wholly enclosed in a garage. We thank our residents for their cooperation.
- If you're out walking the streets (so to speak) at night or early in the morning be sure you wear something that makes you visible to drivers. Remember - safety first.
- Keep your speed to 25 miles per hour on all Indian Hills streets. If you must speed, please go to a race track or to some other neighborhood (only kidding)!
- Keep your streets litter free pick up trash when you come across it.
- Don't be a target for thieves ask your neighbors to pick up your weekly papers if you are going to be away.
