Tampa Bay Watch trains and organizes citizen volunteers, students, at-risk youth, and civic organizations to participate in environmental projects while heightening community awareness of the fragile nature and importance of the environment.

Tampa Bay Watch makes the bay better by empowering citizens of all ages for environmental stewardship. Through their education efforts, bay area students, residents and visitors are equipped with the knowledge, skill and desire to act as stewards of their environment. Personal experience with nature builds the desire to protect nature, which is why they are helping the bay area community to experience our amazing Tampa Bay.





Juli Milas called the meeting to order at 7:34PM. The Pledge of Allegiance was lead by Gil Leimbach. Juli recognized Norm Coffman and Wesley Memorial Church for allowing us to conduct our meetings. Juli thanked Gil for hosting the meeting and also Lynette Peel for her assistance. Town & Country Hospital was recognized for providing the Health Screening during tonight's meeting. Thank you Marcea, Micah and Joanne! Juli accepted a motion to approve the minutes from the May 28, 2009 General Membership meeting. It was moved, seconded and approved.

Gil announced that the Bay Crest Park Civic Association's current account balance is \$12,403.17 as of July 31, 2009. We have 512 paid members to date.

Juli recognized newcomers Windy Ancipink, Ginny Cooper, Michelle Cook and Steven Wood.

Deputy Michelle Branscomb with the Hillsborough County Sheriff's Department and our CRD was introduced and shared that there are crimes in the surrounding neighborhoods that a task force is addressing. She reminded us all that school has started and we should report any students who appear to be skipping class. Michelle stated that a reader board would be placed at the entrance of Bay Crest with the truancy number to report an issue. Please be prepared to give a description of the student and location/street where you saw them. Statistics show that 60% of students who skip school will commit a crime.

Paul Morales, Hillsborough County Code Enforcement Officer who is dedicated specifically to our area, explained some of the violations and what we can do.

Juli announced that there are two board member resignations: **Tom Suttle** and **Chet Krupski**. Thank you to Tom and Chet for their many years of support and good work!!

Juli shared that the Mini Grant Program for Shimberg Gardens is in process. The Parks and Recreation department will be working on the park area by the Library soon. It has not been forgotten, just taking a little longer than we had all hoped. Also, the Crisis Center of Tampa Bay presented at the Town & Country Community Council meeting. The Crisis Center is available 24 hours a day, 7 days a week and can be reached by dialing 211. Town & Country 50th Going Gold is on schedule for September 19 (11:00 – 4:00) at Jackson Springs Park. Gene Milas introduced **Larry Gispert**, the head of the Hillsborough County Emergency Management Department. Larry shared the facts around storm surge during a hurricane and how it would affect the Tampa Bay area. He stressed that we should all make a plan for our families in the event Bay Crest is ordered to evacuate.

Steve Eggert, an active Bay Crest member, has agreed to chair the newly re-instituted Bay Crest Good Neighbor Patrol. Steve said they are looking for volunteers to help with this valuable patrol to get it going again. Please contact Steve if you can help take a shift.

Juli asked if the group had a preference on the next Bay Crest Community Yard Sale. A vote was taken, and the majority chose October 17 for the next event. More information to come.

Gene reported that the board agreed to have the buffer strip along Memorial Highway worked on and would have the dead trees replaced as well. Also, a landscaping contractor will be going through the community to spray Roundup and edge curbing in the neighborhood. This work is being paid for by the Civic Association.

County Emergency Management Director Speaks at August Meeting




Our program speaker for the August General Membership Meeting was Mr. Larry Gispert, Director of the Hillsborough County Emergency Management Department.

Larry brought a unique blend of education, entertainment and fun to the meeting with his stories and experiences in tracking and evaluating damage from numerous large hurricanes in the past several years. These included Katrina, Andrew, Camille, Ike, Donna and many others. He offered fascinating data about where hurricanes landed, what damage they did, and the heights of flood surges caused by the high winds.

Of particular interest were many pictures of landmarks in Hillsborough County with overlays of the portions that would be underwater in a major storm surge. He also showed many first-responder photographs of damage from major storms, particularly Katrina.

He showed graphically the landfall points of storms over many years, and noted that the Tampa area has never had a direct hit from a major storm and that we are overdue. He also emphasized hurricane preparedness and planning, especially in planning your route and timing to escape a major storm. His bottom line: "Don't wait until the last minute."

Mr. Gispert concluded the thought-provoking presentation with a question and answer session.





Bay Crest Elementary Covered Play Court Dedicated

With children marching into the area to Olympics-themed music, staff, parents and others gathered Friday morning, August 28 to dedicate the long-awaited play court cover at Bay Crest Elementary School.

The project, funded by the Bay Crest PTA, Hillsborough County, and several donors (including our Civic Association), will protect children



from excess sun and heat during outside activities. The project also included painting and refurbishing the court surface and the surrounding walkway.

Support the Kaye Prox Food Bank -- "Providing emergency food to needy families, elderly, and the homeless in our community."

The Kaye Prox Food Bank, located at the Lutheran Church of Our Savior, 8401 West Hillsborough, now serves 90 to 100 families a week on Mondays, Wednesdays and Fridays from 3:00 PM until 4:30 PM. Also served are the area's 30-40 homeless persons on the same days. Home deliveries are provided to the most needy in our community twice a month. Kaye Prox began this ministry in the 70's and worked tirelessly until her death in 2002.



This unique volunteer program is a combined effort of five area churches — Lutheran Church of Our Savior, Incarnation Catholic Church, First Reformed Presbyterian, Wesley Memorial United Methodist and Wellspring United Methodist. The partner churches do monthly food drives, collect monetary donations and provide valued volunteers. There are also volunteers from the community that may not have a church affiliation or are not a member of a partner church. The requirement of being a volunteer is "a desire to help the needy." Volunteer opportunities are available outside the food bank hours, including making sandwiches for the homeless, picking up bakery items from Publix on Mondays and Fridays and helping with food deliveries.

The Kaye Prox Food Bank is a member of America's Second Harvest and Tampa Bay Harvest. This affiliation helps obtain food at handling fee prices and use food that would normally be destroyed.

Please bring non-perishable canned or bagged food items to our next General Membership Meeting on November 19. Help the Kaye Prox Food Bank help families, children and individuals in need.

BAY CREST ON YOUR SIDE

Curbs more appealing. Again this year, the Association contracted for a community-wide curbside cleanup. In the past few months, a contractor has been spraying grass and weeds that have grown into and over the curbs with herbicide then following with edging and blowing. This once-a-year effort helps our overall community appearance, but would be less necessary if all our residents kept their curbside grass trimmed and edged. Please help keep our curbs more "appealing" by maintaining a neat appearance year-round.

Keep grass trimmings under control. On a similar note, please don't leave yard grass clippings in the street or gutters (photo at right). They wash directly to the bay, reducing oxygen level for fish and promoting algae growth and pollution (not to mention adding still more silt to our canals). Use a blower to clear the streets and tell your lawn service people to keep the curbs and sewers clear of clippings.

Shrubs being replaced. Over several water-restricted years and some motor vehicle accidents, many of the wax myrtle plantings on the Memorial Highway buffer strip have died, grown poorly, or been mowed down. The Associated contracted for new plantings, and work has recently been completed to fill in numerous "holes" with 17 new bushes. We're keeping our fingers crossed for enough rain to ensure the new plants will flourish.





"Bargain" day. If the photo looks like your garage, then you could be having the equivalent of a big sale at the home store... except that your customers will be thieves. Leaving your garage door (and car doors) open are like advertising "Here's the stuff – come and get it!" Be

sure your property is secure 24/7, including the garage, car

AND doors to your home. Many thefts occur because the bad guys can just walk in. Our Good Neighbor Patrol (see page 15) advises that many garage doors are left open in Bay Crest. Protect yourself and your stuff at no cost – lock it up!

Why not use the sidewalks? We are fortunate to have sidewalks in most areas of Bay Crest Park, so why do so many choose the middle of the street to walk or run? It creates an unnecessary danger for drivers and pedestrians, particularly at hours when visibility is poorer. Please use the sidewalks where they exist.

Are you recycling? The County is challenging all residents of Bay Crest Park to recycle more! Start recycling more right now by putting your recycling bins out every week filled to the brim with recyclables. Don't have recycling bins? Need new ones? No problem. Go to the County's new recycling Web site, www.hillsboroughrecycles.org. to request yours today.

With the efforts of new Chairman Steve Eggert (shown addressing the August meeting) and two dozen eager volunteers, the neighborhood's "observe and report" citizen patrol is now in full operation. reports volunteers have signed on to cruise the community on a regular basis to note any

potential problems. These include suspicious activities, loitering of unknown people or vehicles, possible code violations, and any other events that may cause problems, law enforcement or otherwise.

The role of the volunteer is to observe and report, keeping close ties with the Sheriff's Department, Code Enforcement, Solid Waste, and other County agencies. Volunteers have no direct involvement in enforcement or investigation.



Code Enforcement - Residential Property Maintenance



Hillsborough County's Minimum Code Ordinance requires that property be maintained and kept free from nuisances, structural defects and deterioration. The purpose of this Ordinance is "...to secure the public safety, health and general welfare of the citizens of Hillsborough County, Florida." This Ordinance regulates the condition of the property including overgrown conditions, accumulations of junk, trash or debris, the storage of inoperable vehicles, and various other nuisance conditions, as well as the conditions of all buildings or structures located on the property.

Q. What is overgrowth?

A: Overgrowth is defined by the County as the growth of grass, weeds or underbrush in a height exceeding ten (10) inches within twohundred (200) feet of a building, structure, recreational area, or street right-of-way and is determined by the County to create a nuisance for the surrounding community.

Q: When is a vehicle considered to be inoperable?

A: Hillsborough County's Minimum Code Ordinance defines an inoperable vehicle as one which "...is in a state of disrepair and or incapable of being moved under its own power."

Q: What other things are considered to be a nuisance?

A: Nuisances are intentionally given a very broad definition, as the intent is to address conditions that affect the public's safety, health or general welfare. A nuisance can mean:

"any nuisance as defined by law, or any attractive nuisance that may be detrimental to children whether in or near a building or upon an unoccupied lot. This includes, but is not limited to, abandoned wells, excavations, unclean swimming pools; abandoned iceboxes, refrigerators and motor vehicles; structurally unsound fences or structures, lumber, trash, debris; unsanitary conditions or anything offensive to the senses or dangerous to health, including the emission of odors, sewage, human waste, liquids, gases, dust, smoke, vibration or noise, or whatever may render air, food, or drink detrimental to the health of human beings; physical conditions such as, but not limited to, old, dilapidated, abandoned scrap or metal, paper, building materials and equipment, bottles, glass, appliances, furniture, rags, rubber, motor vehicles, and parts thereof, and physical conditions posing fire hazards, physical conditions posing a hazard, such as, but not limited to, dead or damaged trees."

Q: What parts of a building are regulated by this Ordinance?

A: In a word -all. This Ordinance requires that all "...buildings, structures and parts thereof shall be maintained in sound condition, good working order, and in a safe and sanitary manner." Specific regulations are included to address roofs, walls, windows, fire safety, mobile homes, and much more. Hillsborough County's Minimum Code Ordinance is available online in the "Publications" section of Code Enforcement's Website.

Q: How can I report a suspected violation?

A: Suspected violations of this code can be reported in several ways: phone, website, fax or in person.

Q: Can I remain anonymous when registering a complaint?

A: Yes. We do not require that you provide any personal information when registering your complaint. Remember that all information you choose to provide to the County, including names, phone numbers, or email addresses, is subject to the Public Record Laws. In other words, we must provide this information to anyone who asks for it. If you wish to remain completely anonymous, do not provide your personal information when registering the complaint.

Q: What do I do if I've received a notice of violation?

A: If you have any questions about what is required of you to achieve compliance with Hillsborough County's Code, please contact the Investigator assigned to your case. The Investigator's name is listed at the bottom of the notice you received. The goal of Code Enforcement is to preserve the quality and value of public and private property, and maintain a high standard of living by eliminating conditions that threaten the life, health, safety, and general welfare of the public. The department recognizes that this goal is most effectively achieved through the education of, and cooperation with, the citizens of Hillsborough County.



Gardening Tips

WHAT TO PLANT IN NOVEMBER



VEGETABLES: Beets, Broccoli, Cabbage, Carrots, Cauliflower, Celery, Chinese Cabbage, Collards, Kohlrabi, Lettuce, Mustard, Onions (bulbing and bunching), Peas, Radish, Spinach, Strawberry, Turnips.

HERBS AND SPICES:. Anise, Basil, Bay Laurel, Borage, Caraway, Cardamon, Chervil, Chives, Cilantro/Coriander, Dill, Fennel, Garlic, Ginger, Horehound, Lemon Balm, Lovage, Marjoram, Mexican Tarragon, Mint, Nasturtium, Oregano, Rosemary, Sage, Savory, Thyme, Watercress.

BULBS: African Lily, Amaryllis, Aztec Lily, Calla, Crinum, Elephant Ears, Gladiolus, Lapeirousia, Louisiana Iris, Moraea, Narcissus, Pineapple Lily, Shell Ginger, Society Garlic, Spider Lily, Walking Iris.

WHAT TO DO IN NOVEMBER

Plant and fertilize annuals.
Fertilize citrus trees if not done in October
Sidedress vegetable plants with fertilizer.
Set strawberry plants. November is the last month to plant strawberries.
Plant winter ryegrass seed.

Reduce irrigation frequency as weather cools. Lawn and landscape irrigation should be reduced during winter months. Adjust time clocks to conform to time changes or turn off sprinkler systems completely and water only when plants or the lawn need it.

Plant containerized roses. Plant roses now for a beautiful spring display. Prepare a good rose bed, buy roses grafted on Fortuniana or Dr. Huey rootstocks, and plant them at the same depth as in the containers. Antique or old garden roses do not need to be grafted.

Plant cold-hardy landscape plants. Fall is for planting. Cold-hardy trees and shrubs establish well during cooler months. Check poinsettias for poinsettia hornworms. Young worms can be controlled with an insecticide. Handpick mature worms.

Root-prune plants scheduled for transplanting. The best time to transplant trees and shrubs is December through February. Root-prune them now to help them survive the move. Cut a 12-15 inch circle around the plant, slicing the roots with a shovel to a depth of 12 inches. When transplanting (four to six weeks later) dig four inches beyond the root-pruned area.

Monitor the vegetable garden. Continue planting fall vegetables. Apply two to four pounds of 8-8-8, or 1 or 2 pounds of 15-15-15, or similar fertilizer per 100 square feet every 2-3 weeks. Watch for caterpillar feeding and spray with Bacillus Thuringiensis if detected. Aphids and other soft-bodied insects can be controlled with insecticidal soap. Remove young weed seedlings. Apply mulch.

Bring houseplants in for the winter. Houseplants set outside for the summer should be cleaned up and set in protected areas before the temperature dips below 55°F.

Divide and reset perennials. Continue to dig and replant herbaceous perennials and bulbs such as daylilies, gerberas, and caladiums. Use horticultural oil to control scale insects. Horticultural oil sprays are an effective and environmentally safe way to control scale insects. The oil coats the scale and suffocates it.
