### National Night Out

On Tuesday, August 5, 2008 communities, municipalities, and police departments across the country will celebrate the 25<sup>th</sup> Anniversary of National Night Out, a program that recognizes the efforts of police-community partnerships to reduce crime and educate the public. In 2006, the last year for which figures are available, over 10 million people participated in the event. This year more than thirty events are scheduled throughout Prince George's County.

For our area, the program will be held at PGCPD District V at 6707 Groveton Dr., Clinton starting at 5:30 PM. There will be demonstrations of the helicopter, motorcycle and K-9 Unit and a display on auto theft prevention. Health screenings will be provided by Southern Maryland Hospital. The Fire department and Parks and Recreation are also expected to participate. A moon bounce and skate mobile will be set up for the kids. Best of all, food and beverages will be provided at no charge including hot dogs, hamburgers, chicken and pizza.

Plan to attend this family event. Come out and meet the officers who serve and protect our community.

# **BHCA Treasurer on State Task Force**

The State's Attorney for Prince George's County hosts monthly Community in the Courthouse sessions. Citizens are invited to discuss concerns of their community with the State's Attorney's office. Due to the amount of concerns regarding group homes and foster care, a task force was formed. The task force was asked to look into group homes answering some of the questions posed by the community such as:

- What is the difference between group homes and foster care?
- Who supervises and regulates group homes?
- What is the age range of children in group homes?
- What are these children doing? The community thinks they may be truant, destroying property, loitering and engaging in other non-productive activity.

Carolyn Green-Fitzgerald, BHCA Treasurer, is representing Brookwood-Hollaway Civic Association on this task force and will keep the community updated via this newsletter.

The Committee's Chair, Rick Brown, reports, "we continue to enjoy reduced numbers of incidents over this time last year, as a direct result of the cooperation and efforts between the Neighborhood Watch and District V Police. However, we still have work to do and cannot afford to let up; so let's all stay alert and keep our minds on safety and security." Rick also stated, "Residents are using the N.W. communications chain to receive and share safety and security information and everyone should continue to monitor and report incidents." Observations, incidents, suspicious persons, etc. should be reported to the police and subsequently, directly to Rick at 301-877-1242 or email: crb9904@verizon.net. This will allow us to follow up with our police department resources. "We continue to field questions from residents interested in learning about the N.W. Program, but are getting few new volunteers. encouraged to be a "block watcher" by observing and reporting incidents in their immediate area."

"Our patrols continue to canvas the area, but the schedule has been scaled back until we are able to enlist additional volunteers. We would like to put at least four more teams on the schedule. To achieve this we need eight individuals to volunteer 2 – 4 hours a month. In particular, we need volunteers for weekdays (evenings and days)."

We need another N.W. committee member to work with Rick and Roberta Rosser to stay abreast of what the committee is doing, assist in the absence of Rick or Roberta, attend Board meetings, and help manage the watch patrol equipment.

Note: Juvenile gatherings in the Rhodenda and Toucan/Pitman area continue to get police attention for loitering and curfew violations. Since our last issue two more "gatherings" have been broken up. Please continue to call in these incidents to the non-emergency number 301-333-4000.

### **More Boots on the Ground**

If you saw the Washington Post's Prince George's Extra on Thursday, July 17 you read the above headline. This article highlighted the increased number of parking violations issued throughout the county. We had previously informed our members of this steppedup enforcement when it was released by the County's Revenue Authority. Using fifteen Revenue Authority enforcement agents this is "an effort to get tough on long-ignored parking laws". Common practices that are illegal include "parking on the wrong side of the road and parking on unpaved land unless the property is larger than one acre". These can "result in a ticket and the resulting \$50 fine." Officials say "the effort is a centerpiece of the County's Livable Communities Initiative, a bid to improve the quality of life". ### **Local Development Update**

The Transnational Law & Business University (TLBU) on the West Side of Frank Tippett Road, had a hearing on Thursday, July 17<sup>th</sup> before the Planning Commission (M-NCPPC) for consideration of its Comprehensive Design Plan (CDP) and, in a very unusual circumstance, its Preliminary Design Plan on the same date.

BHCA President, Barry Schlossberg, testified at the hearing addressing the impact 409 single-family homes will have on the area's infrastructure including traffic, schools, public and emergency services. He told the Commission, that at an earlier meeting with the agents and possible developer, BHCA agreed to work with the developer to try to get Parks and Recreation to construct a recreation center on the area being set aside for a community park, should the development be approved.

The CDP was approved by the Commission but they placed some thirty "recommendations" on the Plan. The Commission had a different view of the Preliminary Plan noting historical, archeological and environmental concerns. Additionally, a daycare center, which had been in the base plan, was not included in the Preliminary Plan. The Commission did not approve the Preliminary Plan.

When asked what the next step would be, a representative of the developer said, "I don't know what we're going to do."

Being curious, Fletcher Mack, BHCA V.P. did some research and learned that several acres had been purchased by Global Country of World Peace but there was no information as to any development plans being filed.
