Sidewalk issue draws Councilman's response

Ιn our February newsletter, we published a JNA member's concern about the sidewalk project that was underway i n t h e neighborhood.

A staff member to Councilman Justin Rodriguez provided one answer to the concerns. After some discussions with the councilman, the following statement is being published at his request.

With regard to the W... Kings Hwy. section of Wilson (Woodlawn to Meredith), the project is currently funded for sidewalks to be installed on the east side of the street only.

On the northwest corner of the Wilson and W. Kings Hwy. intersection, an ADA ramp was installed as part of a street rehabilitation project (a different funding source). This is standard on any of our street rehabilitation projects, even if there are no sidewalks so the apron can connect to sidewalks should funding for a sidewalk project become available in the future.

Although this ramp does not connect to any sidewalks on Wilson, it does lead directly into two utility poles. Which brings us squarely to the utility pole issue...

City Public Service (CPS) had utility lines running on one of the two photographed but no longer does. Time Warner and AT&T are on the other photographed but scheduled to remove their service lines very soon and, with that action, both poles will be ready for removal in the event funding is allocated to install sidewalks on this side and section of Wilson.

The currently funded ramps and sidewalks that have been installed as well as those vet to be installed on both sides of Wilson from Culebra to Woodlawn and on the east side of Wilson from Woodlawn Meredith consist of the following features:

1. Will be installed with the full intent of being divorced from the curb where possible but married to the curb where either there is not enough right of way for the installation or there are utility conflicts (poles or boxes).

2. Where there are utility conflicts (utility poles) or even trees, the sidewalks will be built in order to meander around those obstructions.

I hope this helps clarify the concerns brought up by the JNA member."

C.O.P Information

There's a lot of talk about crime problems in our area, but not a whole lot of citizen participation is there to do something about it.

Cellular on Patrol was started in this area in January, 1994. The original concept was neighbors carrying cell phones provided to them once they attended a two day class and report suspicious activity to the police department.

That concept is still the same. Attend two classes, carry your own cell phone, and be the extra eyes and ears of the police in our neighborhood.

On April 8 & 15 at 6 PM, you can attend the next C.O.P class. They're free. Class length is about 3 to 4 hours on two Thursdays.

After the first session, you can schedule a ride along with a police officer who patrols this area.

It costs taxpayers just \$0.42 per household if the form is mailed back, but it costs \$57 per household to follow up with people who do not respond by mail.

That means that for every 1-percent increase in the national mail back response rate taxpayers save about \$85 million.
