Let us be ready to take advantage of this once in every three-years (if we are lucky) opportunity to get rid of all junk stored in and around our properties or apartment units. Couch potatoes, let us get up and out, exercise, just a little, by clearing-out the defensible space that we need to maintain around our properties for fire safety and get rid of all yard clippings that such action will produce, **FREE** of charge! **NO** driving to the landfill, **NO** landfill fees, **NO** hauling charges, all free! With the City of San Diego in such dire financial situation and scheduled budgetary shortfalls, how can we impress in our minds and that of our neighbors how privileged we are to be the recipients of such huge mobilization of equipment and human resources to help us keep our community safe and clean? The only way that we can demonstrate our deep appreciation for such beneficial endowment of resources is by cleaning and gathering all overly used items and place them at the curb! Go into your entire house, closets, your storage sheds, your garage and all yards and get rid of all junk and unused items. Remember, if you have **NOT** used it in a year, you have no need of it! Place all discards at the curb on clean-up day and the City trucks will be happy to pick them all up.

CIVIL PROCESS

(An overview of how citizens can organize to abate Problem Properties)

After the presentation to the Neighborhood Association, neighbors called and email wanting to review the code sections (laws) that govern the nuisance property abatement. One thing to remember is that we are NOT practicing law without a license and that the venue of this "Civil Process" is nested in "SMALL CLAIMS COURT" which it doesn't use representation by Attorneys. All that is needed is the basic knowledge of the code section from those bring the action to court. Below you will find the code sections and procedures requested.

Nuisance Laws:

3479 Civil Code: "Anything which is injurious to health, including, but not limited to, the illegal sale of controlled substances, or is indecent or offensive to the senses, or an obstruction to the free use of property, so as to interfere with the comfortable enjoyment of life or property, or unlawfully obstructs the free passage or use, in the customary manner, of any navigable lake, or river, bay, stream, canal, or basin, or any public park, square, street, or highway, is a nuisance.

3480 Civil Code: A public nuisance is one which affects at the same time an entire community or neighborhood, or any considerable number of persons, although the extent of the annoyance or damage inflicted upon individuals may be unequal.

731 Code of Civil Procedure: An action may be brought by any person whose property is injuriously affected, or whose personal enjoyment is lessened by a nuisance, as the same is defined in section thirty-four hundred and seventy-nine of the Civil Code, and by the judgment in such action the nuisance may be enjoined or abated as well as damages recovered therefore.

What are the various remedies?

- n Abating the activity
- n Sale of the property
- n Changing the Operating of the business
- n Eviction of the problem tenant
- n Hiring a professional management company
- n Hiring security guards
- n Filing a Small Claims Court complaint

California State Law: Dictates that "a property owner responsibility is to use the property in an ordinary and reasonable manner that is conducive to the Peace and Harmony of the neighborhood and does not interfere with the comfortable enjoyment of life or property."

- n Anything injurious to health
- n Indecent to the five senses
- n Unlawfully obstructs free use of streets
- n Obstruction to free use of property so as to interfere with the comfortable enjoyment of life or property (is a nuisance).

Tools to Abate Retail Business of Drugs (among many other):

- n Civil Abatement:
 - a. Organized citizens
 - b. Block Watch

DEFENSABLE SPACE:

Take advantage of the October 24 rollover clean up to get rid of all vegetation and to clear your defensible space. You have two weeks to do so.

GRAFFITI:

After the raid by ICE, Homeland Security and SDPD, the 5000 block of lower Auburn was quiet until last night (Saturday, October 10). A house

had a quiet party, no music, but a bit of loud talking and loud arguments. A substantially big group of people spread into the dark and quiet streets of the neighborhood, but not for long. This morning, the trash bay at 5014 Auburn and the fence of the brown house on top of the Fox Canyon hill got tagged with white paint graffiti, coincidence or circumstantial? Do we call ICE, Homeland Security and the SDPD again?

LOUD PARTIES:

Singing farewell to Sumer? It seems, based on the proliferation of loud partying. Will neighbors ever learn or change their perception of happiness v. the pursuit of peace and quiet? Perhaps! But you can always help by applying some behavior modification. Call the police and report the noise, which is the genesis to all ills and other detrimental behavior and the excuse for drug use, drinking, rapes, fights, etc. Chances are you can also help stop the graffiti-fest. Hello, Marisa.

I wanted to give you an update on the yard sale at 52nd Street. I opened a case on the address. Yesterday, I made contact with residents at the property and brought them the guidelines for having yard sales in the City. I explained the requirements as well through an interpreter. I will check on the property again and if the sales have stopped, I will close the case. If not, after I have documented over three sales, I will begin enforcement. COUNCILMEMBER EMERALD MAKES BID TO PROTECT DOWNTOWN HOMEOWNERS

Exposes Developer Giveaway

District Seven Councilmember Marti Emerald took a stand against higher housing costs for future downtown homeowners.

On Tuesday, October 6th, the full City Council debated and approved a Comprehensive Downtown Parking Plan that would allow developers to unbundle (separate) required parking spaces from the purchase of downtown condominiums. This would allow developers to charge consumers \$30,000 to \$50,000 extra for a parking space that is currently included in the price of the condo, thus leaving the consumer with higher costs for housing and creating a windfall of profit for downtown developers. The plan also encourages the City to further subsidize private developers with tax dollars by purchasing parking spaces for public use in new, private downtown buildings.

Emerald, in outlining her objections to general fund dollars being diverted to purchase downtown parking spaces, explained that a similar deal was initiated in her Council District many years ago. The cost to taxpayers for 350 Park n' Rides spaces at the College Grove Shopping Center was almost \$2.5 million. Those spaces were never posted or used as proposed. The City is still on the hook for \$1.5 million in payments for the unused spaces.

Emerald encouraged her colleagues to remove these proposals from the plan for further study at the Public Safety and Neighborhood Services Committee. In the end, Emerald was joined by Councilmembers Lightner and Frye in opposing the plan that puts consumers at risk.

**COUNCILMEMBER EMERALD BLASTS
MAYOR OVER WINTER HOMELESS
SHELTER LOCATION**

San Carlos Library Parking Lot Not Acceptable

The location chosen by the Mayor's office is absolutely inappropriate for a winter homeless shelter. The Mayor's proposal would hoist a tent in front of the San Carlos Library, in the middle of a residential neighborhood, steps away from a school, and half a mile from the closest bus stop. "This proposal is insincere and disappointing. It leaves the impression the Mayor's office is not truly engaged in solving this dilemma over a winter shelter," said Seventh District Councilmember Marti Emerald.

In September, the Councilmember explored four sites in her district for a possible winter homeless shelter location but found none suitable: MCAS Miramar - security issues.

Alvarado Hospital Campus - underused buildings and parking lots - they still provide needed parking and office space for hospital staff.

Chollas Parkway - a short stretch of street between 54th and University - too close to a residential neighborhood, there is not a large enough paved area for a shelter, traffic control, and difficulty bringing utilities to the site.

SDSU Chapultepec Hall - the closed SDSU dormitory -- restrictions on occupancy - only students may reside on campus. In addition to the reasons listed, these sites lack transportation for the homeless to reach the services they need. Ultimately, this brings us back to downtown San Diego, the main transportation hub for the City and where most of the homeless and social services are located. Councilmember Emerald added, "We do need to create a regional and holistic fix for the challenge of homelessness but today our priority must be picking a downtown shelter site so the homeless have a safe place to stay during the winter."



**Eight Bills Authored by Assemblymember
Marty Block
Clear the Legislature**

Urges San Diegans to call Governor for Bills Awaiting Signature

SACRAMENTO - Assemblymember Marty Block (AD-78) today urged San Diegan's to call Governor Arnold Schwarzenegger's office in support of seven bills he has authored. An eighth, AB 667 (which improves access to children's dental health services), has already been signed into law by Governor Schwarzenegger. "As concerned individuals you are the most powerful voice in government," Assemblymember Block said in a prepared statement. "Your calls, emails and faxes have the power to bring about action when government too often seems deadlocked." The bills authored by the Assemblymember have already passed both the Assembly and Senate, many with wide bipartisan support. The bills are unique in that they will not add to California's already tight budget and span a variety of issues:

AB 24 which calls for a feasibility study for a San Diego State University satellite campus and possible future CSU campus in the City of Chula Vista. Study would be paid for with nonstate funding.

B 374 which requires the Superintendent of Public Instruction to produce a "consequences of dropping out notice" to inform pupils of the consequences of dropping out of school and make the notice available to school districts. This form would describe that students are more likely to earn less money, spend time in jail, be on public assistance, have fewer choices about where to live, and have a more difficult time properly caring for and educating their children.

AB 381 which provides part-time community college faculty within a bargaining unit the ability to elect as a group to participate in the California State Disability Insurance Program (SDI). Currently, part-time faculty are not eligible and lack adequate coverage to financially protect them when faced with a non-work related short term disability.

AB 628 which permits utilization of existing identification cameras at California Toll Roads, like the SR-125 South Bay Expressway, to allow motorists to "Pay-By-Plate" and pay the toll later (instead of a fine) for those who want to use the toll road but don't have accurate cash or a Fast Trak transponder.

AB 995 which adds to the list of tissue bank licensure exceptions the storage of a human cell, tissue, or cellular- or tissue-based product that is either a medical device or a biologic product, as defined, by a licensed physician or podiatrist acting within the scope of his or her license and practicing in a lawful practice setting, as specified.

AB 1005 which allows for greater transparency by requiring the California Board of Accountancy to post the minutes of those meetings on its website, and post all formal accusations filed by the board against a licensee. This bill will improve the public's right-to-know about accountants with a history of substantiated unprofessional conduct.

AB 1317 which requires a warning in all advertisements for human egg donation to inform patients of potential health risks associated with that donation.

"Your calls to the Governor can be very effective," added Assemblymember Block, "Even though the bills passed both houses of the legislature, they can fall victim to lobbying efforts by those who oppose proposed laws for any number of reasons." 



Call (858) 694-7000 for an appointment or information.

1) Make an Appointment for Saturday Service

- CALL MONDAY – FRIDAY 8 A.M. to 5 P.M.

2) Transport the Waste Safely

- Bring only a total of five gallons or 50 pounds of waste.
- Leave all products in their original sealed containers.
- Place fuels (such as diesel, gasoline, contaminated oil) in a container that can be left behind.
- Place the wastes away from passengers (in the trunk or in the back of the vehicle).
- Keep waste separate from other items (such as trash or recyclable materials) for safe unloading.

3) Bring Proof of City Residency to the Facility

- Picture I.D. and a recent bill showing your address.

4) Call About:

- Loads larger than 50 pounds
- Containers larger than five gallons
- Leaky or open containers
- Products you can't identify

Where do I bring my waste?

- Bring your waste to the Household Hazardous Waste Transfer Facility located at the Miramar Landfill entrance on Convoy Street, just North of the 52-Fwy

When is the facility open?

- OPEN SATURDAYS ONLY
9 a.m. to 3 p.m.
(Except holidays)
- Service by Appointment Only

What CAN I bring?

- Products used in the routine maintenance of your home, yard or vehicle.
- Products labeled with words such as Danger, Warning, Caution, Poison, Flammable, or Corrosive.

What CAN'T I bring?

- Ammunition, fireworks and flares
- Asbestos and lead wastes
- Business or commercial wastes
- Compressed gas cylinders
- Medical or laboratory waste
- PCB's
- Radioactive materials
- Call for assistance with disposal of these items.

OTHER AVAILABLE DISPOSAL OPTIONS

- Recycle uncontaminated used motor oil, oil filters, and automotive batteries at participating locations. Call for locations.
- Recycle rechargeable batteries or exchange propane tanks at participating locations. Call for locations.
- Put medical needles and syringes in a sealed container and place in the trash.
