City of San Diego Public Notice of FY 2011 Community Development Block Grant (CDBG) and

Emergency Shelter Grant (ESG) Entitlements

On April 6, 2010, the City Council approved the FY 2011 CDBG allocations in the amount of \$15,027,728 and the ESG allocations in the amount of \$595,120 as estimates based on FY 2010. At the time of the public hearing process, the City had not yet received confirmation from the U.S. Department of Housing and Urban Development (HUD) of the federal entitlement amounts to be awarded to the City for FY 2011. Since that time the City has received official notification from HUD that the CDBG award totaled \$16,324,437 and the ESG award totaled \$660,147 for FY 2011, representing an increase from the estimated totals.

Notice is hereby given that additional funding recommendations will be considered by the City Council offices. However, this process will be limited to the 84 eligible projects that were considered on April 6th and received partial funding or no funding. A public notice will be issued to adopt and approve the additional funding recommendations once a hearing is confirmed.

Urban Corps will plant more than 2,000 trees in public spaces throughout the City of San Diego in 2010. San Diego residents are invited to request a "free tree" to be planted in a public-right-of-way, or organize a community-wide planting day, in exchange for signing a watering agreement as a promise of volunteer maintenance. "Thanks to funding from the City of San Diego Community Development Block Grant Funds (CDBG), we are able to plant

nearly 500 street trees in all council districts," says CEO Sam Duran. "There is a beautiful variety to choose from including Crape Myrtle, Hong Kong Orchid, and Jacaranda trees. We need citizens to step up and help

coordinate tree plantings, as well as commit to help care for them." Duran reports an additional 400 street trees may be planted in the designated Redevelopment Areas of City Heights, Barrio Logan, and San Ysidro in Council Districts 3 and 8 through grant funding from California ReLeaf. Many of these will be planted in coordination with the Green Street Community Enhancement Program, an Urban Corps partnership with the Redevelopment Agency of the City of San Diego.

The planting of 57 more street trees by volunteers in low-income neighborhoods is being made possible by a grant from California ReLeaf. Urban Corps will also be planting trees where the 54 and 94 freeways intersect through a landscape architecture contract from CalTrans. Finally, an additional 1,000 trees will be planted through the United Voices for Healthier Communities "Healthy Community Trees Project" tree planting event to be held October 23, 2010. RECYCLING CENTER URBAN CORPS OPENS RECYCLING BUYBACK CENTER AT QUALCOMM STADIUM

SAN DIEGO, CA – State raids of recycling funds have not stopped Urban Corps of San Diego County from its plans to open a Recycling Buyback Center at Qualcomm Stadium. Amidst the closing of recycling centers throughout California, including several locations in San Diego, the Urban Corps Recycling Buyback Center at Qualcomm opened its doors to the public on Wed. Mar. 10, 2010.


The center collects bottles and cans and reimburses CRV deposits five days a week; hours are Wednesday through Sunday from 8:00 a.m. to 3:00 p.m. The Buyback Center is closed Mondays and Tuesdays. The Center is located at the southwest end of the stadium parking lot at Gate 3 near the practice field.

Urban Corps is a non-profit local conservation corps which offers youth ages 18-25 the opportunity to earn a paycheck while learning environmental job skills, gaining an education, and giving back to the community. Corpsmembers plant trees, paint out graffiti, restore native habitats, and collect recyclables. The majority of participants are high school dropouts with little or no job training. After completing the program, Corpsmembers are not only more employable, but they know the importance of protecting natural resources and have the life skills and confidence needed to succeed in the mainstream workforce. Since its founding in 1989, Urban Corps has helped create a brighter future for more than 7,000 youth.

The Urban Corps Recycling Department collects recyclables from businesses, schools, offices and event venues throughout the county including Qualcomm Stadium and Petco Park. Crews collected more than 1.1 million pounds of recycables in 2009 and anticipate doubling those totals

in 2010 with the opening of the Recycling Buyback Center at Qualcomm Stadium.

COUNCILMEMBER EMERALD'S LANDMARK WATER LEGISLATION IS APPROVED Council Vote Unanimous

The San Diego City Council has approved a cutting edge water submetering ordinance for all new apartment buildings and condos. Councilmember Marti Emerald wrote and promoted this ordinance, and is very happy with Monday's unanimous Council vote.


"I am thrilled with today's vote. San Diego is now setting the standard for water conservation in our region and the state," said Emerald. "Submetering alone has the potential to save apartment and condo residents between 19-40% on water use. That's huge!"

Councilmember Emerald created a Water Sub-metering Working Group a year ago to craft this new ordinance. The Working Group includes repre-

sentatives from the San Diego County Apartment Owner's Association, the County Weights and Measures Department, developers, affordable housing advocates and plumbing experts; a broad-based group that created a comprehensive plan to conserve water and protect consumers. When the new sub-metering ordinance becomes effective June 1, 2010, San Diego will be the largest city in California to require sub-meters.

NEIGHBORHOOD WATCH

At the last association meeting and as scheduled, Police Officer Luis Roman, CRO, presented the issue of the Neighborhood Watch Program to the audience in attendance. Officer Roman distributed Crime Statistics specific to our neighborhood (01/12/10), the booklet pictured to the right, and the Service Area 820 map which included Fox Canyon as the 828. The program was thoroughly explained and expectations were set for those wanting and willing to sign up to be Block Captains. In all, at this meeting, five (5) neighbors committed to the program. In addition. Officer Roman conducted a questions and answers session.

THE FOX CANYON WIGHTMAN STREET NEIGHBORHOOD PARK

Good news has been lining up upon one of our **Park System** park parcels; the Wightman Street Neighborhood Park. The good fortune begins as follows:

The California State Parks Urban Park Act GRANT for the Fox Canyon Community

Good news, the Administration of Governor Arnold Schwarzenegger extended the \$2.3 mil Park Grant to June 30, 2011. Please see page 10 to read the Governor's letter to Councilmember Marti Emerald.

The Superior Court Case:

On February 11, 2010, Superior Judge, the Honorable Linda B. Quinn entered an order on Superior Court CASE NO. 37-2008-00093831-CU-TT-CTL which in Line 26, # 2, reads: "Respondent shall give notice of the draft mitigated negative declaration for Project no. 27 149112 for Wightman Street Neighborhood Park in compliance with the California Environmental 28 Quality Act ("CEQA")". In her order, the Judge found the NMD adequate but the noticing defective.

As the result of a court order, rescind Resolution No. R-304140, denying the environmental appeal for the Wightman Street Neighborhood Park project located at 5024-5050 Wightman Street, and Resolution No. R-304141, certifying the Mitigated Negative Declaration

STAFF RECOMMENDATION: Approve Requested Action EXECUTIVE SUMMARY OF ITEM BACKGROUND:

A Mitigated Negative Declaration for the General Development Plan for the Wightman Street Neighborhood Park (Project No. 149112) was approved by a Mayor-appointed designee on July 29, 2008. The Mitigated Negative Declaration was timely appealed on August 4, 2008, and the City Council considered the environmental appeal, and denied it through Resolution No. R-304140 on September 16, 2008. A lawsuit was subsequently filed under CEQA. On February 11, 2010, the court issued an order denying the petition for writ of mandate in part and granting it in part. The court held that the Mitigated Negative Declaration was **substantively** sufficient under CEQA and no Environmental Impact Report is required, and therefore denied the petition on those grounds. However, the court also held that the public notice period for the draft Mitigated Negative Declaration was one day short, and granted the petition on that ground. The writ, issued by the court on March 22, 2010, thereby requires the City to rescind its denial of the environmental appeal and provide adequate notice of the draft Mitigated Negative Declaration. Staff recommends that the resolution certifying the Mitigated Negative Declaration also be rescinded, although the writ does not expressly require it, in order to avoid any confusion when re-noticing the draft Mitigated Negative Declaration. Future action by a Mayor-appointed designee will be required to adopt the Mitigated Negative Declaration, as appropriate, after providing an adequate notice period for the draft Mitigated Negative Declaration.

City Staff Recommendation:

Staff recommends that the resolution certifying the Mitigated Negative Declaration also be rescinded, although the writ does not expressly require it, in order to avoid any confusion when re-noticing the draft Mitigated Negative Declaration. Future action by a Mayor-appointed designee will be required to adopt the Mitigated Negative Declaration, as appropriate, after providing an adequate notice period for the draft Mitigated Negative Declaration. Future City Council action will only be necessary if another environmental appeal is filed.

The City Council:

With direction from Councilwoman **Dona Fry**, The City Council, with a unanimous vote, approved the Staff recommendation (R-2010-673) on April 6, 2010.

Dear Ms. Emerald,

Congratulations on your election to the San Diego City Council, and thank you for your letter regarding an extension to a California State Parks Urban Park Act Grant for the Fox Canyon community.

I agree with you regarding the economy's impact on local communities and their parks. The December 2008 freeze on bond-funded projects was a setback to starting or completing thousands of park projects statewide. The good news is that the bond sales in 2009 succeeded in providing sufficient funds to reimburse local governments, nonprofit agencies or their contractors for bond-funded park project work.

My administration recognizes the delays in the work progress also took away valuable time from these projects, and the grant contract deadlines needed adjustment. For this reason, last year, contracts that ended in June 2009 were extended for one year. We have committed this year to extend the local assistance grants again for one year to June 30, 2011.

Thank you again for writing. I hope you'll keep in touch with me on this or anything else you want to bring to my attention.
