#### Rock, Read & Lead

On Saturday, September 18th, the Friends of the Charlotte Mecklenburg Library held the first annual Rock & Read 5K Run/Walk. The event raised over \$10,000 for the Charlotte Mecklenburg Public Library System. Music, recorded and live, all along the way was the power behind the 500 participants on a course around parts of Colonial Village and Sedgefield. We thank all the Sedgefield residents for being so patient with us on race day and helping with the traffic. We could not have done it without you! Special recognition goes to our Race director, Amanda Anderson, and hundreds of amazing volunteers who led Friends of the Library to such a successful event.

The Rock & Read 5K is just another way the Friends organization is raising awareness of the struggles of our community libraries. Three branches were closed earlier this year and the book collection budget was cut by almost 50%. Did you know that over 29,000 people use the branches everyday and library visits are up almost 40% in the past six years. The Friends of the Library take great pride to support efforts in developing literacy for all ages but especially for young children in the elementary educational years. Don't forget the Library System is also the community's largest supplier of free internet access and provides vital educational support for all ages. As you can see, the libraries are more than just a home for books!

You may recall that Friends board president, Harriet Smith headed a "Save the Library" campaign earlier this year that raised over \$400,000 in three months. This success would never be possible without the support and generosity of our Charlotte community.

At this writing, the Friends book sale is about to start on October 21st and runs until the 29th at Quail Corners Shopping Center.

Thanks and appreciation to Jane McNeary, a Friends member who has coordinated the largest ever book sale in Charlotte. Some 15,000 books were culled from over 100,000 books coming mostly from the closed library branches.

Fundraisers and book sales can help our libraries in the short term, but real success comes from transformational leadership in the community. Charlotte is full of amazing leaders like Amanda, Harriet, and Jane, who stand out because of their selfless character and their common love to see others succeed.



#### Swine and Dine



### Update from the SNA Zoning Group by Katie Zender

#### Strawn Apartments Property Re-Zoning

The Charlotte Housing Authority (CHA) requested rezoning of almost 17 acres surrounding Strawn Apartments. This property is bordered by S. Blvd, S. Caldwell, Templeton Avenue, Euclid Avenue and Rensselaer and the original proposal requested up to 1.3 million square feet of housing, offices and retail, equal to the size of Carolina Place Mall.

The Dilworth Community Development group voted to drop their opposition to the re-zoning after extensive negotiations. CHA made numerous modifications in meetings with the Dilworth group, including down-sizing the amount of leasable/sellable space, specifying the percentage of space allowed for office uses, increased set-back requirements along neighborhood streets, specific minimums for various design elements, traffic management - especially during construction and open space and water management. City council approved the re-zoning at their meeting on September 20, 2010.

#### **Epicurean Lot Re-Zoning**

This property sits at the corner of East Blvd and Scott

Avenue, and the owners requested a re-zoning to allow for a parking lot that would be leased to nearby restaurant owners who do not have enough parking for their businesses. The lot has been vacant for 12 years, is in violation of City ordinance and is in violation of the East Blvd Pedscape plan, which was designed to enhance the walk-ability of East Blvd. The Dilworth Neighborhood Association opposes the re-zoning. City Council is scheduled to vote on October 18th, which is after press-time for this newsletter, so we'll share the outcome at the November general meeting.

#### 2020 Vision Plan Workshop

The final workshop has been postponed until Thursday, November 18th when it will be held at the Charlotte Convention Center. The time is yet to be determined. Details are available here: http://www.centercity2020.info/

#### Savanna Woods Redevelopment

After more than a year after this project was pulled, a new plan for redevelopment has surfaced. It is possible that the corner parcel at Marsh and Park could be purchased and incorporated into the overall project. #### **Neighbor Disputes**

What can be more exciting than moving into a new home and getting to know your new neighbors, or anticipating if a friendship may develop with the new person that moved in next door? In the work place or our personal lives we can normally choose who we associate with and make our friends; however, what happens if our new neighbor seems to have come from a different planet? When living in close proximity to someone it's not always easy to avoid a neighbor. There is no walking away because you're already at your "safe haven."

Unfortunately there is no easy solution. The best solution is for both parties to simply ignore each other whenever their paths cross. If only things were so simple. Often times these situations take a turn for the worse at some point and manifest from hard feelings into exchanged words, damaged property, and even criminal charges. How can this be prevented?

When the police become involved our response is usually "Ignore each other", which is not so simple. But the underlying problem will persist. Unless a threat is conveyed, property is damaged, or an assault occurs the police department's involvement in neighbor disputes is very limited because in the law's eyes your home is sacred, and so is your neighbor's. No contact orders (restraining orders) can be issued through the Sheriff's Department to prevent contact from another party; however, these are just pieces of paper. Often times the threat of arrest if the order is violated is sufficient to prevent further encounters, but these obviously don't create a barrier around you and your home. Often times the problem continues until one party succumbs and moves.

Basically no one says we have to like everyone else, we just have to get along, and this is especially true with neighbors. Unfortunately sometimes we have to suck it up and just be neighborly, then hope for the best. # A Fall & Winter Seasonal Maintenance Guide for our Sedgefield Neighbors

With the fall and winter months upon us, now is the time to do some routine maintenance around your home to prepare for the changing weather ahead. Taking the time to do some work now may save on some major expenses later on. We have compiled a checklist of the top 5 fall and winter home maintenance tasks to prepare your home (and your family) for the colder temperatures ahead.

- 1. Schedule checkups for all home heating systems.
  - Regular maintenance can help furnaces, wood stoves, chimneys and other home heating components stay in top working order. Most experts recommend that you schedule an annual inspection by a qualified professional for each system, but service intervals may vary from one system or manufacturer to another, so play it safe and check your owners manual or contact each heating system manufacturer for guidance. By performing this routine maintenance measures now, you can prevent possible problems later on during the cold months. If you have to have repair work done during the maintenance work done now.
- 2. Clean your gutters. In North Carolina, you're less likely to have ice form in your gutters than in other parts of the country. Nevertheless, debris in your gutters can easily divert water onto the roof or siding, setting the stage for mold and rot and dramatically shortening the lifespan of shingles and paint. Inspect and clean your gutters in the late fall after leaves have dropped.
- 3. Put away lawn and garden equipment. Pick up anything in the yard that could be damaged by cold or snow, such as garden tools, hoses and nozzles, and patio furniture and accessories. Run your lawn mower until it's out of gas, if possible; if you leave gas in the tank over the winter, it can degrade and lose some of its combustion ability. Worse, gas can react with the air in the tank and oxidize; forming deposits that affect the machine's performance; worse still, moisture can condense inside the tank and cause rust that blocks the fuel lines.

- 4. Trim back vegetation. In some areas of the South plants grow year-round, so it's important to keep an eye on whether they're encroaching on the roof and walls. Trim trees so that branches don't hang over the roof, and keep heavy, dense growth away from siding. A good rule of thumb is to trim back bushes and shrubs so that there's enough room to walk easily between plantings and your house.
- 5. Pick up a paintbrush. Fall is a good time to do interior and exterior painting. Painting the exterior will seal all surfaces before winter's moisture has a chance to do damage. When painting the interior the weather will still be warm enough outside to leave windows open to ventilate during painting. Most of your professional painters are not as busy in the fall months as the rest of the year, so doing the work now may save you in the long run.

#### Still Fighting the Cankerworm

This year, as in the past, the City of Charlotte will band the large street trees around Sedgefield. You may recall in 2008 the City conducted aerial spraying as an added assault on the cankerworm. Banding will be our only protection this year. The tree canopy in Sedgefield is our most prized asset. Banding must be done at the right time to stop the female moth from crawling up the tree and laying eggs. The moths hatch from the ground upon the first heavy freeze which is usually late November or early December. Trees most at risk are the willow oaks. Property owners must take steps to band trees on their property (not street trees). In years past, the Sedgefield Neighborhood Association has purchased banding materials and volunteers have banded the most vulnerable trees mostly on vacant properties.

The Sedgefield Neighborhood Association is planning a volunteer day on Saturday, Dec 11th to band identified trees. This year we will provide banding service to our senior and disabled residents for an attractive fee of \$10 per large tree (24" diam) and \$5 per smaller tree. You can email to sedgefield-neighbor@hotmail.com with your name and address. We will confirm receipt of your request and collect payment upon completion. Checks may be payable to Sedgefield Neighborhood Association. Volunteers are encouraged to meet at St Paul UMC at 9am to break into work groups. If you plan to volunteer, please email to the address above. SNA is buying the banding material and some of the supplies needed (gloves, spreaders, razor knives, scissors, staple guns, etc.) If you want to volunteer

and can bring your own work or disposable gloves, it would be appreciated. The dry crew will place batting, roll & staple the bands. The wet crew gets to spread the muck (Tanglefoot). It is easiest to drag a wagon of supplies and walk from place to place. Wear your grubby clothes and appropriate shoes. Please bring your cell phones to facilitate communication. This event has always been big fun for us and a great way to meet neighbors.

FYI some general information for residents. Several banding methods and materials are available with prices ranging from \$1.50/ft DIY to \$7.00/ft professionally installed. Prior to purchasing your banding materials, survey your trees (not street trees) and estimate the material Measure the circumference of your trees at chest height. Bug Barrier material is a complete product and does not involve spreading any sticky substance. This product is practical for use on larger trees with uniformly round trunks. To ensure effectiveness, plastic wrap is also required to secure the top and bottom edge of Barrier to the tree trunk. On very small trees or irregularly shaped and multi-trunk trees, the standard banding method (batting, roll roofing, Tanglefoot glue) will be required. When using the Tanglefoot method, you can place the insulation and the band now, but wait a day or so after the first freeze to spread the glue. Many tree and landscape services can come to your home and band your trees, usually with a minimum per residence. A very important part of tree protection includes removal of the material in late spring.
