Email us at ppeca\_800@yahoo.com Recently, I was asked to attend a meeting for the Far East Area Commission. You are probably asking "What is this?" or better yet, "What can it do for me?". Well, I'll tell you briefly what it is and why it effects all of us in a good way.

The Far East Area Commission is a group of individuals who have banned together to have a say in what happens in the Brice Rd/Tussing Rd. revitalization. As you all know, a number of businesses have moved out of this area in the last few years, leaving behind abandoned buildings. The Commission is forming so that we as residents of this area (10 Square Miles surrounding Brice/Tussing Road) have a say so in what goes into those buildings. The Commission will be notified when any business is looking to move into the area, thus giving them/us the ability to approve or reject certain businesses.

This process is a long process, but it has been in the works for a few months. I am told that in a couple of months, they will be looking for support for a petition to add the Commission to the area. They will need volunteers to circulate the petition and get signatures. As of right now, there are a number of established businesses on board, as well as, the Civic Associations of numerous subdivisions (including Park Place East Civic Association) and area Block Watch Groups.

tance we'd be happy to hear from you!


- We are working with the post office and the city to get the broken down mailboxes in the neighborhood fixed.

Please be advised, any homeowner, whose Property Easement backs up to a road such as Hines Road/Tussing Road, is responsible for maintaining that Easement. Per Columbus Code Enforcement, if the property Easement is not maintained, the homeowner will be held accountable and a monetary fine can and will be assessed against you. This maintenance includes cutting the grass in that area. Please also keep the tree lawn area of your property free of litter/debris and grass cut.
