

This way it will be documented. When Community Solutions does a drive thru they are not aware how long a boat or RV has been in your driveway. Contacting them ahead of time will prevent any frustrations that incur from a letter being sent. Thank you.

We would like to ask to please park vehicles in the driveway and to avoid street parking if at all possible. This sometimes creates hazards such as views being blocked when pulling into road, safety for walkers/bike riders and impeding normal traffic flow if vehicles are parked on the street It also makes it difficult for the school bus/garbage trucks to maneuver through the parked vehicles. Guest parking on the street is not the problem. Kirkwood HOA can no longer mandate the rule against street parking since the roads have been taken over by the NC DOT, but law enforcement can issue citations if vehicles are impeding traffic. It seems the worst problems are vehicles parked at intersections/ street corners.

Trashcans



Please make sure that all Trashcans are out of view of any street except on the collection day. This means all Trashcans need to be placed behind a screen, behind the home or in the garage. The HOA will be sending letters for all cans that are left in front of the garages or on the side of the home.

The Rules and Regulations state:

All garbage and trash will be kept in containers. Trash containers must be stored in garages, behind the home or behind a fence, or otherwise concealed from view except on garbage/trash collection days when the same shall be placed on the street or driveway for collection. Containers are to be brought in out of view the same day as collection.






