### ANNUAL MEETING

#### **Common Code Violations**

Fall is a great time to inspect your property for some of these common code violations: **Exterior Housing Maintenance**: peeling paint, missing siding, loose or missing guttering, falling soffits, and loose roofing shingles must be repaired.

**Grass and Weeds:** Weeds or tall grass must not exceed 8 inches in height. **Litter:** Litter in the form of tree branches, boxes, used wood, auto parts, or other waste materials must be removed from the porperty. **Off-Street Parking:** Vehicles, including recreational vehicles, trailers and boats, cannot be parked on the street or driveway.

## Barking Dogs



Dog owners are responsible for ensuring that their pets do not disturb the peace. A habitually barking dog that disturbs the peace is considered a public nuisance. To report a habitually barking dog, please contact St. Louis County Animal Control Services. Also, when walking your dogs and they make a mess, please be responsible and pick up the mess. Your neighbors don't want the mess in their yards either.

## Trash and Recycling

If is very important to do your part! Please keep these helpful reminders about your waste and recycling containers in mind:

- \* Please do NOT use your black recycling container for anything other than recycling no trash and no yard waste. This causes significant problems for the hauler and delays in getting your waste picked up.
- \* Please place your waste and recycling at your curb by 6:00 a.m. on your scheduled collectio day or you may be missed. If your materials are not at the cub by 6:00 a.m., the hauler cannot be held resonsible for the missed collection.
- \* Please store your containers behind the front line of your house after the day of your collection, no in front of the house or garage.

#### **IMPORTANT NEWS**


Please make sure you pay your assessments. If you are late, <u>you will be charged a late fee</u>. It is important to collect this money to allow us to pay subdivision bills and also plan for neighborhood improvements. You should be aware that these are legal and binding fees and failure to pay results in a lien being filed against your home. You will not be able to obtain a clear title should you choose to sell or refinance your home. Although all monies spent for filing fees, court cost and attorney fees are assessed to the delinquent homeowner, it depletes our working capital until finally collected. We currently have less than 5% of residents who have not paid, but it amounts to thousands of dollars that could be used for improvements. PLEASE PAY PROMPTLY, INVEST IN YOUR NEIGHBORHOOD AND PROTECT THE EQUITY IN YOUR HOME!
