## Executive Committee Recap

The Executive Committee met on June 14<sup>th</sup> at 1201 Williams Street on the 19<sup>th</sup> floor. Present were officers Larry Ambrose, William Cornell, Cathy Donahue, Randle Loeb, Jane Lorimer, Steve Nissen, Andrew Schurger, and Jennifer Tomeny; committee chairs Ken Beaudrie, Michael Henry, and Anthony Thomas; and guests present were Albert Gallo, Michael Smilanic, and Brad Zeig.

A motion to approve the minutes of the May meeting was made by Randle Loeb and seconded by Jane Lorimer; the motion was passed unanimously.

A motion to approve the Treasurer's Report was made by Jane Lorimer and seconded by Andrew Schurger; the motion passed unanimously.

Delegate-at-large George Mayl earlier had tendered his resignation; Chair Nissen proposed the appointment of Cindy Johnstone (Friends and Neighbors of Washington Park) instead. The appointment was approved.

#### Committee Reports

Budget Jane presented a report of expenses to date as related to the budget.

Dollar Dictionary Drive A mailing of 2,000 solicitations was completed.

Education William and Mike expressed a need to hold a school board candidate forum in October.

Membership Ken reported that current membership is 92 RNOs (17 patrons) and 20 associates (6 patrons).

Parks and Recreation Larry reported that the shuttle of visitors by RTD to neighborhood fairs needs inquiry.

Safety It would be good for those who wish to join the Transition Team to apply (Editors note: the team is now full).

Transportation Brad reported that they are seeking issues such as the shuttle of people to neighborhood fairs.

Website/Communications Will reported hope to have the website development much further along prior to the Denver County Fair. Andrew demonstrated how the QR code leads directly to the website when photographed.

Zoning: Mike reported on the presentation before City Council on the Food Producing Animal ordinance.

#### Old Business

Neighborhood Handbook Nothing new to report.

Denver County Fair Two hundred dollars was approved in support of the Fair by a vote of ten in favor and one opposed. Overall, \$450.00 is approved including a map of the RNOs in the City.

INC Brochure Approved production of 1,000 copies.

#### New Business

Discussion of meeting formats Andrew suggested having postings on a bulletin board of "Around the City." Issues requiring policy changes may need a brief report.

School Board Forum October 8<sup>th</sup> approved with the site to be determined

Online Voting Jane Lorimer discussed the potential of voting via online polls for both EC and Delegation motions. EC acknowledged it might be a way to get more members involved in INC voting matters. EC decided, while most motions benefited from group discussions, there are some topics that would qualify for an online voting process. The outcome: EC will review types of motions that may or may not be suitable and Jane was asked to present at the next EC meeting how the technology works and how to ensure no duplicate voting by any one member.

#### Other Items

Presidents Dinner Committee Visit Denver will again support the dinner. Additional sponsors will be needed.

The meeting was adjourned at 9:20 p.m.

## Delegation Recap

The June 11<sup>th</sup> INC Delegation Meeting was held at the Denver Film Society with Congress Park Neighbors hosting; Maggie welcomed INC to Congress Park. The morning began with Tom Botello, Director, explaining the history of the Film Society and the premises. The Honorable Mayor-elect Michael Hancock paid a visit to the meeting along with Councilman-elect Chris Herndon of District 11. Donna Berego of Partners Against Graffiti spoke about the "Brush Off" taking place on July 23<sup>rd</sup> at Invesco Field and August 20<sup>th</sup> at East High School; the community is removing graffiti.

A motion to approve the minutes of the May meeting was made by Sally Kurtzman and seconded by Katie Fisher; the motion was approved unanimously.

#### Committee Reports

Dollar Dictionary Drive: The Dollar Dictionary will need \$7,000 by July 15<sup>th</sup> to meet the expectation of a thesaurus and a dictionary for all third-graders in DPS.

Membership: There are 92 memberships.

Parks and Recreation: The Alma Recreation Center is closed for the summer. Volunteers are being recruited for activities and a film festival for children.

Education: Committee meetings takes place on the fourth Thursday. The community collaborative process is under controversy as to how the representatives work together. There will be three vacant seats on the School Board.

Zoning: The committee will meet on June 25<sup>th</sup>. They desire the current head of Excises and Licensing to meet with the neighborhood groups. They were supposed to send notices to the neighborhood organizations about medical-marijuana establishments; this has not occurred. The Food Producing Animals ordinance hearing takes place on Monday, June 13<sup>th</sup>, and therefore the Executive Committee will meet Tuesday evening, June 14<sup>th</sup>.



The Denver County Fair will be July 28<sup>th</sup> to 31<sup>st</sup> at The National Western Complex. INC will have an information/promotional booth at the fair and volunteers are needed. George Mayl has resigned; Steve Nissen will appoint a replacement.

Food was provided for the June 11 meeting by Under the Umbrella Bakery located at 12<sup>th</sup> and Madison Streets.

The Mayor-elect's transition team and the City and County are recruiting people to work in a variety of positions in public service. All are encouraged to go online and apply (Editors note: the team is now full).

The Web Site Committee made a brief presentation of the logo and received a number of suggestions. They have promised to have an active site to present by the meeting in July. Their goal is to launch this site by the County Fair. There will be links to neighborhood groups and a number of features that improve information sharing and knowledge about how the site is being used and by whom.

The meeting was adjourned at 11:00 a.m.

## Zoning Committee

The INC Zoning and Planning (ZAP) committee met June 25<sup>th</sup>. Alice Gilbertson of Historic Denver and Savannah Jameson of the City's Landmark Commission staff spoke about the proposed citywide historic survey. This information-gathering survey will ultimately be educational, useful to developers, identify historic and sustainable property, help with small area plans, and boost tourism. A pilot study is planned of three diverse neighborhoods with strong neighborhood support and a range of historic interest. ZAP members who believe their registered neighborhood organizations (RNO) might be interested in applying for the pilot study may contact agilbertson@historicdenver.org.

ZAP members from Curtis Park, Park Hill, and West Cheesman Park talked about possible use of conservation-overlay districts in their neighborhoods, a tool under the new zoning code.

Rich McClintock and Alex Mehn of Transportation Solutions spoke on Denver's projected growth and the need to address air quality and traffic issues. Transportation Solutions is a non-profit Transportation Management Association for southeast Denver. Mayor Vidal recently completed the adoption of Complete Streets as official City policy, making each street subject to consideration for pedestrians, bikes, and cars; citizens may negotiate with Public Works on street plans. Denver Moves is concerned with connectivity of bicycle routes and FasTracks includes plans for density at transit-oriented development

sites. Small Area Plans are looked at seriously. Rich and Alex will come to speak to individual RNOs. Contact rmccclintock@transolutions.org or amehn@transolutions.org.

Other topics discussed: The need for RNOs to learn about development projects; the need for INC's Executive Committee to meet with Mayor Hancock – perhaps set up with Doug Linkhart; the need to send INC Statement of Requests to the new Mayor and Council Members; the need for better coordination among Excise and License, Planning, and Zoning departments; and the need for more young members of INC. Also discussed was the need for full and timely information about the Denver Public Library's funding situation, financial assets, and possibilities – particularly if the Library and/or the City plan to propose establishing a new library district, separate from City Government.

Neighbors for the most part are very active – dog walking, contacting new neighbors and making them feel welcome, bike riding, skate boarding, and pushing baby-carriages. The parks in Hilltop are always being used for sports or picnics. Dog droppings are taken care of also.

**Lowry United Neighborhoods** – Lowry successfully had an All-Lowry garage sale along with electronic and ARC pickups the following week; every neighborhood could do this. Lowry has a summer filled with concerts, films, wine

walks, et cetera and look forward to working with our new City Councilwoman, Mary Beth Susman.

**Ruby Hill N.A.** – Ruby Hill is having a neighborhood picnic day at Godsmen Park on July 31<sup>st</sup>; find details at <http://rubyhilldenver.com/happening/calendar/ruby-hill-neighborhood-picnic>.

**Sloan's Lake N.A.** (SLNA) – SLNA looks forward to hosting the July INC meeting of the Delegation on Saturday, July 9<sup>th</sup> at Sloan's Lake Community Church. Please come to our beautiful neighborhood.

**United Community Action Network** (UCAN) – UCAN is working to make sense of the communities north of I-70. While RTD signed the Record of Decision for the North Metro Fastracks line four weeks ago, that action took place a week after the City Council voted to subsidize the permanent onsite encapsulation and deed restriction of 80 acres in Globeville just above Heron Pond Open Space. Heavy industrial zoning underlies the property that is rail-served, directly abutting Laradon Hall and Globeville townhomes. Heron Pond is planned to remain permanently contaminated with smelter waste. Those areas directly about the North Side Park and the South Platte River. The stock show is making actions to vacate their 100-acre site with the \$32 million in taxpayer owned buildings they lease from the City for one dollar per year. I-70 appears to be staying on its current alignment but move to one side or the other, possibly requiring condemnation of Nestle-Purina.

## Recycler's Corner

### Recycle your plastic garden pots and trays

Are you looking for a place to recycle your used plastic pots and trays that your flowers, shrubs, and vegetable plants came in? Well, you are in luck! The Garden Centers of Colorado accepts plastic garden pots for recycling. So go ahead and clear your garage of those stacks of garden pots that you have been saving and bring them to a drop site for recycling.

Participating stores in Denver include:

- City Floral Garden Center, 1440 Kearney Street.
- Groundcovers Greenhouse, 4301 East Iliff Avenue.
- Hilltop Gardens, 9660 Federal Boulevard.

Several wholesale growers are also accepting recyclables from their customers. Check with participating stores for hours of operation. A complete list of participating stores is listed online at [www.GardenCentersofColorado.org](http://www.GardenCentersofColorado.org).

Plastic garden pots of any size or color can be recycled. Products that are accepted for recycling include any pot that annuals, perennials, trees, or shrubs are grown in; carrying trays; flower pack holders; hanging baskets (with the hanging wire removed); flat trays; clean shrink wrap; and other greenhouse type plastics. Not accepted for recycling

are paper items such as soil or mulch bags, rubber items, glass, or any trash of any kind. The recycled products are crushed, baled, and then sent to manufacturers to be made into new plastic landscape products.

### Using Reusable Bags Is Still Best

Did you know that over a lifetime, one person using reusable bags can save more than 20,000 plastic bags? American shoppers take away an estimated 30 billion disposable plastic bags from stores each year and less than five percent of those plastic bags ever get recycled. That is a lot of wasted bags and oil because it takes around 12 million barrels of oil to make those plastic bags in the first place. Americans also use over 10 billion disposable paper grocery bags each year requiring 14 million trees to produce.

***So what happens to all these plastic bags?*** Most become trash or litter our environment. Because plastic bags are lightweight and can easily be caught in the wind, many bags fly away from landfills or fly away before ever making it to the landfill and then end up polluting our land and waterways. Plastic bags are not biodegradable and can stick around for hundreds of years in nature. Once plastic bags reach our oceans, they can cause the death of sea turtles, whales, marine mammals, and seabirds that ingest or entangle in them. The best way to avoid contributing to this waste is to shop with reusable shopping bags.

Reusable bags not only have environmental benefits, but can also save you money. Most grocery stores will reward you with a few cents off for each reusable bag used. So depending on how much you shop, you could save \$20 to \$50 a year by bringing along your own bags. And do not forget that if you only have a few items, you can skip the bag all together.

Unfortunately, recent news stories have suggested that disposable bags may be better because reusable bags may be dirty or be contaminated. These news stories failed to mention that just regularly washing your reusable bags can prevent contamination. Also, avoid using your reusable shopping bags to carry other items such as gym clothes without washing them before using them to carry food again.

If you do have plastic grocery bags to recycle, please use the collection bins provided around the entrance areas at supermarkets. Please do not put plastic bags in your purple recycling cart as plastic bags are difficult to sort and often become entangled in sorting equipment. This causes major equipment problems and increases the cost of running the recycling facility. Paper bags are recyclable in the purple recycling carts.

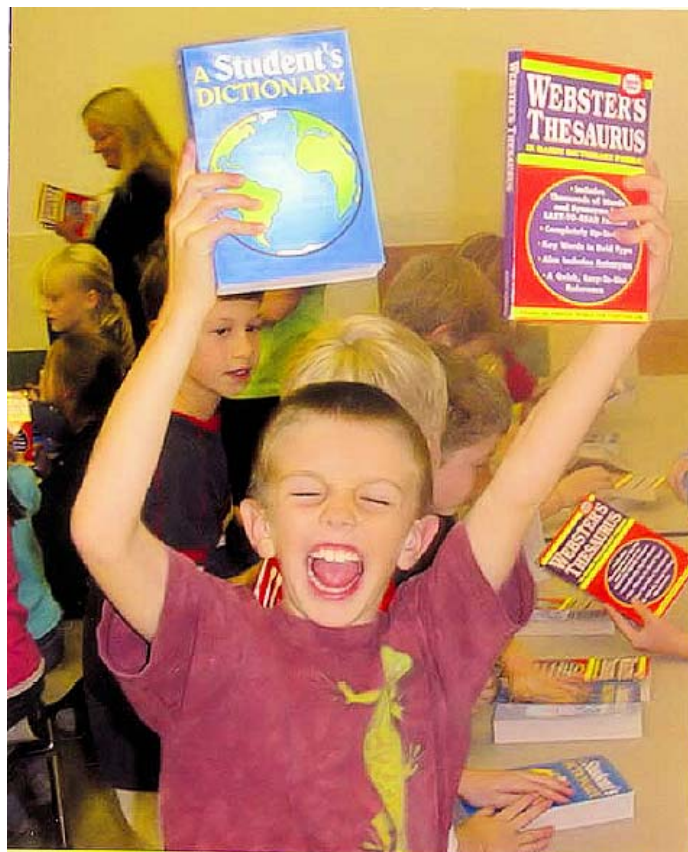

a great start but the momentum has stuttered in our fund raising efforts. This community effort is supported by grants, neighborhood associations, and individuals. Free to third-graders, these books come with the student's promise to take care of the books and use them often. Our purchase cost is \$3.20 per student. Please help us reach our goal for this year's 6,300 third-graders.

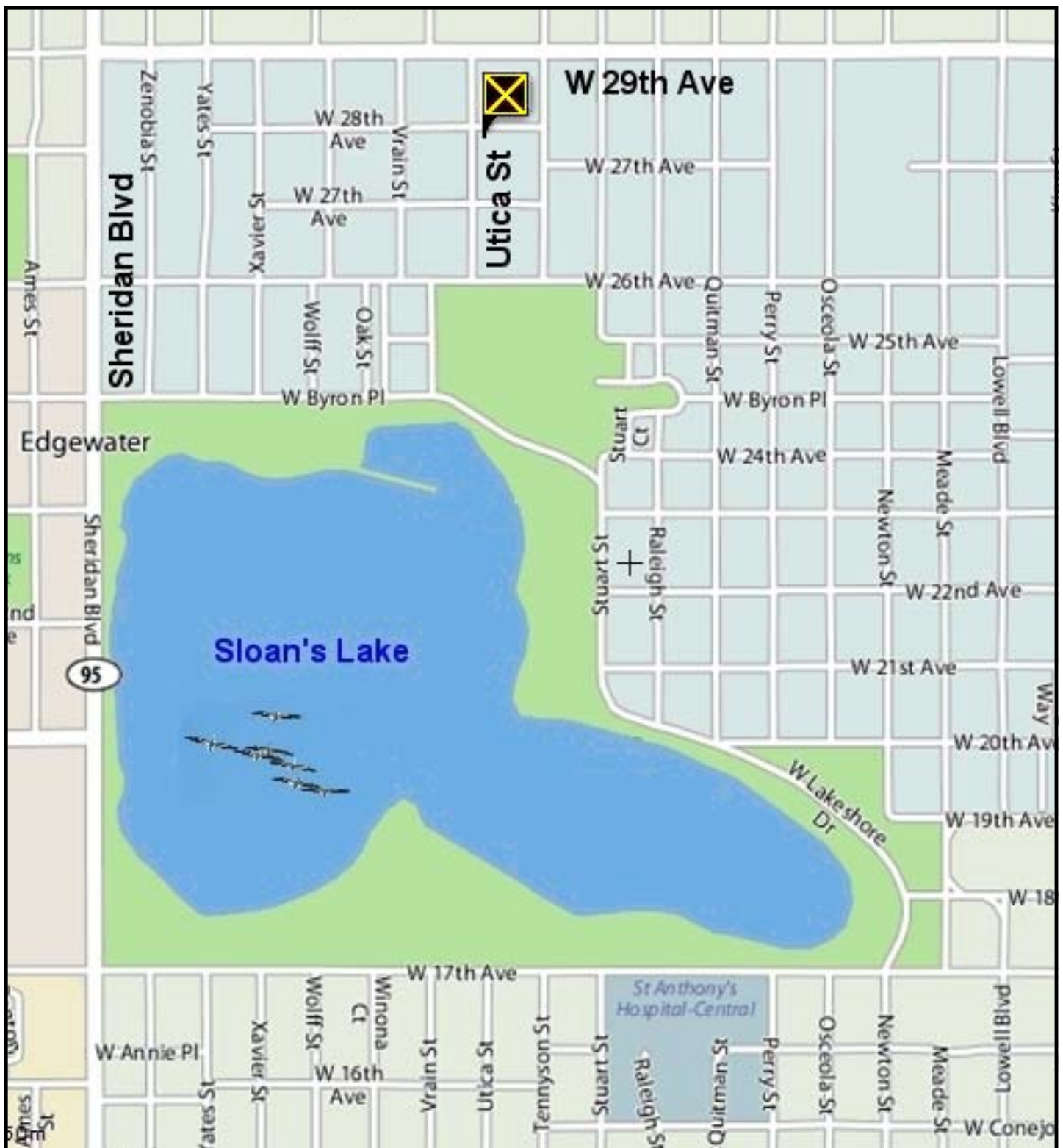
